On a daily basis, I continue to see **illegal MUSLIMS** and other illegal nationals, who commit felonies of illegal entry, illegal overstay, or illegal out of status, and who engage in felony fraud sham marriages, being readily rewarded with *privileges* of permanent immigration benefits of green cards and ensuing United States citizenship, our highest privilege.

While at the same time, I am forced to the edge of bankruptcy in litigation costs over continues punishments of false, trumped up allegations, for my whistleblower activities of fighting to protect my Beloved Americans from seditious, treasonous activities, that of aiding and abetting **illegal MUSLIMS** at a time Our Nation is at War against seditious MUSLIMS factions - doesn't this equate to TREASON?!

Or, are we to presume these extensive, long running conspiracies of aiding and abetting these **illegal MUSLIMS** is not treason because we absolutely know, and are completely and totally assured, not one of these **illegal MUSLIMS** is, in any form or manner, associated or connected with any seditious factions, and therefore these criminal conspiracies are okay and no threat to our security?!

Nearly ever day, one of our Beloved, Blood Americans is being murdered in Iraq or Afghanistan.

While, at the exact the same time, at the expense of the American Taxpayers (without their knowledge or consent using their hard earned tax dollars [four out of eight hours per work day]) the criminally corrupt officials are protected, supported, promoted and rewarded, kept in positions of power and authority, holding (and grossly violating and abusing) the public trust, and continuously given every opportunity to destroy incriminating material evidence, such as videotaped testimonies and my official case notes, so they are now able to say none of the more than 70 fraudulent sham MUSLIM marriages, and over 150 other fraud cases, which I documented in conflicting sworn testimony on videotapes or in my official case notes, were ever fraud.

Although repeatedly warned NOT to give any information to the conspirators, the FBI and DOJ continuously turned over all sensitive whistleblower and informant information and documents on case files to the conspirators, allowing them to destroy relevant videotapes, official case notes, and for their cover up conspirators to threaten or pay off informants.

Are the above entitled treasonous conspiracies of aiding and abetting **illegal MUSLIMS**, who commit numerous FELONIES in illegal entry or overstay and engage in fraudulent sham marriages, and rewarding their felony activities with green cards and ensuing United States citizenship, (our nation's highest privilege), to be exposed and stopped **only AFTER more blood runs on our sovereign soil?**
