He kindly agreed to be our Ambassador on humanitarian grounds as we are a nation of people who have had houses stolen from us by Australian authorities.

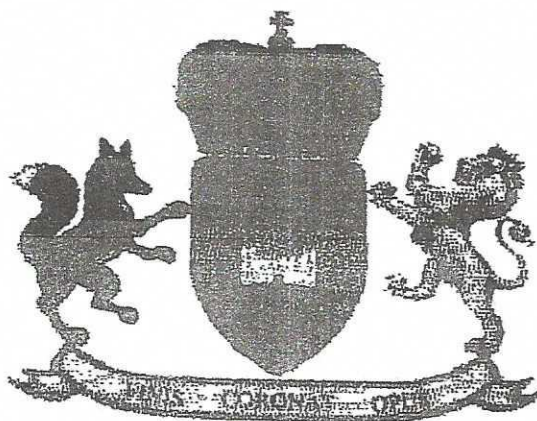
We asked him if he could consider being our Ambassador even if we could not afford to pay him.

Dear Sir,

This letter is to inform you of the formation of a new nation named The Principality of Snake Hill. It was formed by peaceful unilateral secession from Australia on 2nd September 2003 following the theft of two of our properties and the threat to steal the remainder of our properties. All relevant Australian and international authorities were notified. The Australian Head of State consented to our secession.

I am writing this letter to you because I believe that what has happened to us should come to your attention as you are the Secretary General of the United Nations, and my previous letters to the United Nations have remained unanswered.

On 2nd September 2003 I wrote to the Governor General of Australia, the Prime Minister of Australia, the Premier of New South Wales and the Governor of New South Wales to declare that we had regretfully decided to secede with our remaining properties.

We had a few reasons for such a drastic measure. My parents and I have endured the fraudulent taking of two properties through a Court case which we believe was unfairly judged, the devaluing of our rural property because of rezoning, the denial of rental income which we depended upon, and attempts that were made on our lives following death threats which the Police laughed at and refused to investigate.

It seems that it is fairly common for people to be treated in this way here in New South Wales, and we were shocked and disappointed to discover that the authorities are aware of the problem and condone it. The local television and radio programs report on such cases on an almost daily basis.

Perhaps we were naive, but we always believed that the Police and Judges were here to uphold the Law, but it appears that we were mistaken. We came to Australia in 1969 from Sweden, and it was not like this then. It has become progressively worse. At first we thought that this was a personal attack but during this ordeal we have met so many people who have endured similar or even much worse attacks on their properties and on themselves.

The common denominators seem to be that we are all law abiding, hard working and have assets. It is those assets that have made us targets.

These are the facts of the case which was fraudulently begun against us to take two properties (the loss is worth almost \$1,000,000) :

We were approximately 1 year ahead with our interest only mortgage payments when we were sued for being 1 year behind. We were not served with a Notice of Default, or the Statement of Claim, or even the Amended Statement of Claim. We received the Amended Statement of Claim by fax when we were expecting a payout figure for the refinance.

The court case dragged out for about 4 years, and the mortgagee took the rents from the properties (twice the mortgage payment each month) and admitted (even in Affidavit to the Court) that we were 1 year ahead when they sued us.

We did not know exactly how to defend our case and every solicitor said they would not go against a large law firm. We prepared and filed our Defence on time and it stated that we were ahead when they sued us.

At the Hearing we were not allowed to say anything, and the Judge decided that we "were clearly in default" and gave our properties away. He based his decision largely on a Mediator's report which stated that we should pay the other party 50% interest and amazing legal costs. He also decided that we were in default, although he admitted that we were ahead when they sued us.

We lodged an Appeal and a Stay to stop the sale of the properties until the Appeal had been decided. Our stay was not granted with the Judge saying that the properties could be sold as we had no sentimental attachment to them, and they were sold for half market value.

We tried to delay the settlement of the sale by filing a Caveat on the Titles, but we were ordered to remove the Caveat by a Judge, who said that we had no right in either Equity or Common Law.

The other party asked that our Appeal should not be allowed, and the Court agreed. The Judge told us that the facts of the case were "irrelevant" and that we had no right or reason to appeal, since they have already taken the properties from us and sold them.

He said that our losing almost one million dollars was "not a big deal".

This is not an isolated problem, as there are hundreds of other people that have lost their properties in a similar way. Many have been placed in bankruptcy without a bill of costs, and with ample assets to cover all debts. They have been told that it is none of their business how much the bill is for, and they are bankrupted without a chance to defend themselves.

We tried to complain to the police and several government departments about the fraud, perjury and professional misconduct that we allege the other party has committed. In all of this time, we have been given feeble excuses for their lack of jurisdiction, lack of funding or general disinterest, and no investigation has yet begun. We have heard from others that they, the victims, are actually investigated rather than the alleged criminal.

Is this normal?

I have complained about this in numerous letters to Mr Carr, Mr Debus and Mr Watkins who all seem to be concerned, but nothing positive has happened in this time. It is two years since I received a reply from Mr Carr stating that he was concerned. In this time we have lost 2 properties, and the other party have threatened to take our other properties as well to "help pay the legal fees" for having sued us without cause.

The Police have refused, until recently, to look at any of our evidence and have completely refused to conduct an investigation into our complaint. They have discussed the matter with the people we are complaining about and I ~~am taking you~~ <sup>have brought you</sup> the other party's affidavit regarding the conversations. The Police have called me crazy and told me that I am trying to "double-dip" by expecting that the Police might try to get our properties and money back for us. They have told me that they are "not here to get people's stolen property back" and "are sick and tired of people expecting us to investigate fraud". This was a senior member of the Fraud Squad. The NSW Police's Fraud Squad recently established that we were sued without cause.

I believe that the Police should investigate fraud (and perjury) and then criminally prosecute the alleged offenders, but they have told us that they cannot charge a lawyer with such an offence as lawyers are immune.

Unfortunately, I have not found the section of the Crimes Act that actually states that lawyers or anyone else is excluded from investigation and subsequent punishment if they commit an offence under that Act. I have not found it in any other Act either.

As a result, we still expect that someone should investigate this matter, and we also expect to have our properties returned and our losses reimbursed.

Is it acceptable that there are many victims of property fraud who are denied justice in the Supreme Court? As a direct result, their properties and often their livelihood are taken away based on a fraudulent Claim, and the Judges (a few feature repeatedly) refuse to allow the victims a fair hearing, thereby aiding and abetting the fraud.

One other victim of fraud went to the Police with her evidence thinking that they were finally interested in investigating her complaint of fraud. She was threatened with being charged with being a public nuisance unless she stopped asking for an investigation. The Police officer admitted that he was aware that a crime had been committed against her, but said that they will definitely not investigate or charge the offender, as the offender is a lawyer.


I have enclosed a few of the documents from our case, and if you read them you will notice how blatant this fraud was. Please pay attention to the dates mentioned in the documents.

Just in case you are short of light reading, I have also enclosed a copy of an article from a magazine which was published about victims of the (In)Justice System. I think you will find it a little amusing and a little disturbing. People have been horrified that this is possible and widespread here.

On behalf of Secretary-General Kofi Annan, I wish to acknowledge receipt of your letter of 28 June 2004 and attachments, which were recently referred to this office for reply.

I must advise you that the matter you raise is one of domestic jurisdiction pertaining to the Government of Australia, and therefore does not fall within the competence of the United Nations. The United Nations cannot intervene in a situation that is considered essentially an internal issue pertaining to the jurisdiction of a Member State. I must also add that the Secretary-General does not act alone and that he must have the support of the Member States in order to take any action.

Meanwhile, I am pleased to enclose for your information a UN fact-sheet explaining the process by which a new State or Government may obtain recognition by the United Nations. I hope this will be helpful to you.


I regret that we cannot be of greater assistance, and thank you for taking the time to write to the United Nations.

I have the honour to send you herewith a submission from the Principality of Snake Hill which is an Application instituting proceedings before the International Court of Justice and relating to a dispute with the Government of the United States of America concerning the payment of compensation and restitution to a Snake Hill citizen for acts by American authorities.

**II. APPLICATION INSTITUTING PROCEEDINGS ON BEHALF OF THE**

To the President

And Members of the International Court of Justice,

Having regard to Article 36, paragraph 2, of the Statute of the Court and to the acceptance of the compulsory jurisdiction of the International Court of Justice by the United States of America, and by the Principality of Snake Hill on 26th January, 2005.

Having regard to Article 40, paragraph 1,

Have the honour to address to you the following Application:

The United States of America has repeatedly disregarded domestic and international law by not ensuring that one of our prominent and distinguished citizens, Ambassador Lee Emil Wanta, can freely access his own money . His money was wrongfully taken from him, and despite Court orders that the money is his, he has not received access to those funds.

There have been numerous promises of repayment of those stolen funds, but the matter remains unresolved.

The Government of the United States of America has neglected its duty of care towards

Ambassador Wanta by not enforcing laws, especially banking laws, thereby preventing him from using his own money as he sees fit.

The Government of the United States of America failed to adequately protect Ambassador Wanta from attacks upon his personal health and safety, which is a contravention of the Geneva Convention and the Vienna Convention, as an Ambassador of a foreign country must be assured of his personal safety while in the host country.

The Government of the United States of America has abused Ambassador Wanta's human rights through the denial of access to his own monetary funds.

Ambassador Wanta had promised to use a portion of his cash money to help the people of the United States by providing employment and much needed infrastructure, so the retention of his money hinders the development of that country, plus prevents him paying his repatriation personal civil income taxes on time, as that would also help the American people and the American economy.

Ambassador Wanta had promised to use a portion of his money to help other countries with humanitarian aid through the United Nations, so the retention of his money hinders the development of those countries and delays much needed humanitarian assistance to so many people.

Ambassador Wanta had also promised to use a portion of his money to help develop Snake Hill, so the retention of his money hinders the development of our country and delays much needed humanitarian assistance to our people.

Ambassador Wanta and his legal representatives have met with and corresponded with many United States of America Government Officials to discuss his payment of their restitution of his stolen monetary funds. They have on numerous occasions brought the Declaration of Basic Principles of Justice for Victims of Crime and Abuse of Power to the Government's attention. Despite a few promises, he has received nothing at all. Consequently a legal dispute exists between the Snake Hill and United States Government.

Having vainly resorted to diplomatic negotiations in respect of this issue, Snake Hill has decided to bring its dispute with the Government of the United States of America to the International Court of Justice.

Accordingly, and subject to the subsequent presentation to the Court of a Memorial, Counter Memorial and, in general, of any evidence or argument,

Whether the Government of the United States of America appears or not, and after such time limits as the Court may fix in the absence of an agreement between the Parties:

(1) by refusing to fully compensate Ambassador Wanta, the United States of America has committed violations of obligations under international law in that it has hindered the much needed employment opportunities in the United States of America which they should be entitled to enjoy under international law

(2) by refusing to fully compensate Ambassador Wanta, the United States of America has committed violations of obligations under international law in that it has hindered the much needed humanitarian aid in many countries through United Nations humanitarian programs, which those needy people should be entitled to enjoy under international law

(8) that the Government of the United States of America ensures and enforces the protection of Snake Hill nationals and diplomats when in the United States of America,

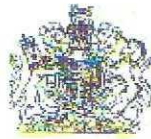

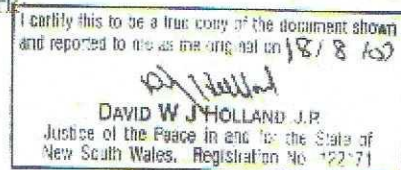

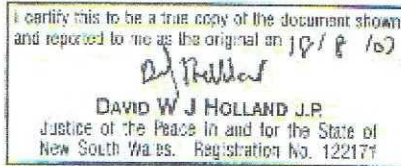

Your Majesty,

I am writing this letter to you because I believe that what has happened to us should come to your attention as you are the Queen of Australia.

On 2nd September 2003 I wrote to the Governor General of Australia, the Prime Minister of Australia, the Premier of New South Wales and the Governor of New South Wales to declare that we had regretfully decided to secede with our remaining properties. I enclose copies of those letters for your perusal. We have absolutely no argument with you or your family. We greatly respect and admire you.

We had a few reasons for such a drastic measure. My parents and I have endured the fraudulent taking of two properties through a Court case which we believe was unfairly judged, the devaluing of our rural property because of rezoning, the denial of rental income which we depended upon, and attempts that were made on our lives following death threats which the Police laughed at and refused to investigate.

It seems that it is fairly common for people to be treated in this way here in New South Wales, and we were shocked and disappointed to discover that the authorities are aware of the problem and condone it. The local television and radio programs report on such cases on an almost daily basis.

Perhaps we were naive, but we always believed that the Police and Judges were here to uphold the Law, but it appears that we were mistaken. We came to Australia in 1969 from Sweden, and it was not like this then. It has become progressively worse. At first we thought that this was a personal attack but during this ordeal we have met so many people who have endured similar or even much worse attacks on their properties and on themselves.

The common denominators seem to be that we are all law abiding, hard

working and have assets. It is those assets that have made us targets.

These are the facts of the case which was fraudulently begun against us to take two properties (the loss is worth approximately \$500,000) :

We were approximately 1 year ahead with our interest only mortgage payments when we were sued for being 1 year behind. We were not served with a Notice of Default, or the Statement of Claim, or even the Amended Statement of Claim. We received the Amended Statement of Claim by fax when we were expecting a payout figure for the refinance.

The court case dragged out for about 4 years, and the mortgagee took the rents from the properties (twice the mortgage payment each month) and admitted (even in Affidavit to the Court) that we were 1 year ahead when they sued us.

We did not know exactly how to defend our case and every solicitor said they would not go against a large law firm. Our Defence was filed on time and stated that we were ahead when they sued us.

At the Hearing we were not allowed to say anything, and the Judge decided that we "were clearly in default" and gave our properties away. He based his decision largely on a Mediator's report which stated that we should pay the other party 50% interest and amazing legal costs. He also decided that we were in default, although he admitted that we were ahead when they sued us.

We lodged an Appeal and a Stay to stop the sale of the properties until the Appeal had been decided. Our stay was not granted with the Registrar saying that the properties could be sold as we had no sentimental attachment to them, and they were sold for half market value.

We tried to delay the settlement of the sale by filing a Caveat on the Titles, but we were ordered to remove the Caveat by a Judge, who said that we had no right in either Equity or Common Law.

The other party asked that our Appeal should not be allowed, and the Court agreed. The Judge told us today that the facts of the case were "irrelevant" and that we had no right or reason to appeal, since they have already taken the properties from us and sold them.

He said that our losing half a million dollars was "not a big deal".

This is not an isolated problem, as there are hundreds of other people that

have lost their properties in a similar way. Many have been placed in bankruptcy without a bill of costs, and with ample assets to cover any such bill. They have been told that it is none of their business how much the bill is for, and they are bankrupted without a chance to defend themselves.

We tried to complain to the police and several government departments about the fraud, perjury and professional misconduct that we allege the other party has committed. In all of this time, we have been given feeble excuses for their lack of jurisdiction, lack of funding or general disinterest, and no investigation has yet begun. We have heard from others that they, the victims, are actually investigated rather than the alleged criminal.

Is this normal?

Is this unique to Australia, or is English Law really so strange and unfair?

We were advised to find precedents to follow for our Appeal, and the other party tried to claim that we did not have a right to appeal due to issue estoppel. When I quoted a Canadian Supreme Court Case, I was told that Canada did not follow the same legal system as Australia, and "we do not care what they do over there" although I have read many precedents from other English speaking countries quoted in Australian court cases.

I have complained about this to Mr Carr, Mr Debus and Mr Watkins who all seem to be concerned, but nothing positive has happened in this time. It is a year since I received a reply from Mr Carr stating that he was concerned. In this time we have lost 2 properties, and the other party have threatened to take our other properties as well to "help pay the legal fees" for having sued us without cause.

The Police have refused to look at any of our evidence and have completely refused to conduct an investigation into our complaint. They have discussed the matter with the people we are complaining about and I am faxing you the other party's affidavit regarding the conversations. The Police have called me crazy and told me that I am trying to "double-dip" by expecting that the Police might try to get our properties and money back for us. They have told me that they are "not here to get people's stolen property back" and "are sick and tired of people expecting us to investigate fraud". This was a senior member of the Fraud Squad.

One other victim of fraud went to the Police today with her evidence thinking that they were finally interested in investigating her complaint of fraud. She was threatened with being charged with being a public nuisance

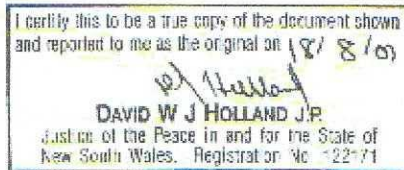
unless she stopped asking for an investigation. The Police officer admitted that he was aware that a crime had been committed against her, but said that they will definitely not investigate or charge the offender. We know her matter well and we drove her to the Police Station this morning and met her directly after her meeting with the Police. She was obviously very upset by the meeting.

Another disturbing part of this ordeal is that we have received offers from several hit men to resolve our problem forcefully. We have declined the offers, saying that we prefer to try to resolve this through the proper legal channels. They have laughed at our naivety, saying that the system is obviously corrupt, and that they pity us wasting so much money and energy trying to fight a system which completely ignores the law. It seems to be as corrupt as they say it is, and it is amazing that so many of us resist their offers.

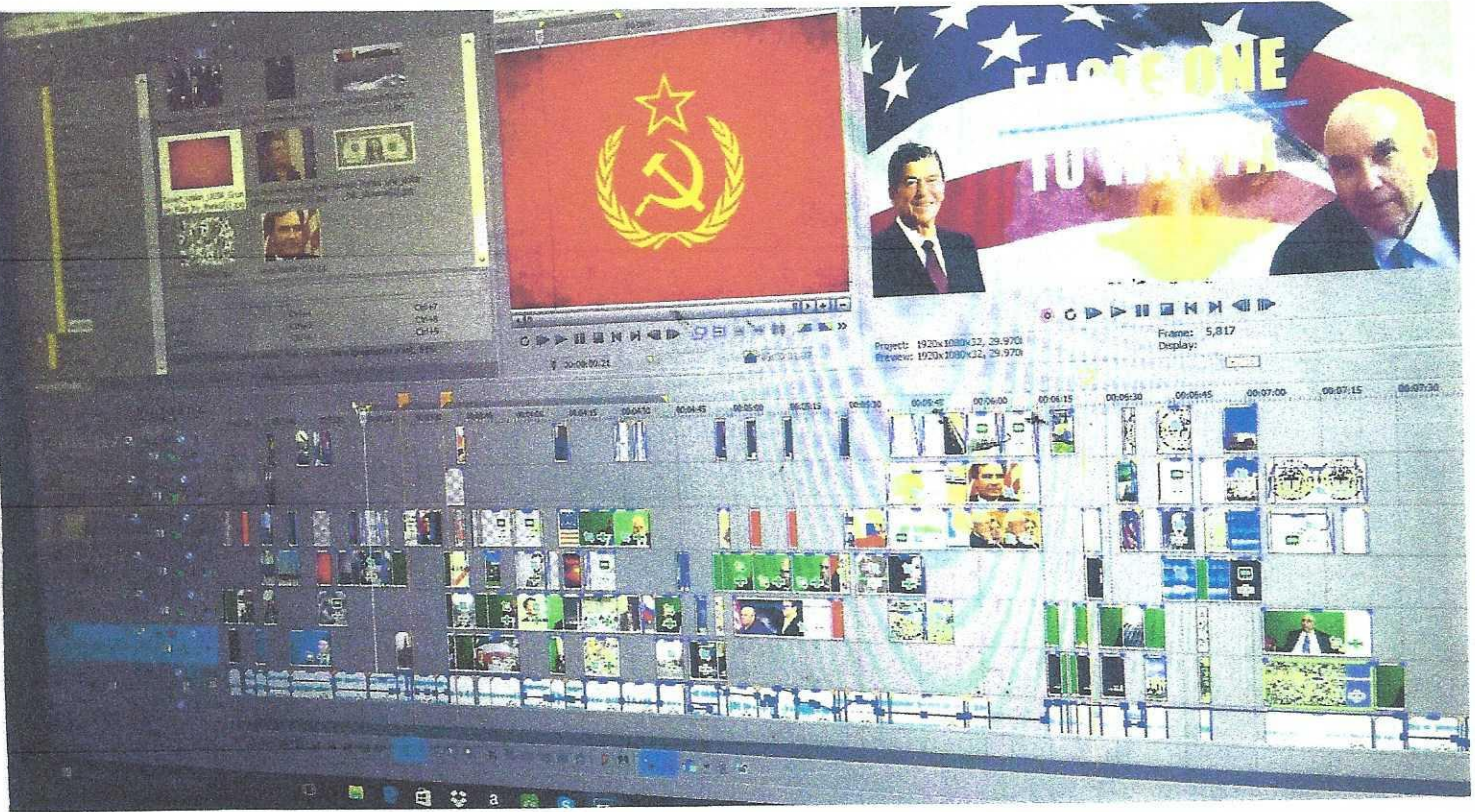

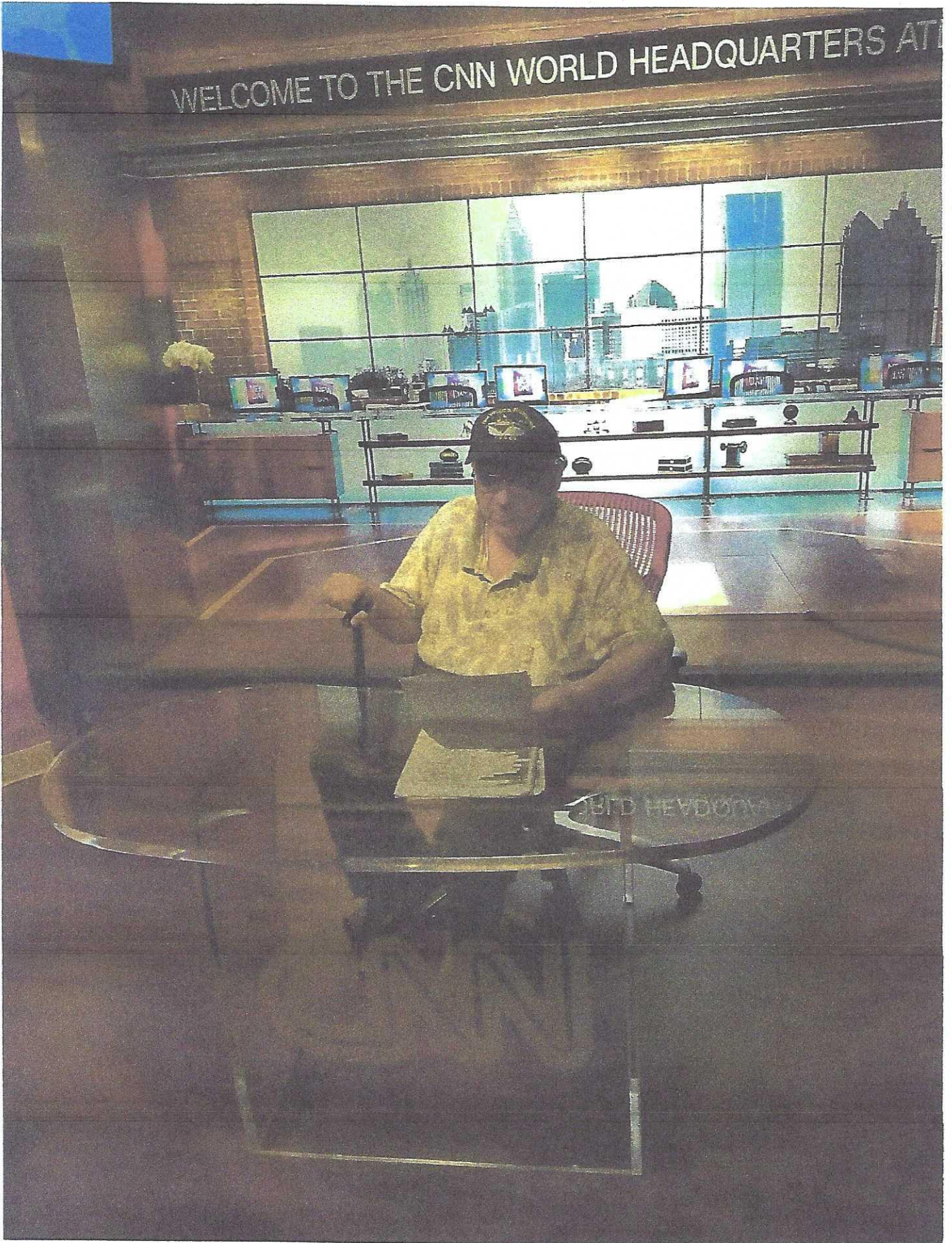
