UNITED States of America - It can now be reported that former Managing Director of the International Monetary Fund (IMF) Christine Lagarde has turned over even more new evidence to duly elected now inaugurated United States President Albert Gore Jr. of Carthage, Tennessee and the Office of Naval Intelligence concerning a \$26 billion ponzi scheme involving the National Bank of Ukraine, the British owned Alpha Bank and the Clinton Foundation.






