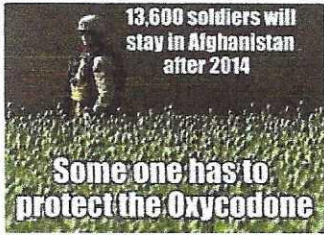

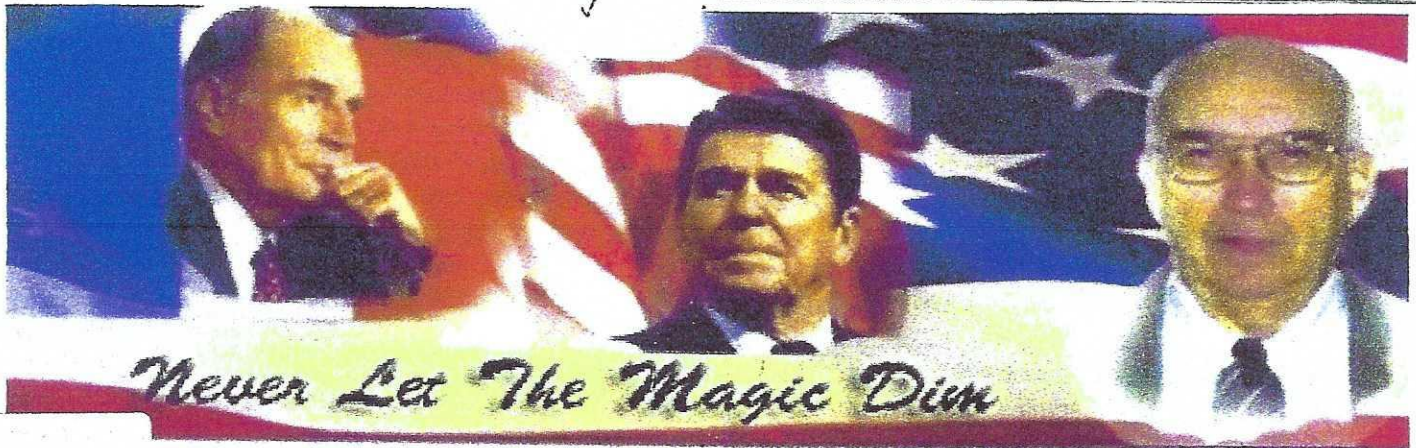

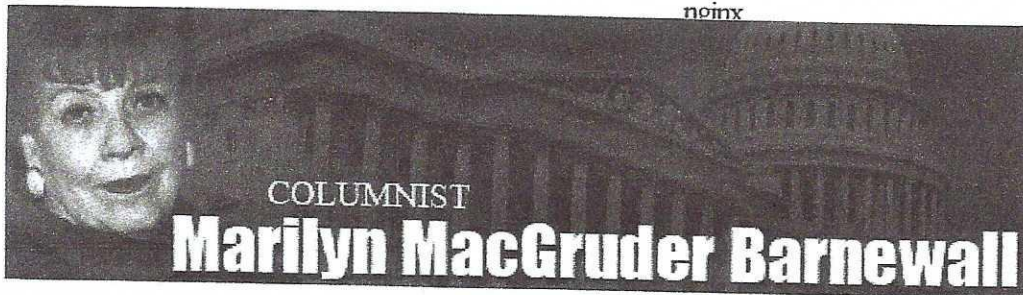

So many people ask: "Where can I put my money? The banks aren't safe because of the 'bail-ins' like they had in Cyprus where they used bank customer deposits to pay national debt. Under America's Dodd Frank Bill, my deposits belong to the bank, not to me. If the bank makes bad investment decisions, my money is used to pay for their mistakes. The government's coming after pension money and many cities are going bankrupt. People once employed by those cities have lost most of their pension benefits. After Roosevelt confiscated gold in 1933, I'm sure not going to put my gold in a safe deposit box! Where is a safe place to put my money?"

I used to have an answer to those questions. My favorite personal investment was tax liens. By investing in them I was able to give people who couldn't pay their taxes a three year grace period to raise the money to pay their taxes – to save their homes – and there was a 7 to 10 percent return on my investment each year.

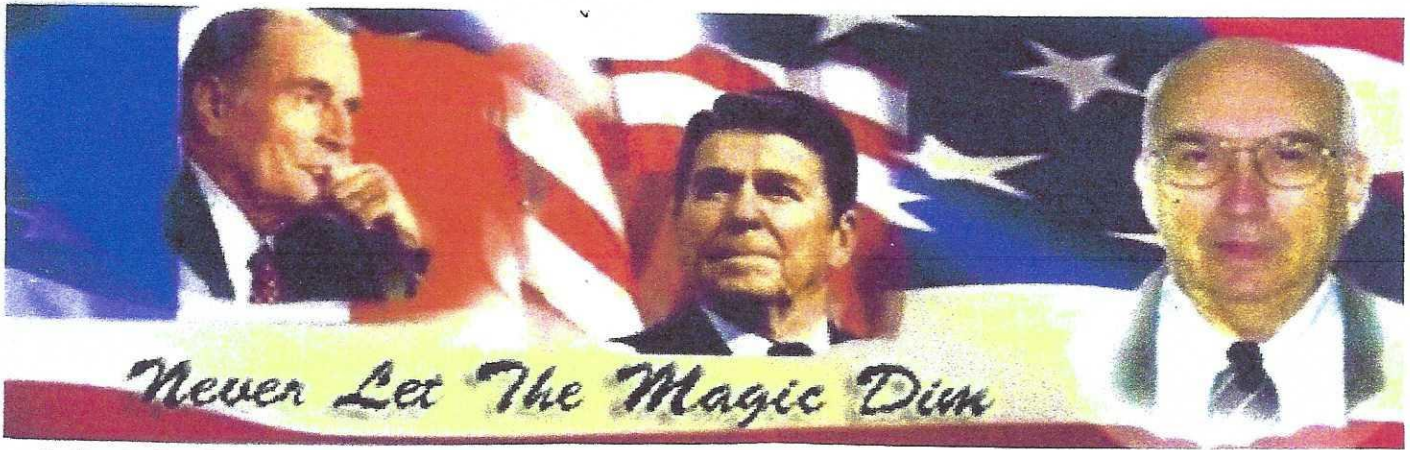

The state needs more aggressive verification of who qualifies for the legal service, says the Legislative Audit Bureau

MADISON (AP) — The state public defender's office could save millions of dollars a year by working harder to verify whether people it represents can afford to pay for their own lawyers, state auditors say.

The Legislative Audit Bureau, in a report Wednesday, cited a case of an individual who claimed indigence and was represented at a taxpayer expense for a traffic offense — even though he reported an annual income of more than \$65,000.

The state could reap between

\$4.7 million and \$6.5 million a year if the defender's office adopted aggressive collection methods, the report to the Joint Legislative Audit Committee said.

"Other states that aggressively pursue reimbursement of costs without causing undue financial hardship recover between 8% and 11% of their indigent public defense costs," it said.

"While AFDC and other public assistance programs verify eligibility by requiring clients to document their income and expenses, the defender's office requires no documentation and conducts no independent verification."

Over a five-year period that ended in fiscal 1993-94, the public defender's budget grew from \$38.8 million to \$59.4 million, an increase

PUBLIC DEFENDER CRITERIA

Public defender offices in Wisconsin compare the difference between income and expenses of an applicant to the cost of providing legal counsel in determining whether the applicant is indigent and therefore eligible for representation.

Income includes liquid and non-liquid assets, including savings and checking accounts, stocks and bonds, life insurance with a cash value, money owed to applicants, real estate and vehicles. Employee income is based on current and future earnings.

Applicants who knowingly provide false information are subject to criminal prosecution. Indigency determinations can be re-evaluated if new income information is uncovered.

of nearly 76%, the audit said.

This occurred despite a crime rate that remained relatively constant and an arrest rate that rose by only 13% during the period, it said.

Public defender Nick Chiarkas called the report "critical, tough and challenging."

But he said the audit supported his claim that the rise in criminal prosecution and the subsequent increase in the caseload is the agency's "central challenge."

The public defender's office, created in the early 1970s, has about 515 employees and a budget of about \$59 million a year, Chiarkas said. He said attorneys in private practice get about \$27 million of the total.

Although the office cannot control cost increases resulting from higher arrest rates or statewide salary negotiations, it could curb costs through "efficiency and effective administration," the report said.

More than 1,400 private attorneys represent the office's clients on an hourly basis. Compensation rates are \$40 per hour for out-of-court time and \$50 per hour for in-court time.
