O TITLE 18 - CRIMES AND CRIMINAL PROCEDURE

U.S. Code as of: 01/06/03

Section 35. Imparting or conveying false information

(a) Whoever imparts or conveys or causes to be imparted or conveyed false information, knowing the information to be false, concerning an attempt or alleged attempt being made or to be made, to do any act which would be a crime prohibited by this chapter or chapter 97 or chapter 111 of this title shall be subject to a civil penalty of not more than \$1,000 which shall be recoverable in a civil action brought in the name of the United States.

(b) Whoever willfully and maliciously, or with reckless disregard for the safety of human life, imparts or conveys or causes to be imparted or conveyed false information, knowing the information to be false, concerning an attempt or alleged attempt being made or to be made, to do any act which would be a crime prohibited by this chapter or chapter 97 or chapter 111 of this title - shall be fined under this title, or imprisoned not more than five years, or both.

Section 371. Conspiracy to commit offense of to defraud United States

If two or more persons conspire either to commit any offense against the United States, or to defraud the United States, or any agency thereof in any manner or for any purpose, and one or more of such persons do any act to effect the object of the conspiracy, each shall be fined under this title or imprisoned not more than five years, or both.

If, however, the offense, the commission of which is the object of the conspiracy, is a misdemeanor only, the punishment for such conspiracy shall not exceed the maximum punishment provided for such misdemeanor.

Section 372. Conspiracy to impede or injure officer

U.S. Code as of: 01/06/03

If two or more persons in any state, Territory, Possession, or District conspire to prevent, by force, intimidation, or threat, any person from accepting or helding any office, trust, or place of confidence under the United States, or from discharging any duties thereof, or to induce by like means any officer of the United States to leave the place, where his duties as an officer are required to be performed, or to injure him in his person or property on account of his lawful discharge of the duties of his office, or while engaged in the lawful discharge thereof, or to injure his property so as to molest, interrupt, hinder, or impede him in the discharge of his official duties, each of such persons shall be fined under this title or imprisoned not more than six years, or both.

§ 3. Accessory after the fact

Whoever, knowing that an offense against the United States has been committed, receives, relieves, comforts or assists the offender in order to hinder or prevent his apprehension, trial or punishment, is an accessory after the fact.

Except as otherwise expressly provided by any Act of Congress, an accessory after the fact shall be imprisoned not more than one-half the maximum term of imprisonment or (notwith-standing section 3571) fined not more than one-half the maximum fine prescribed for the punishment of the principal, or both; or if the principal is punishable by life imprisonment or death, the accessory shall be imprisoned not more than 15 years.

HISTORICAL AND REVISION NOTES

Based on title 18, U.S.C., 1940 ed., §551 (Mar. 4, 1909, ch. 321, §333, 35 Stat. 1152).

The first paragraph is new. It is based upon authority of *Skelly v. United States* (C. C. A. Okl. 1935, 76 F. 2d 483, certiorari denied, 1935, 55 S. Ct. 914, 295 U.S. 757, 79 L. Ed. 1699), where the court defined an accessory after the fact as—

one who knowing a felony to have been committed by another, receives, relieves, comforts, or assists the felon in order to hinder the felon's apprehension, trial, or punishment—

and cited Jones' Blackstone, books 3 and 4, page 2204; U.S. v. Hartwell (Fed. Cas. No. 15,318); Albritton v. State (32 Fla. 358, 13 So. 955); State v. Davis (14 R. I. 281); Schleeter v. Commonwealth (218 Ky. 72, 290 S. W. 1075). (See also State v. Potter, 1942, 221 N. C. 153, 19 S. E. 2d 257; Hunter v. State, 1935, 128 Tex. Cr. R. 191, 79 S. W. 2d 855; State v. Wells, 1940, 195 La. 754, 197 So. 419.)

The second paragraph is from section 551 of title 18, U.S.C., 1940 ed. Here only slight changes were made in phraseology.

§ 4. Misprision of felony

Whoever, having knowledge of the actual commission of a felony cognizable by a court of the United States, conceals and does not as soon as possible make known the same to some judge or other person in civil or military authority under the United States, shall be fined under this title or imprisoned not more than three years, or both.

(June 25, 1948, ch. 645, 62 Stat. 684; Pub. L. 103-322, title XXXIII, §330016(1)(G), Sept. 13, 1994, 108 Stat. 2147.)

§5. United States defined

The term "United States", as used in this title in a territorial sense, includes all places and waters, continental or insular, subject to the jurisdiction of the United States, except the Canal Zone.

(June 25, 1948, ch. 645, 62 Stat. 685.)

HISTORICAL AND REVISION NOTES

Based on title 18, U.S.C., 1940 ed., §§39, 133, 346, 381, 502, and 632, and section 40 of title 50, U.S.C., 1940 ed., War and National Defense (June 15, 1917, ch. 30, title XIII, §1, 40 Stat. 231).

Section consolidates the first sentence of section 39, all of sections 133, 346, and 632, and the second sentences, respectively, of sections 381 and 502, all of title 18, U.S.C., 1940 ed., and section 40 of title 50, U.S.C., 1940 ed., War and National Defense, with minor changes in phraseology.

All of these sections and parts of sections were derived from section 1 of title XIII of said act of June 15, 1917. Said section 40 of title 50, U.S.C., War and National Defense, has also been retained in that title, as it still relates to some sections therein which were not transferred to this title.

The remainder of said section 39 of title 18, U.S.C., 1940 ed., which was derived from sections 2, 3, and 4 of title XIII of the act of June 15, 1917, relating to jurisdiction and other matters, is almost entirely obsolete. The provisions still in force are incorporated in section 3241 of this title.

The remaining provisions of said sections 381 and 502 of title 18, U.S.C., 1940 ed., which were derived from sources other than said section 1 of title XIII of the act of June 15, 1917, are incorporated in sections 1364 and 2275 of this title.

SENATE REVISION AMENDMENT

Words ", except the Canal Zone." were substituted for the period in this section by Senate amendment. See Senate Report No. 1620, amendment No. 2, 80th Cong.

REFERENCES IN TEXT

For definition of Canal Zone, referred to in text, see section 3602(b) of Title 22, Foreign Relations and Intercourse.

§6. Department and agency defined

As used in this title:

The term "department" means one of the executive departments enumerated in section 1 of Title 5, unless the context shows that such term was intended to describe the executive, legislative, or judicial branches of the government.

The term "agency" includes any department, independent establishment, commission, administration, authority, board or bureau of the United States or any corporation in which the United States has a proprietary interest, unless the context shows that such term was intended to be used in a more limited sense.



asked to redact Mr Lee Emil Wanta's Social Security Number beyond the first three digits. However as the Editor possesses copies of all the relevant documentation, it is hereby confirmed that the Social Security Number used by Angela Dunlap and in written communications from State of Wisconsin Departments is identical and correct throughout].

It cannot therefore argued that the Wisconsin Department of Revenue are dealing with two different individuals, since, even in the extensively Sovietised United States, it is not yet the practice for two individuals to be equipped

with a shared Social Security Number.

On 8th March 1999 – that is to say, about three weeks following the date of Angela Dunlap's letter to Mr Heger – the Wisconsin Department of Revenue issued a (subsequently withdrawn) giga-demand for 'tax due' addressed to Leo Wanta for \$754,839.58. The Social Security Number cited on this so-called 'Statement of Delinquent Tax Account' is identical to the Social Security Number cited in all the other relevant documentation from the State of Wisconsin Department of Revenue, including the cited letter to Attorney Jan Morton Heger, which as indicated referred to Lee E. Wanta.

Let us pause here to recapitulate:

© On 18th February 1999, Angela Dunlap of the Department wrote to CIA Counsel (Heger) then acting for Ambassador Wanta, citing his correct and of course unique Social Security Number and his correct and unique Federal Identification Number with Diplomatic Passport coordinates, thus acknowledging him to be a diplomat, stating that Wisconsin Department of Revenue 'has no record of a delinquent tax account issued to Lee E. Wanta'.

About three weeks later, on 8th March 1999, the Wisconsin Department of Revenue issued a 'Statement of Delinquent Tax Account' against Leo Wanta, citing the identical Social Security Number as was referenced in Angela Dunlap's letter to Mr Wanta's lawyer. This fraudulent 'Statement of Delinquent Tax Account' demanded \$754,839.58 in tax from Mr Wanta, when only three weeks earlier, the Department had formally stated in writing to Mr Wanta's lawyer that the Department had no record of a delinquent tax account in respect of an individual with the same Social Security Number as Lee E. Wanta. It conjured one up three weeks later, but could not sustain that claim.

At various times during the evolution of the Department's misconduct in this case, State officials wrote out tax demands by hand, not entering them on the Department's computer systems, eliminating, as expedient, any audit trail.



Figure Q: On 27th May 1994, Special Agent Charles L. Wnukowski, of the Wisconsin Department of Revenue Special Investigations Section, Fraud Unit, sent a copy of the banked check illustrated in Figure P on page 13 of this Supplement, plus a copy of the letter by Attorney Thomas A. Wilson to Dennis Ullman of the Wisconsin Department of Revenue [Figure O, page 12], enclosing this extortion payment, to IVIr Ullman himself. The documents were supplied by a Wanta family member. The significance of the above document is that it provides irrefutable proof that Agent Dennis Ullman, who featured in the subsequent kangaroo County Court jury trial in May 1995, held documentary proof of the second payment of \$14,129.00. Therefore, in withholding this information from the jury, Ullman – along with Douglas Haag and James E. Doyle, later Governor of Wisconsin – committed perjury, perverted the course of justice, misled Judge Michael B.
