The matter under consideration began when Leo E. Wanta, designating himself as "stipulated petitioner for Falls Vending Service, Inc.," filed various motions challenging actions taken by the United States Bankruptcy Court for this district in a case entitled In Re: Falls Vending Service, Inc., Debtor (Case No. 83-02385). Wanta's motions are resisted by the Farmers and Merchants Bank of Menomonee Falls, a secured creditor in the bankruptcy action. Magistrate Robert L. Bittner, after a thorough examination of the matter, has recommended dismissing the action because Wanta lacks standing and also has failed to properly invoke this court's jurisdiction. I concur in the magistrate's analysis and adopt his recommendation in full.

In his written objections, Wanta contends that the magistrate's analysis of his standing is faulty because Falls Vending Service is not a legal and valid corporation, and therefore, cases holding that a corporation can only be represented by

licensed counsel do not apply to this matter. Even if Falls Vending Service is not a corporation, Wanta lacks standing because his affidavit testimony indicates he is only an employee of the company. The owner of a company cannot confer standing on a non-lawyer employee by stipulation or otherwise.

Wanta's objections do not address his failure to properly invoke this court's jurisdiction. No complaint has been filed. Wanta failed to follow the proper procedures to perfect an appeal pursuant to Part 8, Rule 8001 et seq. of the United States Bankruptcy Rules. The matter must be dismissed sua sponte for lack of jurisdiction.

THEREFORE IT IS ORDERED that the action is hereby dismissed.

Wanta protests all the way to prison

■ "You were wrong," the tearful convicted tax cheat tells his prosecutor

MADISON — Former Appleton businessman Leo E. Wanta was sentenced Monday to eight years in prison followed by six years of probation for filing false income tax returns and hiding taxable income in

1988 and 1989. Dane County Circuit Judge Michael Torphy imposed the sentence nearly two years after Wanta was returned to this country from a Swiss jail to answer the state charges. Stammering and tearful, Wanta continued to protest his innocence. "I'm very stunned," he said. "I know there's conspiracy and subterfuge here," he said in a rambling recount of his claims of having been an undercover federal agent in Asia and Europe who was exempt from state taxes. "I just want to get out of here," he said, his voice breaking. "This is

bogus." He tearfully thanked Torphy for freeing him on bond to live with his daughter and care for her twin sons who were born after he was arrested.

He told the judge that Department of Revenue Special Agent Dennis Ullman, Appleton, "continues to manipulate Doug Haag," the assistant attorney general who prosecuted him.

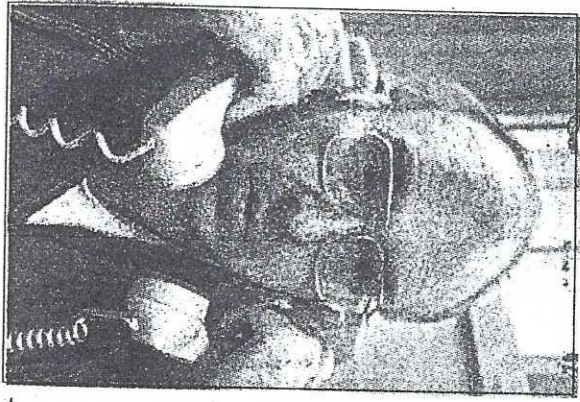
As sheriff's deputies prepared to remove Wanta from the courtroom, Haag shook his hand and wished him luck. Wanta answered, "You were wrong." Wearing handcuffs and a dark pinstripe suit, he was led

off to jail. Haag dismissed Wanta's stories as those of "a 55-year-old man who is a calculating, manipulative con man."

Haag asked the court to impose maximum sentences of 13 years in prison and nine years of probation. He also asked the court to require restitution of unpaid taxes and penalties totaling \$671,819 plus court costs and public defender's costs.

The state said Wanta earned more than \$166,000 in 1988 and \$63,000 in 1989 but filed income tax

J. Ray McDermott & Co., a major builder of oil platforms, paid \$508,615 in bribes to the vice chairman of Tenneco Oil Co. to undertake lucrative construction projects in the Gulf of Mexico. But the cost of doing business jumped unexpectedly last year after the firm pleaded guilty on seven criminal counts. A Federal judge in New Orleans not only fined McDermott \$103,000, but confiscated its \$897,000 in illegal profits from the Tenneco deals.

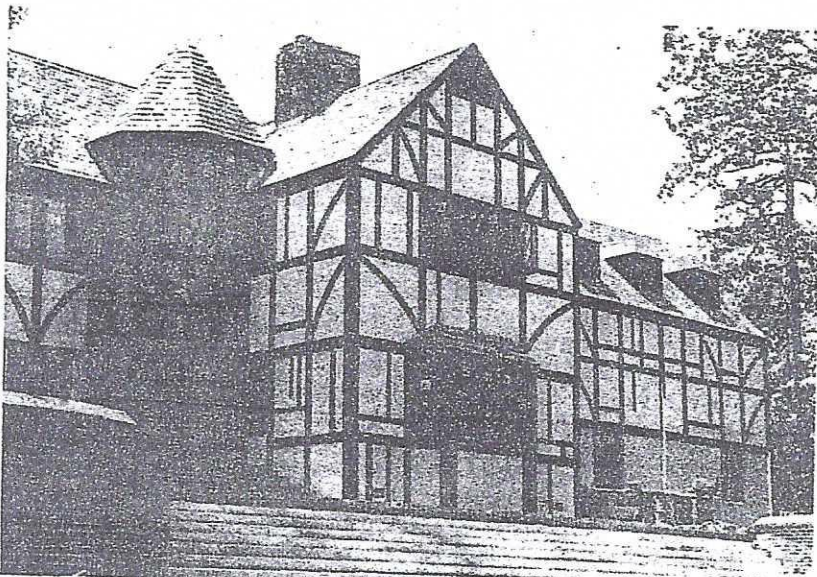
While serving as mayor of Lansing, Ill., for sixteen years, Jack O. McNary shook down real-estate developers and invested his booty in two private businesses. Convicted last year of extortion, McNary was sen-

pit as underworld hit men. While Justice officials concede the law must be applied cautiously, they see no need to sheath their weapon. "This is a valuable tool," says Attorney General-designate Benjamin Civiletti. "We will not shy away from using it to pursue corrupt enterprises which do not fit the layman's view of organized crime." With about 200 RICO cases already filed, and the government increasing its use of the statute, the American Bar Association has scheduled a special seminar on how to deal with RICO at its convention this week.

RICO is one of the broadest criminal statutes Congress has ever passed. The law first enumerates 24 Federal and eight

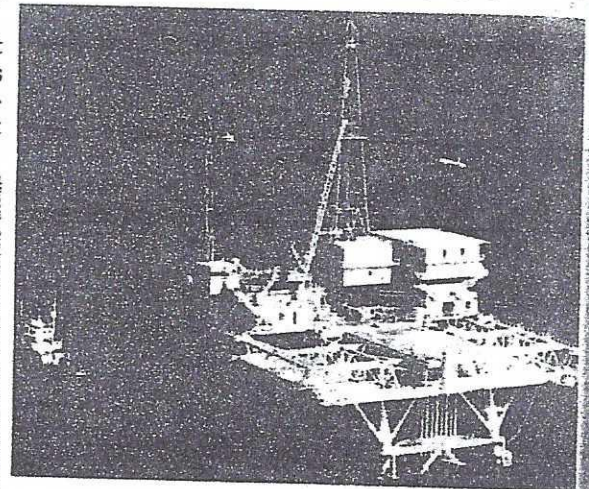
led seven nursing-home owners and three pharmacists to plead guilty and pay fines of \$1 million.

The law also gives prosecutors extraordinary latitude to trace crime back to the otherwise insulated kingpin. "The statute allows a prosecutor to paint a broader picture than could be normally seen by a jury," says Jeremiah T. O'Sullivan, chief of the Organized Crime Strike Force in Boston. For instance, John Christopher was tried in Tampa, Fla., in 1975 for masterminding a ring that kidnapped women and forced them into prostitution. Normally, the scope of the evidence would have been limited to the specific kidnapping; at the RICO trial, however, the judge permitted

tenced to three years in prison. He will also have to ransom his businesses, which the government now effectively controls.

These cases share a dubious distinction. The Justice Department prosecuted them—and other button-down crimes—with a law designed specifically to convict Mafia capos. Known as RICO (Racketeer Influenced and Corrupt Organizations), the nine-year-old law allows the government to seize legitimate businesses if they have been used for illegal schemes or as investments for dirty money. Says Chicago attorney Sherman Magidson, "RICO can reach out and castrate people."

The RICO law frightens many lawyers and judges. They worry about language so loosely drawn that it lets the government sweep even small-time white-collar defendants and public officials into the same

state crimes such as murder, extortion or mail fraud; then it states that anyone found to have participated in two of them within a ten-year period has undertaken a pattern of racketeering. If prosecutors can link such patterns to an interstate "enterprise"—loosely defined as virtually any personal association or business—the defendants become subject to imprisonment for up to twenty years, fines of \$25,000 per count and forfeiture. "Taking away businesses from these guys is like taking away tools from a burglar," says New Jersey Federal prosecutor George Wilson.

RICO is an extremely potent weapon for prosecutors. In plea bargaining, when most cases are settled, the potential RICO penalties often lead defendants to make a deal with the government rather than take their chances with a jury. In Chicago, for instance, the fear of forfeiting their businesses

The government has used RICO in several important prosecutions against reputed mobsters. In Chicago, two alleged organized-crime hit men were sent to prison for 30 years after RICO convictions. And in Boston, after convicting four extortionists, the government seized the contents of five massage parlors—including 5 gallons of massage lotion and a Christmas tree.

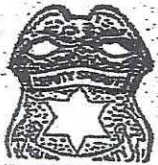
VICTORY: Much of the controversy about RICO has focused on white-collar and government corruption cases. Federal officials won an important victory last month when the U.S. appeals court in New York upheld a guilty verdict in a complicated RICO hospital-fraud prosecution. Prosecutors established that Karl R. Huber, a Phi Beta Kappa Princeton graduate and Harvard law-school-trained attorney, had

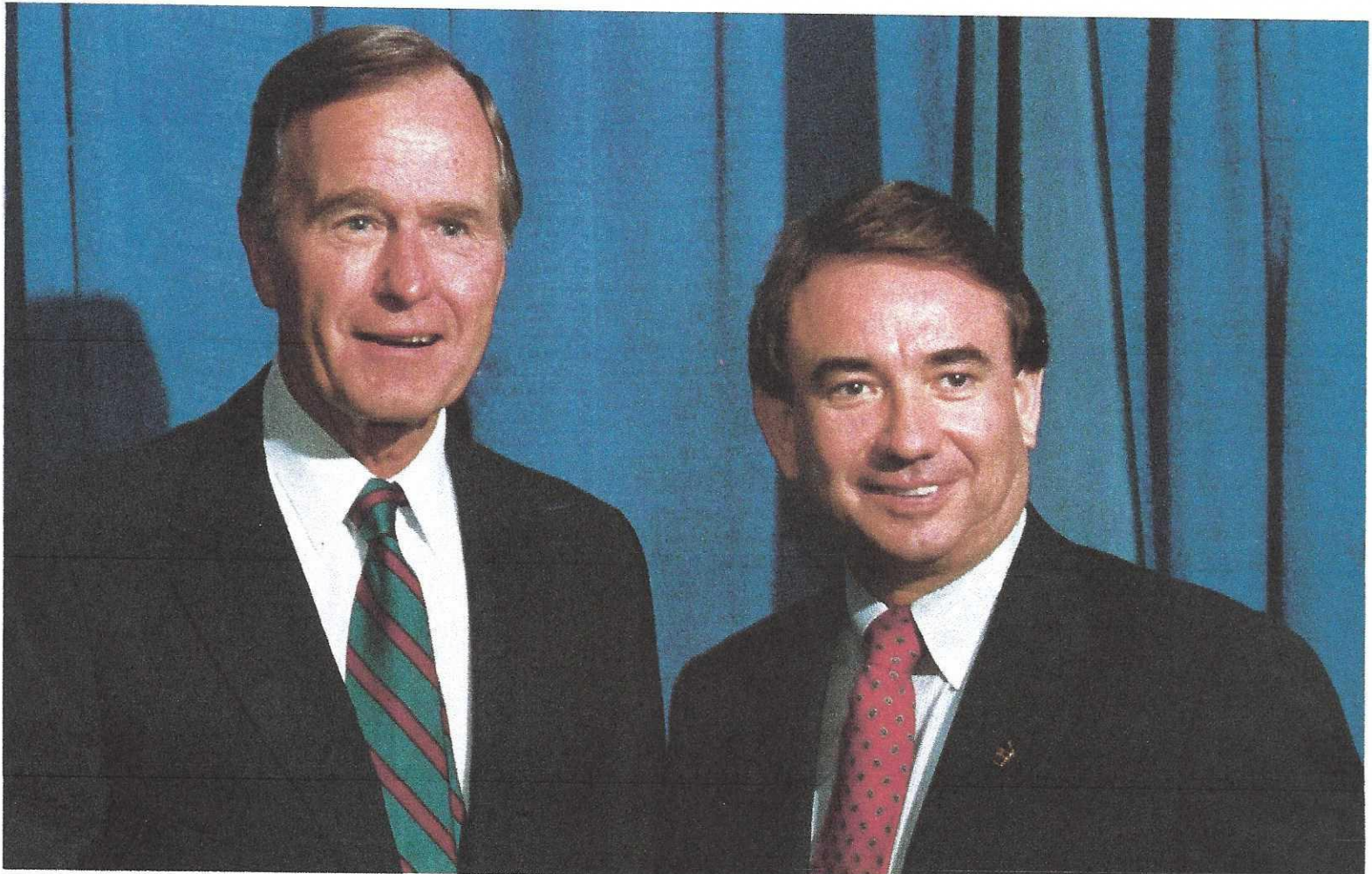

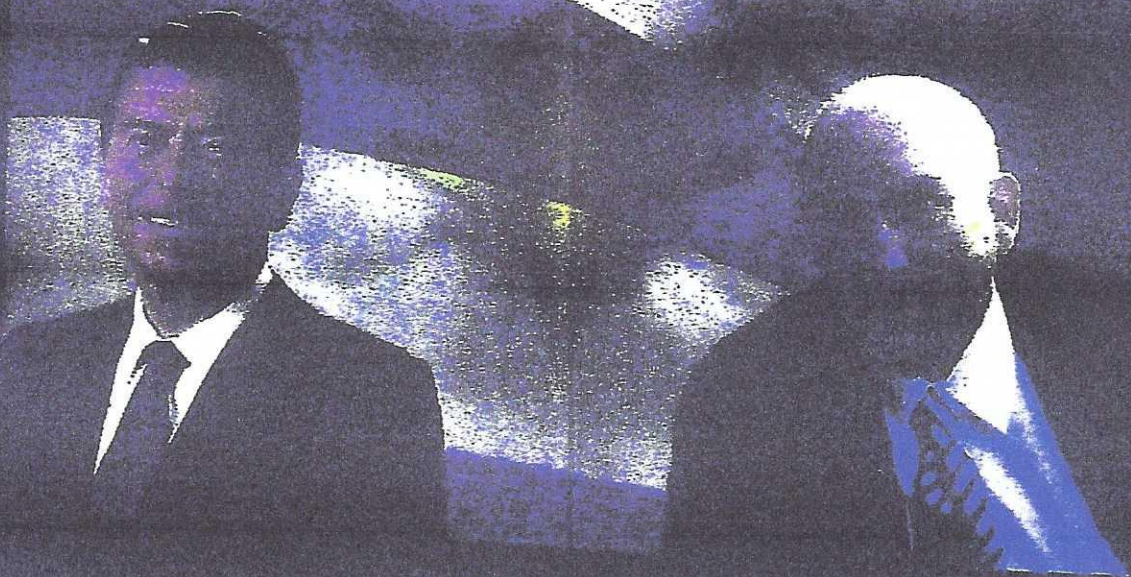

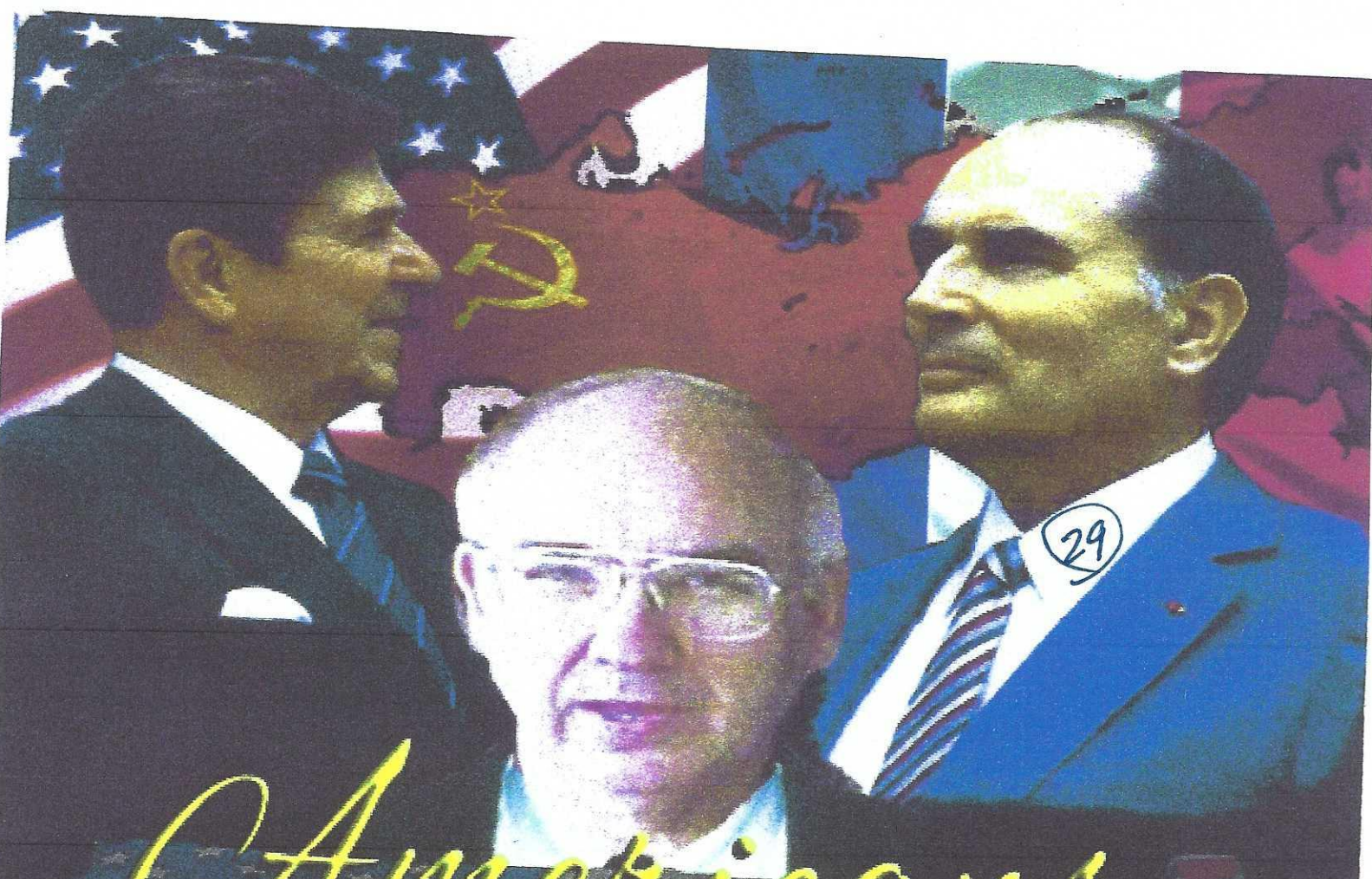

■ State Rep. Johnnie Morris-Tatum, D-Milwaukee, struck a deal with the state Ethics Board last week in which she agreed to pay a \$1,000 fine in addition to \$1,800 she repaid the state last year for some \$12,000 in personal phone calls billed to the taxpayers.

"It's frustrating, isn't it?" Ethics Board Executive Director Roth Judd told the Journal Sentinel. "The bill went to taxpayers a long time ago. This was as much as we were able to get back."

Morris-Tatum's phone tab included \$6,000 in overseas calls, mainly to Senegal. She claimed the calls were for legitimate state business, but when asked by the Journal Sentinel for proof, she couldn't provide any.

We often hear how people in the public sector miss out on the perks private companies offer their workers.

Well, here's something else that happens in the private sector. If you're caught stealing from your employer, the best you can hope for is to get your dishonest but fired. More likely, especially where thousands of dollars are involved, it's turned over to law enforcement, and you are prosecuted, which could mean probation or prison, and certainly full restitution.

The public must get involved to put the brakes on this disturbing trend, and so should the honest lawmakers and public employees, whose reputations likewise suffer every time one of their own gets caught lying, cheating and stealing from the taxpayers.

"It's with regret, as a former federal prosecutor, to say this, but I am beginning to wonder if there is a pattern of misconduct by prosecutors in that office," said John Fitzgibbons, a Tampa lawyer.

... tice will be launching an investigation into Rubinstein in the more recent case.

"Following the policy of the department on matters involving allegations of prosecutorial misconduct, the U.S. attorney in Tampa has referred the matter to the department's Office of Professional Responsibility for appropriate review," said Chris Watney, a department spokeswoman.

This is the second time the 11th Circuit has thrown out a conviction because of misconduct by Rubinstein.

In 1994, the court overturned the convictions of Tom and Penny Crutchfield for illegally importing iguanas. The court criticized Rubinstein for "intentional misconduct," saying he had improperly attacked the character of the defendants and their witnesses.

"These attacks often continued

even after the [trial judge] instructed the prosecutor as to their impropriety," the court wrote. "The prejudicial effect of this misconduct cannot be disputed."

In the more recent case, the court criticized Rubinstein not for his courtroom behavior but for what he did during the secret grand jury proceedings while seeking indictments against the shrimp company.

Sigma International Inc. and two of its executives were accused of selling millions of dollars worth of bad shrimp. After obtaining the indictment, Rubinstein took the case to trial, winning guilty verdicts against the company; its vice-president, William Andrew Walton; and the plant manager, Charles Sternisha.

All three appealed.

A three-judge panel of the appeals court issued a rare and scathing rebuke of Rubinstein on Nov. 30, 1999. It ruled that Rubinstein had lied to the

convictions thrown out

grand jury, tried to rush its deliberations and made improper remarks to it about unrelated crimes.

Nevertheless, the appeals panel did not throw out the indictments.

But prosecutors, stung by the harsh criticism, came to Rubinstein's defense. They asked the appeals panel to reconsider, arguing that the initial ruling was incorrect and unfair. The defendants also asked for reconsideration.

The result was a second blow more stunning than the first.

Armed with new evidence, the same three-judge panel ruled that Rubinstein's misconduct was so bad the indictments should be thrown out.

"On a national level, this is almost unheard of," said Charles Wolfram, a legal ethics professor at Cornell University who is a leading expert in his field.

"The federal court of appeals is just

sick to death of prosecutorial misconduct and not being able to do anything about it," Wolfram said. "This is a shot across the prosecution's bow."

The Sigma case may prompt defendants across the country to seek reviews of their grand jury proceedings. It is also a case that may end up before the U.S. Supreme Court, Wolfram said.

The U.S. attorney's office declined to comment on the ruling or say whether it will appeal. Rubinstein also declined to comment.

Whatever happens next, Tampa lawyer William Jung, who defended Sigma, said the company will continue to fight.

"We will continue to litigate this case," Jung said. "Hopefully someone in the U.S. attorney's office will give it a real stem-to-stern review ... and put this old shaggy dog of a case to rest."

If the case is resolved in Sigma's favor, the company will get a full refund

of \$1.4 million in fines it has paid as a result of its conviction. "The only question is whether it will be with interest," Jung said.

The two executives, Walton and Sternisha, have been free pending their appeals. Each had been sentenced to between one and two years in prison.

The U.S. attorney's office here was also stung by another ruling in 2000. The Florida Bar asked the state Supreme Court to suspend federal prosecutor Karen Cox for three years for allowing a witness to testify using a phony name during a 1998 trial in state court.

"It's with regret, as a former federal prosecutor, to say this, but I am beginning to wonder if there is a pattern of misconduct by prosecutors in that office," Fitzgibbons said. "The Justice Department is going to have put an end to this."

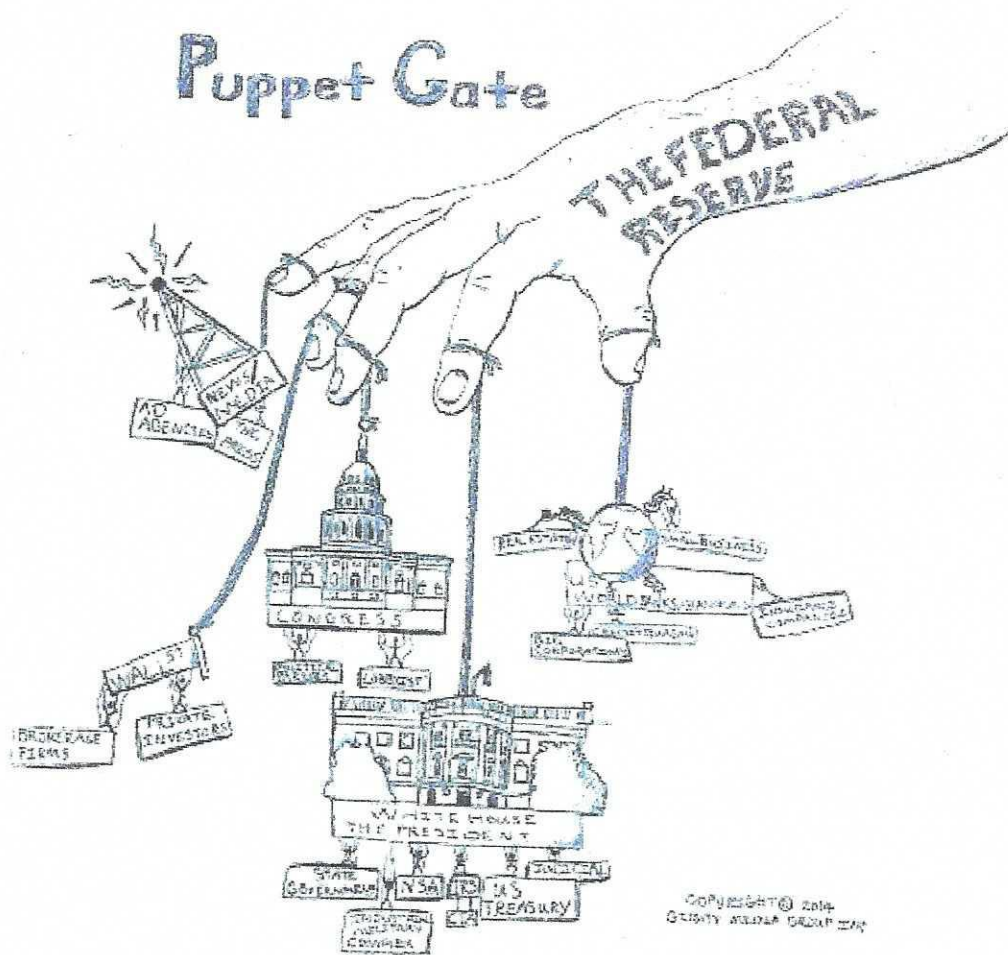

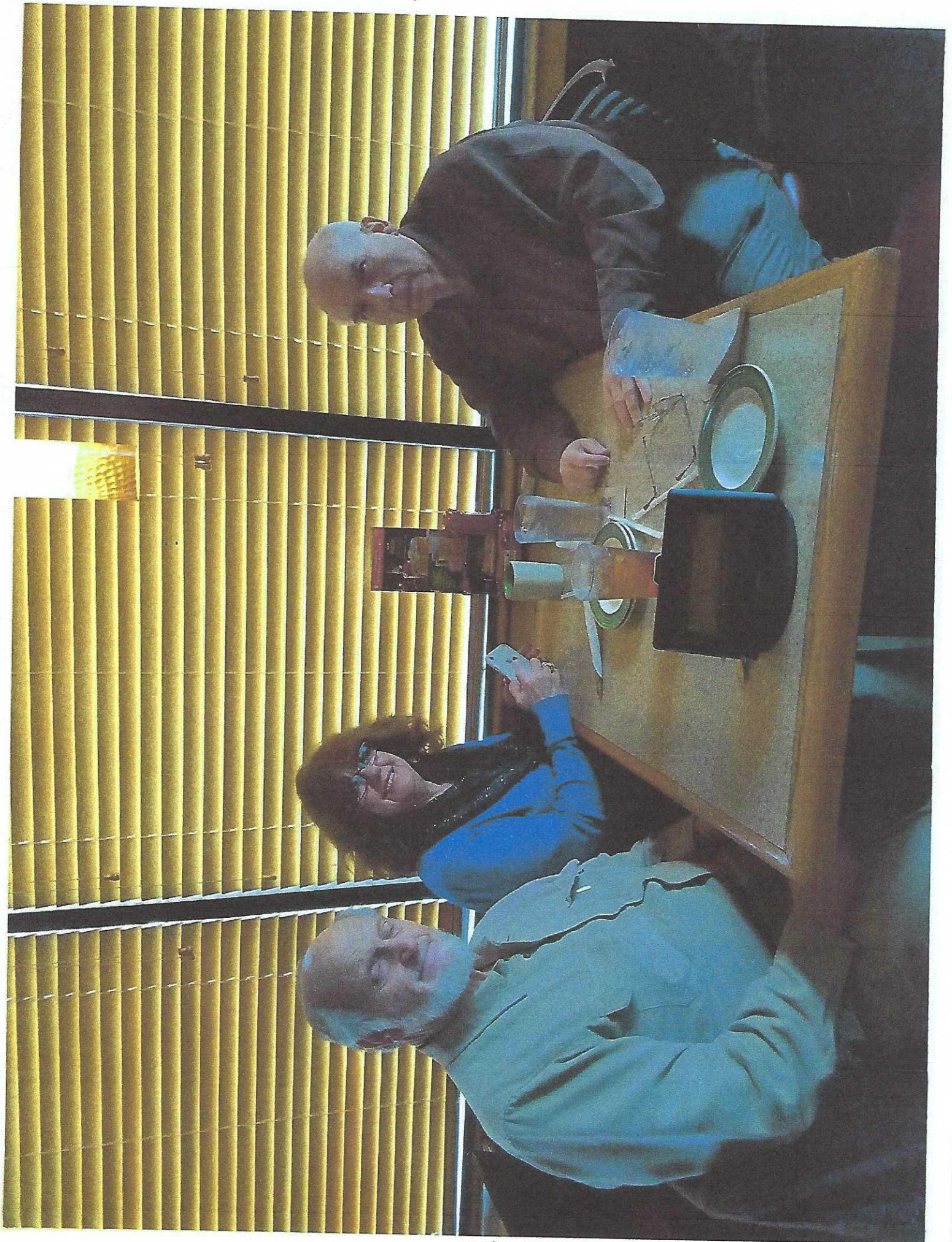

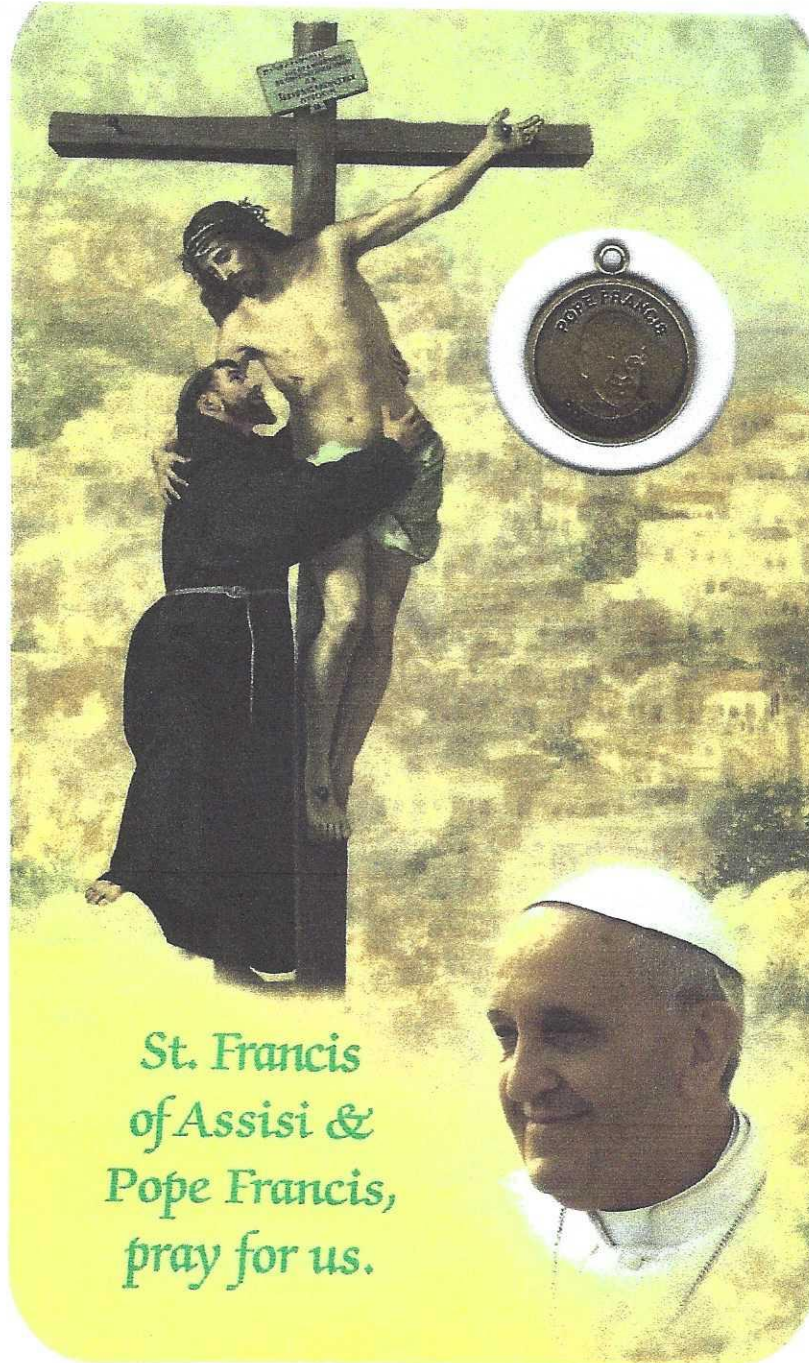
