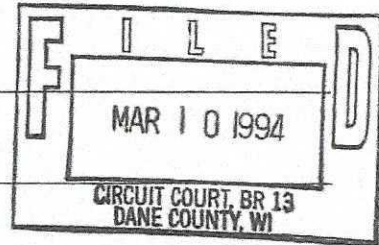

CRIMINAL INFORMATION



Assistant Attorney General Douglas Haag informs the court:

COUNT ONE

That on or about June 11, 1991, at the City of Madison, County of Dane, the above-named defendant, Leo E. Wanta, did feloniously and intentionally render a false and fraudulent Wisconsin individual income tax return for the calendar year 1988 with the intent then and there to evade the income tax due and owing to the State of Wisconsin by reporting in the said income tax return zero taxable income for said calendar year, whereas said defendant had a net taxable income for said calendar year of approximately \$166,372, upon which there was owing to the State of Wisconsin a net income tax of approximately \$10,249, contrary to sec. 71.83(2)(b)1., Stats., an offense punishable by a fine of not more than \$10,000 or imprisonment for a period of not more than five years, or both, together with the costs of prosecution.

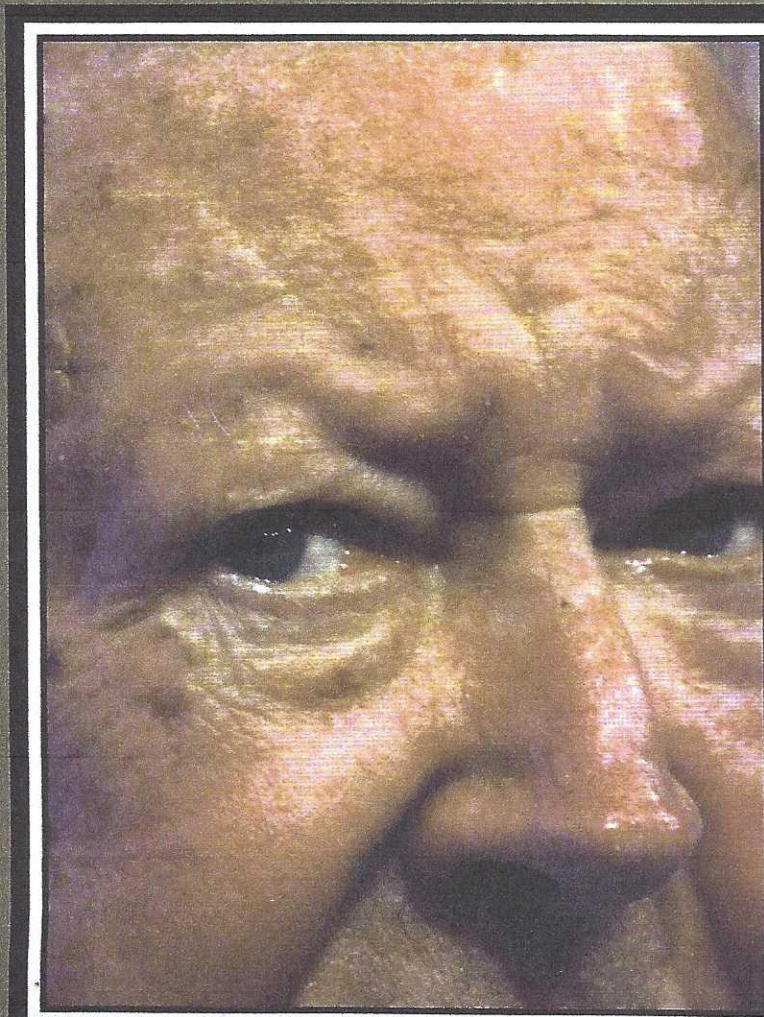

Administration began planning for the inva-
sion of Iraq in January 2001, although it is
quite clear from the advanced stage of inter-
nal documentation circulating in Washington
on this issue then, that planning for such an
operation had been 'in the works' well prior
to President Bush Jr.'s inauguration.

RATIONALES FOR THE IRAQ INVASION

Saddam Hussein's intelligence services (con-
trolled mainly by Qusay Hussein) had alleg-
edly acquired at least one CD of the PROMIS
(originally Prosecutors' Management Infor-
mation System) software, first developed by
William Hamilton, which essentially merges
conflicting computer software programs so
that targeted computers' data can be read re-
motely by a PROMIS software-compatible
installation (enabling, for instance, bank bal-
ances to be altered and raided remotely).

It is believed that Iraqi intelligence, having
acquired a copy of the PROMIS program
ostensibly on the Soviet 'black market' (i.e., it
was made available to the Iraqis by Soviet
intelligence (GRU) in exchange for a substan-
tial payment, believed to have been of the
order of \$2.0 million for a single disk), pro-
ceeded to remove bank balances from one or

more sensitive US-'owned' bank accounts,
including (it is alleged) a bank account hold-
ing funds that had already been stolen (sorry,
'misappropriated') by a powerful US intelli-
gence 'baron' or his group.

That was bad enough.

But the national security rationale for the
invasion was primarily that the Iraqi régime
had already been doing what, separately, the
Iranian Government had been debating for
some time (according to documentation of
the Central Bank of the Islamic Republic of
Iran that we receive), namely invoicing for
exported oil in Euros.

This is absolute anathema to the United
States for the reason illustrated pictorially by
the two sides of the US Treasury's Diamond
Certificate that we again illustrate (*below and
on page 23*). As explained in the captions to
those illustrations, the cost to the Bureau of
Printing and Engraving of producing Dia-
mond Certificates is minimal (anything from
\$100 maximum down, to just a few cents,
depending upon the volume produced).

Your correspondent is himself a master
printer, controlling printing machines, and is
therefore familiar, obviously, with printing
methodology. If, say, 32 or 64 Diamond Cer-

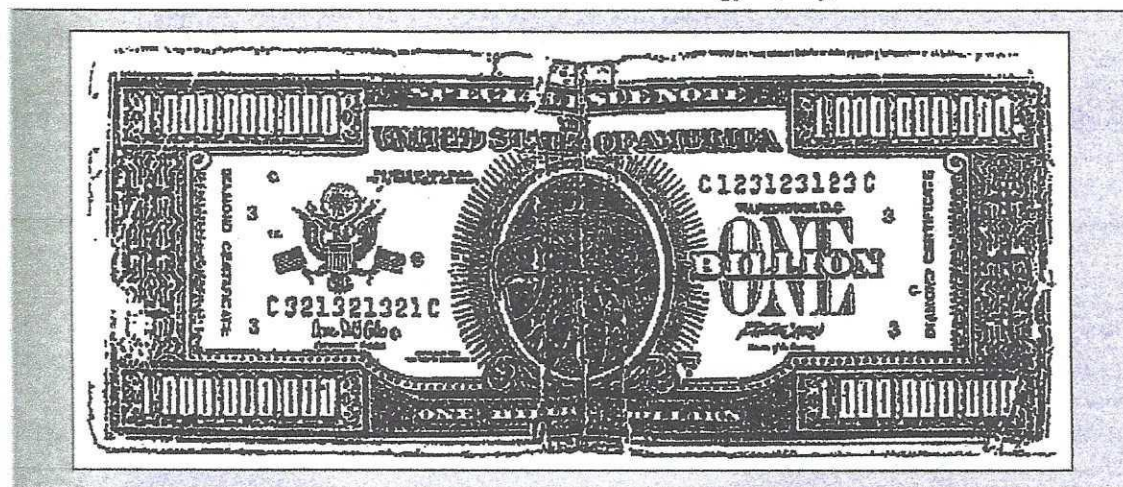


Figure 6A: This image, and Figure 6B on page 23, show the face and reverse of a US Treasury Diamond Certificate, with face value of \$1.0 billion. The reason for its tatty appearance is that it was evidently held in the billfold of a prominent solicitor in Singapore, who allegedly attempted to trade it at a discount with other corrupt parties. The details underlying this relevant scandal are omitted here because the point of showing this Diamond Certificate is to illustrate how US oil imports are financed. The cost of printing this instrument is minimal, but in the hands of the payee, it acquires \$1.0 billion worth of purchasing power.

tificate images are printed on a single sheet, and 1000 such sheets are printed, then with each finished (cut and trimmed) Diamond Certificate having a face value of \$1.0 billion, the total value of the thousand sheets would be \$32,000,000,000,000, or \$64,000,000,000,000.

In the hands of the Saudi Arabian Monetary Agency, for instance, one Diamond Certificate having a face value of \$1.0 billion is 'worth' \$1.0 billion of purchasing power.

Yet it has cost the United States just a few dollars or cents to produce. Therefore, the United States purchases its oil for pieces of paper costing a few dollars or cents, which acquire purchasing power thanks exclusively to the prospective holder's reliance on the legend of the Full Faith and Credit of the United States. Any threat to this fiat system represents a grave threat to the continued existence of United States as a viable economy, because if it became necessary for the United States to remit for its imported energy with foreign currencies (Euros, or even sterling, or else Japanese yen), these could only be obtained in exchange for real goods and services, rather than pieces of paper.

It would accordingly become immediately unavoidable for the United States to run large foreign trade surpluses in order to earn sufficient foreign currency holdings to be able to pay for its imported oil, and the American people would rapidly experience an historically unprecedented collapse of their living standards, leaving the United States in danger of fragmentation.

The invasion of Iraq decapitated the erring Iraqi dictatorship, and served as a warning to other oil-exporting countries, such as Iran and Venezuela, or a radicalised Saudi Arabia, that might conceivably toy with the idea of invoicing in Euros.

But just as critically, the United States also needs, in the national interest, to remain confident that sizeable oil importing countries, such as China and Japan, do not, on the other side of the ledger, start paying for the oil they

import in their own currencies, or in some foreign currency other than the dollar. That is obviously an even greater danger to the perpetuation of the oil-dollar system than the prospect of oil exporters starting to invoice in currencies other than the dollar. All except enemies, have an interest in the *status quo*.

The Pentagon's planners, who were hard-pressed to elaborate a 'saleable' explanation to cover the invasion of Iraq refrained from implicating key foreign powers in the 9/11 attacks, notwithstanding that the text of a message from Uday Hussein to President V. Putin dated June 2000, in which arrangements for the attacks were outlined, had been intercepted and passed obliquely into the public domain by intelligence sources [see the preceding issue of this service, page 222].

As subsequent events have shown, the US Government failed to provide a coherent and reliable rationale for the invasion, inducing universal scepticism concerning official US motivations. To provide cover and to ensure that the inevitable international odium for the necessarily brutal adventure would be shared, Washington needed a military ally to cooperate in the operation, the most obvious country being Britain. Australia, which is the location of the centralised New Underworld Order global control installations near Alice Springs, was further persuaded to join what became the curiously titled 'coalition of the willing'. In any future military operations, the United States will not be able to rely upon the cooperation of the British, unless Britain leaves the EU – as current geopolitical events make much more likely – since, as indicated in the box on page 20 the EU-oriented UK Ministry of Defence is planning to integrate into a fully equipped 'European Army'.

This will in all probability be equipped largely by countries other than Britain, so that it could soon become 'impossible for British forces either to operate independently or to fight alongside those of the USA'⁴, as we have predicted in earlier analyses.

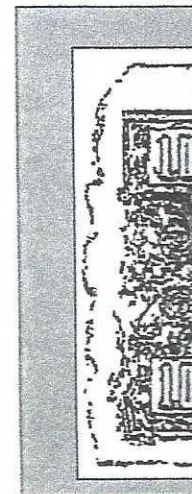


Figure 6B: Say that sheet is 'worth' \$64 adding-in all of the disposal of oil product US dollars. Any cou
