I know you are busy and have a life... lol... so whenever its good for you.. lets talk !~

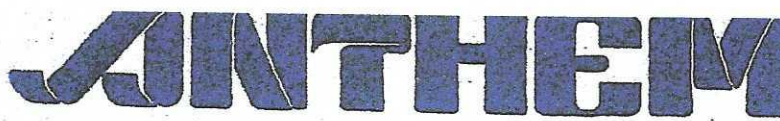

So the email address is tuscansun@comcast.com and is not listed under "Connie." Since I don't think I have heard you use the words "they decided to die..." I have no idea if she's talking with you or with someone else who says he's Lee Wanta. If you want me to provide Connie with information about Michael Cottrell et al, send me what you want me to provide and I will do so. I have no intention of talking about CMKX or to a CMKX group.

Also, all of my AmeriRail files are enclosed on a disc. When I get time, I will continue to edit and copy other files from three hard drives. There are, I'm sure, repetitious files. No way to avoid it - they were saved on D (which used to be C, the drive that was hacked in Dec 2009 after I did the hsr interview with Chuck Wilder and Heneghan wrote about the hsr article). At that time, the computer was acting crazy so I copied all the files I could to the H drive (external) before C crashed (and later became D). Each of the drives has individual files that don't appear on the other two. So, when copying, a lot of decisions have to be made about which file with the same name but a different save date should be copied. It takes time and even then I'm sure I'm saving duplicates and possibly deleting some non-duplicates. I'm saving everything as of 2/1/11 on an 8 GB flash drive so it will, at some point in the future, all be on one instrument I can send you - probably by 2016.

Hello, Lee.

Enclosed are two discs containing the two-hour radio show minus commercials. On the first hour (#1), I recorded two different segments. Track 2 is the beginning of the show. I heard from Kay that you had a chance to listen... I'm so glad I sent him a series of questions about you designed around the material I planned to cover. His style left a lot to be desired - I'm sure mine did, too. Clay talks so loud, I had to hold the telephone away from my ear and there were a lot of technical errors. Not complaints, just facts. You'll notice that some words are cut in half in Liberty Broadcasting's cached recording (no recording problems at my end, but there are with Liberty Broadcasting's taped file), and sentences, too, sometimes. It didn't air that way (according to C.J.). It must have happened when they edited the tapes for their library. Re the interview, it's obvious I don't know anything about the Global Fund nor CMKX (and have no desire to learn), but everyone seems to assume your funds are tied up as part of a giant trust in the sky, no matter how many times I say they aren't... and say it pretty clearly from my perspective. 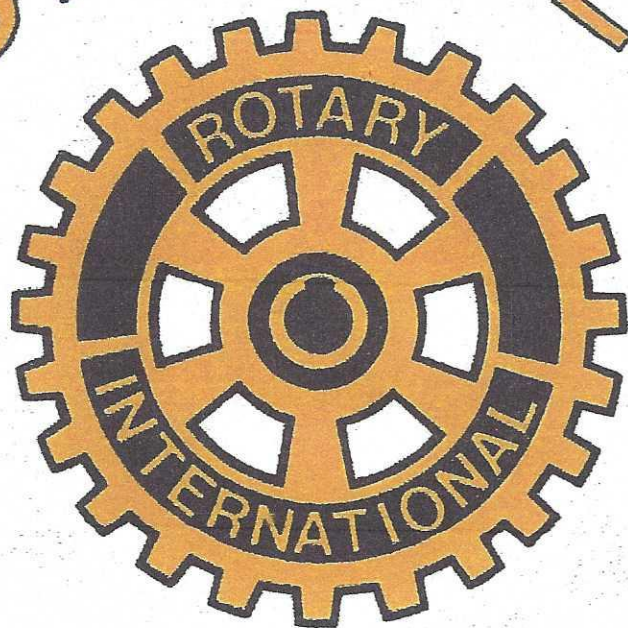

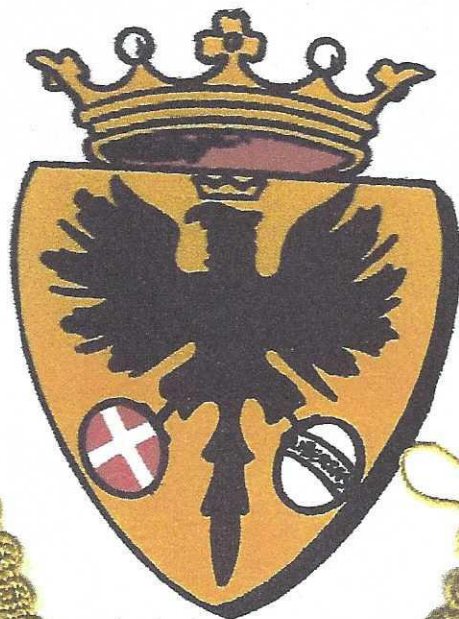

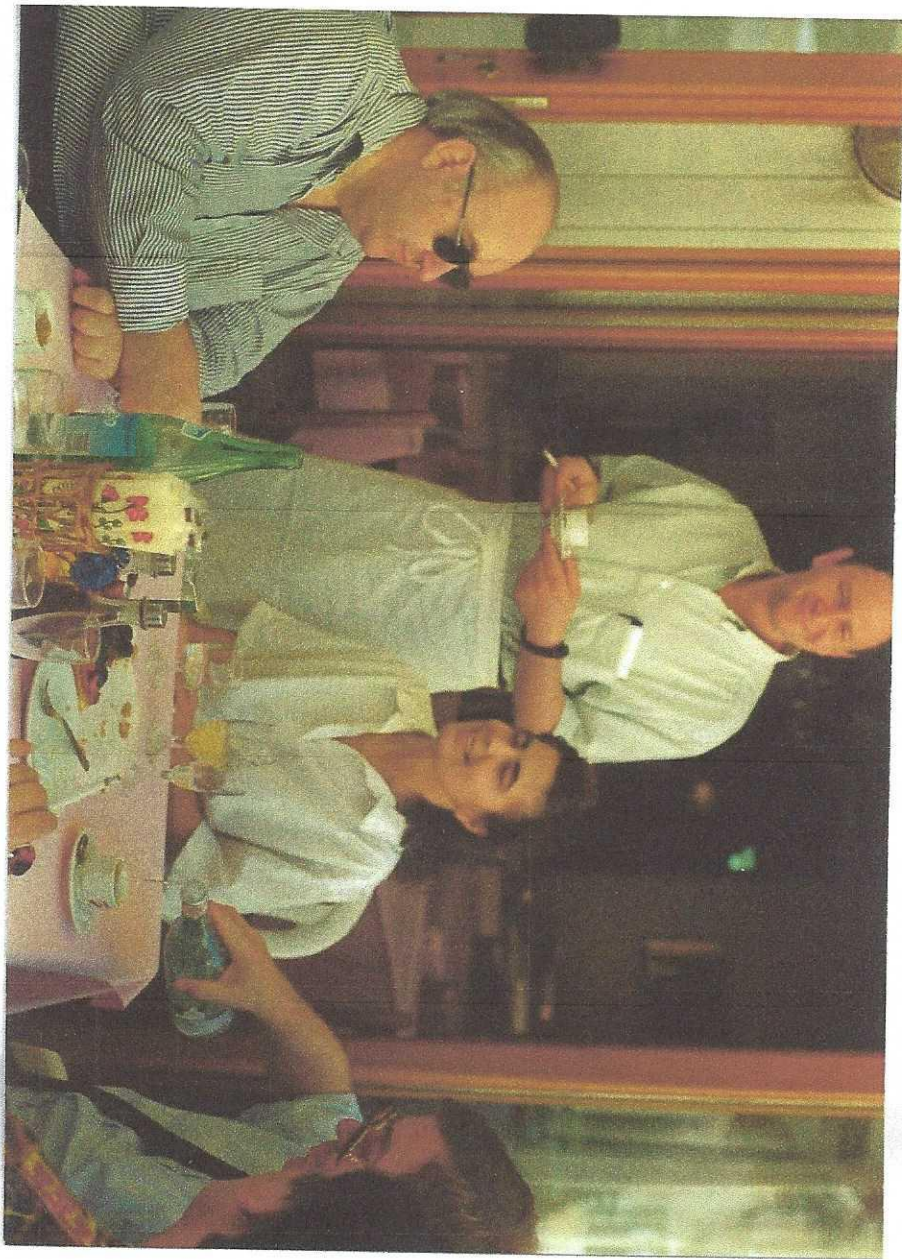
