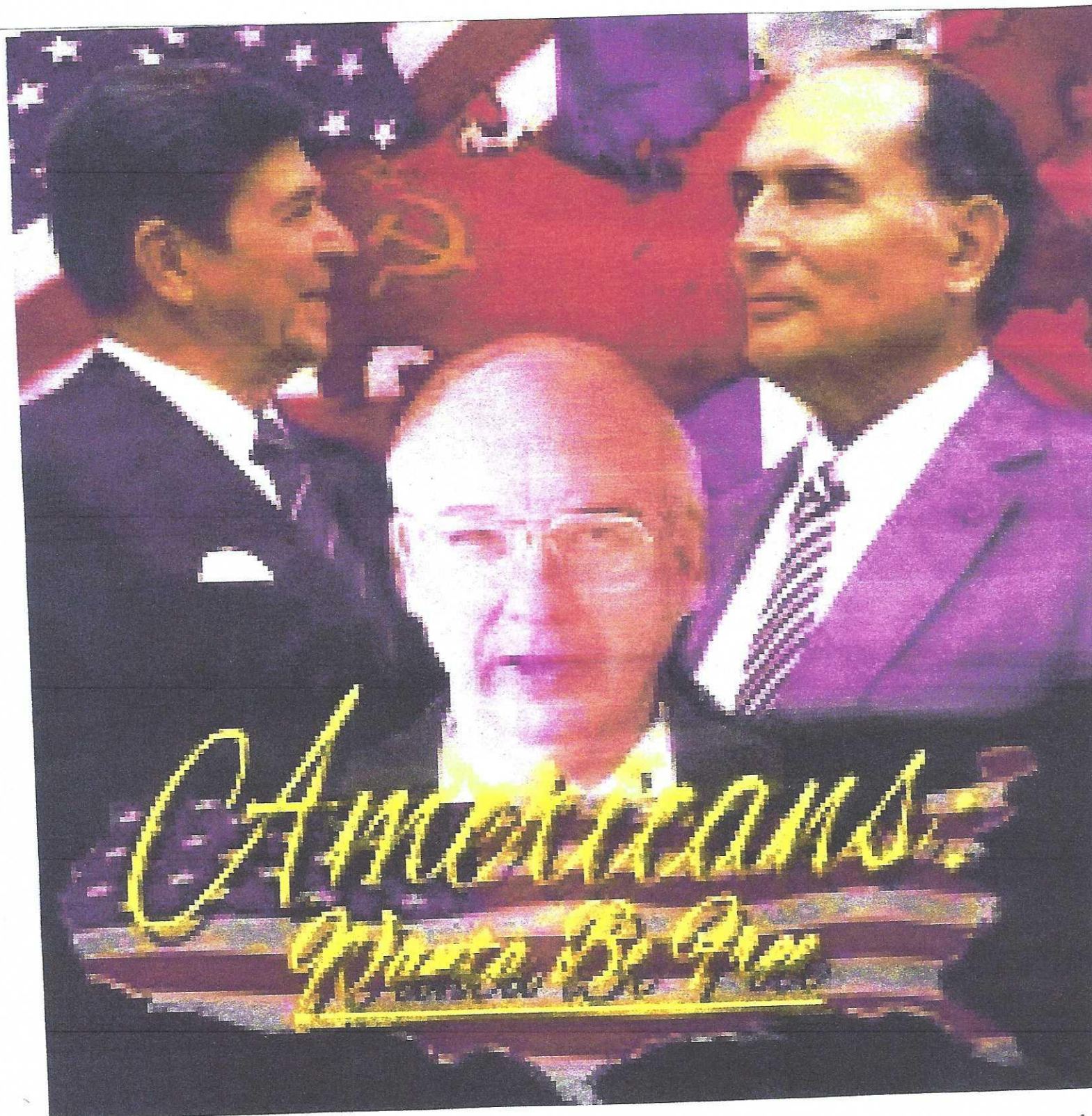

Dear Mr. Attorney General:

Purpose of my letter is to verify or discredit information about what appears to be the unlawful extradition by the State of New York of a prisoner held with no charges filed against him by officials at the Brooklyn House of Detention in December 1993.

NAME OF PRISONER:	Leo Emil Wanta (term 12/01/93)
COURT CASE:	93-M-2072 (term 12/01/93) CRIMINAL

JUDGE:	Allyne R. Ross, U.S. District Court, Brooklyn

INFORMATION REQUESTED: (1) Copy of Arrest Warrant used by New York Detectives to re-arrest Ambassador Wanta on the steps of the courthouse where he had just had all Wisconsin UFAP charges dismissed (because an Australian newspaper editor determined the tax warrants filed by the State of Wisconsin to obtain the UFAP were "doctored" and that signatures and names and addresses were "pasted" over other data on these tax warrants, this results in possible charges of fraud upon the court in both New York and Wisconsin for which there is no Statute of Limitations);

(2) A copy of the extradition agreement signed by Leo Emil Wanta sometime between October 19, 1993 (the date of Judge Ross's dismissal) and December 13, 1993 (the date the State of New York transported Wanta from the Brooklyn House of Detention to the State of Wisconsin;

(3) A copy of the charges filed against Leo Emil Wanta by either the State of New York or any other party to the arrest in New York by New York City Detectives.

A Freedom of Information Act request is enclosed.

Should you wish further information regarding what is being said in my book about the unlawful involvement of the actions taken by the State of New York, the following information is provided.

Published in my latest book, *WANTA! Black Swan, White Hat* (Amazon.com/Kindle). I wrote a letter to your office June 15, 2013 requesting confirmation or denial that the State of New York was involved in an unlawful arrest and extradition of Leo Emil Wanta, Ambassador for the Nation of Somali to Canada and Switzerland. I got no response and so continued with the publication of the book four months later.

On 7 July 1993, the Suisse Sûreté arrested (Somali) Ambassador Leo E. Wanta, an American citizen. No charges were ever filed against Ambassador Wanta by the Swiss yet he was held for over four (4) months in solitary confinement... no doubt because he was a Secret Agent of the United States who reported directly to the President of the United States. He was investigating the unlawful use of "dead" (or what should be dead) credit instruments... e.g., Letters of Credit, etc., that were being reactivated by the Swiss. It was called Operation Chasetlet and several New York banks were involved in the scam.

In Switzerland, Wanta never had contact with a lawyer (though a substantial amount of money was paid to a Msr. Paschoud's law firm). On 16 November 1993, a letter to Mr. Wanta from Israeli Prime Minister Yitzhak Rabin was received at du Bois Prison in Lausanne and the next day Ambassador Wanta was very hastily put on a Swiss Air flight back to the United States. Upon his arrival, Wanta identified himself to the F.B.I. when he de-planed in New York (cleared Customs – I have those forms if they would be helpful) and was placed under arrest by the State of New York on 17 November 1993. He was taken to the Brooklyn House of Detention. There was a brief hearing that same day and the matter was scheduled to be heard by Magistrate Allyne Ross in Federal District Court, Brooklyn, on November 19, 1993.

(As an aside, the Swiss finally managed to hold a Tribunal Hearing regarding Ambassador Wanta seven years later – on 17 November 2000... the court transcripts make it quite evident what a travesty of justice it was! That, too, is covered in the book.)

**Magistrate Ross dismissed all charges** – which came from the State of Wisconsin... the "reason" that Ambassador was arrested in Switzerland in the first place was a UFAP which has since proven to be totally false (and Magistrate Ross was absolutely correct to dismiss the entire thing). It is a long story and I will be glad to provide you with any information you feel might be helpful to you. I will attach to this email the Court Docket and Dismissal Form signed by Magistrate Ross. The tax warrants used to create the UFAP have within the past month been determined by an Australian newspaper editor to have been "phonied." Signatures and Wanta's name and address were pasted to the tax warrants. This material is currently being submitted to experts to determine if fraud upon the court (which eliminates any Statute of Limitations, as I am told by counsel) occurred.

Before Ambassador Wanta could depart the court building, two New York Detectives re-arrested him. They had no warrant and no Miranda rights were given him (for this second arrest). He was returned to the Brooklyn House of Detention. A former Officer at this institution can verify the following information... Captain Madigan. 21/



Following is the text as it appears in Wanta!: Black Swan, White Hat.

“When Wanta saw the FBI Agents who were awaiting him at the airport, he immediately identified himself as the person they wanted. New York court transcripts verify that.

“After going through Immigration using his Diplomatic Passport issued by the Democratic Republic of Somalia and re-entering the U.S.A. legally, Wanta was taken to the Federal Detention Center in Brooklyn. There was a brief Arraignment in the Federal District Court of Judge Allyne Ross in Brooklyn, held on 17 November and Wanta appeared in Judge Ross’s Court on 19 November 1993.

“All charges were dismissed by Magistrate Judge Ross. Leo E. Wanta walked out of the Courtroom a free man – and, because of a wire from Wisconsin to the New York Police Department making the same old charges using the same old Tax Warrants (you’d think those phony Warrants would be tired by now), Wanta was re-arrested by New York Detectives and was taken back to the Brooklyn Detention Center.

“And that is how the State of New York became complicit in the unlawful imprisonment of Leo Wanta. There was no warrant, no Miranda rights, no crime was adjudged against Wanta, and there were no charges filed against him by New York State (or any city or county in that state). Regardless, he was held for almost a month in the Brooklyn facility. He and Captain Madigan quickly became friends and Lee, because he is a trained Emergency Medical Technician (EMT), was put on suicide watch... meaning Lee was watching out for others. He agreed to be extradited from New York to Wisconsin provided the extradition take place quickly. It was close to the holidays, Wanta thought the charges to be ridiculous (which they were), wanted to get to Wisconsin quickly and get the matter settled quickly so he could spend the holidays with his adult children and so agreed to sign a seven day extradition permission form.

“The extradition papers he signed in New York placed a seven (7) day limitation on the validity of the extradition. In other words, New York had his permission to extradite him provided the extradition occurred prior to November 27, 1993 (possibly November 28, 1993). Wanta was not returned to the State of Wisconsin until 13 December, 1993... which suggests the State of New York also became involved in an unlawful extradition, as a result.”

Another quote from the book comes from the court transcript:

“The comments made by Wanta’s legal counsel in New York, when the Swiss flew him back to the United States, and where he was taken into Federal District Court over these charges will, perhaps, help explain the numerous problems with Wisconsin’s criminal charges against Wanta. The Hearing from which these comments are made was held on November 19, 1993, two days after Leo Emil Wanta was returned in chains to face the Wisconsin criminal charges. The lawyer representing Wanta had less than two days to evaluate the charges, but he got it exactly right when he said:

“Well, Judge, it’s a little unusual in that it’s a UFAB (ph.) [*Barnewall Note: The “ph” means “phonetic” as written by the Court Stenographer; it is a flight affidavit*] not issued in this district, but issued out of Wisconsin. I think they normally do UFAB here.

“Number two, if you read carefully the UFAB affidavit, not the removal affidavit from this district but the affidavit from Wisconsin, the State charge in Wisconsin is still a complaint, there is no indictment, number one.

“Number two, it is... the complaint is bare of dates. There is no statement when my client left the country and when the complaint was returned. The only statement in the UFAB complaint is once he was abroad, there is a statement that at some point when he was abroad he was given notice of the pendency of the charges, and further, earlier before there were any charges, an agent says that he told him he intended to file charges.

“Of course, the agent’s intent is almost irrelevant in this, because the agent, certainly in no jurisdiction that I’m aware of, has the power to file charges. He can ask a judge to sign a warrant or he can ask someone to file a complaint. But he doesn’t have the power or the discretion to do that.

“So any statement of his intent to do that is something that’s going to happen in the future that may or may not happen.”

As an aside, Ambassador Wanta had paid the taxes (though he did not owe them) in May and June (twice) of 1992 – a year before he was arrested for non-payment. The Wisconsin Department of Revenue did not credit the payment until November 1995, six months after his criminal trial in Dane County, Wisconsin. I have copies of the cancelled check and one wire transfer from a Malaysian bank. At the very least, New York did not do its homework before making the second arrest and the month-long detainment (with what appears to be no charges filed). How does the State of New York justify holding someone prisoner (pre-Patriot Act) for a month with no charges filed?

Thus, my request for a copy of the New York State extradition signed by Leo Emil Wanta in which he agreed to be extradited to Wisconsin within seven days and please explain why, after signing no further such agreements, Wanta was not extradited to Wisconsin until 13 December 1993 when he signed the seven day extradition on approximately November 20, 1993. Can your office provide an extradition document that made it lawful for the State of New York to extradite Ambassador Wanta on 13 December 1993? Also please provide me with a copy of the charges filed against him by the State of New York that gave New York the authority to hold Wanta in prison from 17 November 1993 through 13 December 1993, when the charges Wisconsin filed against him (used as the base for his arrest in Switzerland and then New York) were dismissed on 19 November 1993, by Magistrate Ross.

Attachments to this email provide links that will make documents available to you regarding the 19 November 1993 dismissal, the Ambassador’s re-entry back into the United States, etc. More documents are available. Should you wish it, I have a complete court transcript from the 19 April 1993 hearing. Should you wish a copy of the Somali Diplomatic Passport used by re-enter the United States and the letters signed by the officially recognized (by Somalia) President appointing Leo Emil Wanta as Ambassador to Canada and Switzerland, I will be glad to provide those documents. I simply cannot fathom how a man can be held in a New York Prison for almost a month (after a New York Court has just dismissed the Wisconsin charges against him) without having any charges filed against him.

Thank you in advance for your assistance in this matter.

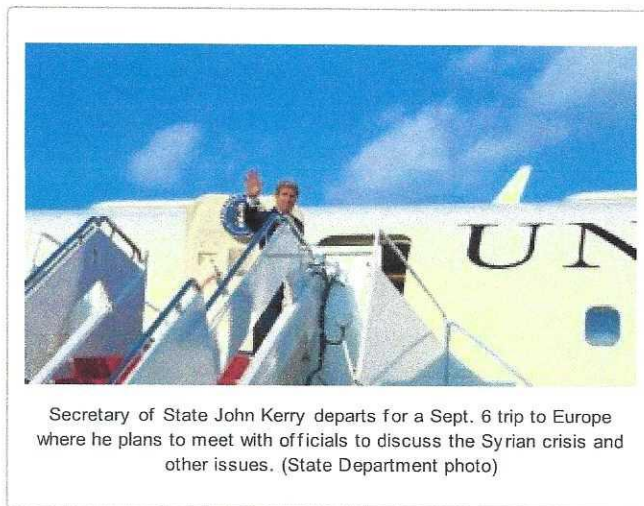
The fraudulent nature of Powell's speech was a no-brainer. And so, that very afternoon we strongly urged your predecessor to "widen the discussion beyond ... the circle of those advisers clearly bent on a war for which we see no compelling reason and from which we believe the unintended consequences are likely to be catastrophic." We offer you the same advice today.

Our sources confirm that a chemical incident of some sort did cause fatalities and injuries on August 21 in a suburb of Damascus. They insist, however, that the incident was not the result of an attack by the Syrian Army using military-grade chemical weapons from its arsenal. That is the most salient fact, according to CIA officers working on the Syria issue. They tell us that CIA Director John Brennan is perpetrating a pre-Iraq-War-type fraud on members of Congress, the media, the public – and perhaps even you.

We have observed John Brennan closely over recent years and, sadly, we find what our former colleagues are now telling us easy to believe. Sadder still, this goes in spades for those of us who have worked with him personally; we give him zero credence. And that goes, as well, for his titular boss, Director of National Intelligence James Clapper, who has admitted he gave "clearly erroneous" sworn testimony to Congress denying NSA eavesdropping on Americans.

## Intelligence Summary or Political Ploy?

That Secretary of State John Kerry would invoke Clapper's name this week in Congressional testimony, in an apparent attempt to enhance the credibility of the four-page "[Government Assessment](#)" strikes us as odd. The more so, since it was, for some unexplained reason, not Clapper but the White House that released the "assessment."

This is not a fine point. We know how these things are done. Although the "Government Assessment" is being sold to the media as an "intelligence summary," it is a political, not an intelligence document. The drafters, massagers, and fixers avoided presenting essential detail. Moreover, they conceded upfront that, though they pinned "high confidence" on the assessment, it still fell "short of confirmation."

*Déjà Fraud:* This brings a flashback to the famous Downing Street Minutes of July 23, 2002, on Iraq. The minutes record the Richard Dearlove, then head of British intelligence, reporting to Prime Minister Tony Blair and other senior officials that President Bush had decided to remove Saddam Hussein through military action that would be "justified by the conjunction of terrorism and WMD." Dearlove had gotten the word from then-CIA Director George Tenet whom he visited at CIA headquarters on July 20.

The discussion that followed centered on the ephemeral nature of the evidence, prompting Dearlove to explain: "But the intelligence and facts were being fixed around the policy." We are concerned that this is precisely what has happened with the "intelligence" on Syria.

### **The Intelligence**

There is a growing body of evidence from numerous sources in the Middle East — mostly affiliated with the Syrian opposition and its supporters — providing a strong circumstantial case that the August 21 chemical incident was a pre-planned provocation by the Syrian opposition and its Saudi and Turkish supporters. The aim is reported to have been to create the kind of incident that would bring the United States into the war.

According to some reports, canisters containing chemical agent were brought into a suburb of Damascus, where they were then opened. Some people in the immediate vicinity died; others were injured.

We are unaware of any reliable evidence that a Syrian military rocket capable of carrying a chemical agent was fired into the area. In fact, we are aware of no reliable physical evidence to support the claim that this was a result of a strike by a Syrian military unit with expertise in chemical weapons.

In addition, we have learned that on August 13-14, 2013, Western-sponsored opposition forces in Turkey started advance preparations for a major, irregular military surge. Initial meetings between senior opposition military commanders and Qatari, Turkish and U.S. intelligence officials took place at the converted Turkish military garrison in Antakya, Hatay Province, now used as the command center and headquarters of the Free Syrian Army (FSA) and their foreign sponsors.

Senior opposition commanders who came from Istanbul pre-briefed the regional commanders on an imminent escalation in the fighting due to "a war-changing development," which, in turn, would lead to a U.S.-led bombing of Syria.

At operations coordinating meetings at Antakya, attended by senior Turkish, Qatari and U.S. intelligence officials as well as senior commanders of the Syrian opposition, the Syrians were told that the bombing would start in a few days. Opposition leaders were ordered to prepare their forces quickly to exploit the U.S. bombing, march into Damascus, and remove the Bashar al-Assad government.

The Qatari and Turkish intelligence officials assured the Syrian regional commanders that they would be provided with plenty of weapons for the coming offensive. And they were. A weapons distribution operation unprecedented in scope began in all opposition camps on August 21-23. The weapons were distributed from storehouses controlled by Qatari and Turkish intelligence under the tight supervision of U.S. intelligence officers.

### **Cui bono?**

That the various groups trying to overthrow Syrian President Bashar al-Assad have ample incentive to get the U.S. more deeply involved in support of that effort is clear. Until now, it has not been quite as clear that the Netanyahu government in Israel has equally powerful incentive to get Washington more deeply engaged in yet another war in the area. But with outspoken urging coming from Israel and those Americans who lobby for Israeli interests, this priority Israeli objective is becoming crystal clear.

Reporter Judi Rudoren, writing from Jerusalem in an important article in Friday's New York Times addresses Israeli motivation in an uncommonly candid way. Her article, titled "Israel Backs Limited Strike Against Syria," notes that the



Israelis have argued, quietly, that the best outcome for Syria's two-and-a-half-year-old civil war, at least for the moment, is no outcome. Rudoren continues:

"For Jerusalem, the status quo, horrific as it may be from a humanitarian perspective, seems preferable to either a victory by Mr. Assad's government and his Iranian backers or a strengthening of rebel groups, increasingly dominated by Sunni jihadis.

"This is a playoff situation in which you need both teams to lose, but at least you don't want one to win — we'll settle for a tie," said Alon Pinkas, a former Israeli consul general in New York. "Let them both bleed, hemorrhage to death: that's the strategic thinking here. As long as this lingers, there's no real threat from Syria."

We think this is the way Israel's current leaders look at the situation in Syria, and that deeper U.S. involvement — albeit, initially, by "limited" military strikes — is likely to ensure that there is no early resolution of the conflict in Syria. The longer Sunni and Shia are at each other's throats in Syria and in the wider region, the safer Israel calculates that it is.

That Syria's main ally is Iran, with whom it has a mutual defense treaty, also plays a role in Israeli calculations. Iran's leaders are not likely to be able to have much military impact in Syria, and Israel can highlight that as an embarrassment for Tehran.

### **Iran's Role**

Iran can readily be blamed by association and charged with all manner of provocation, real and imagined. Some have seen Israel's hand in the provenance of the most damaging charges against Assad regarding chemical weapons and our experience suggests to us that such is supremely possible.

Possible also is a false-flag attack by an interested party resulting in the sinking or damaging, say, of one of the five U.S. destroyers now on patrol just west of Syria. Our mainstream media could be counted on to milk that for all it's worth, and you would find yourself under still more pressure to widen U.S. military involvement in Syria — and perhaps beyond, against Iran.

Iran has joined those who blame the Syrian rebels for the August 21 chemical incident, and has been quick to warn the U.S. not to get more deeply involved. According to the Iranian English-channel Press TV, Iranian Foreign Minister Mohammad Javid Zarif has claimed: "The Syria crisis is a trap set by Zionist pressure groups for [the United States]."

Actually, he may be not far off the mark. But we think your advisers may be chary of entertaining this notion. Thus, we see as our continuing responsibility to try to get word to you so as to ensure that you and other decision makers are given the full picture.

### **Inevitable Retaliation**

We hope your advisers have warned you that retaliation for attacks on Syrian are not a matter of IF, but rather WHERE and WHEN. Retaliation is inevitable. For example, terrorist strikes on U.S. embassies and other installations are likely to make what happened to the U.S. "Mission" in Benghazi on Sept. 11, 2012, look like a minor dust-up by comparison. One of us addressed this key consideration directly a week ago in [an article](#) titled "Possible Consequences of a U.S. Military Attack on Syria — Remembering the U.S. Marine Barracks Destruction in Beirut, 1983."

Dear Mr. President:

As the official biographer for Leo Emil Wanta – a man who in 1993 was named Somali Ambassador to Switzerland and Somali Ambassador to Canada, when I came across the enclosed file today I thought it might be helpful.

1. Leo Wanta was appointed by Somali Acting President Haji Mohamed Haile Hashi as Ambassador to Switzerland and Canada (May or June of 1993) – I know Somalia was in a great state of disruption at the time and that national leaders changed quickly.
2. I know that an Investiture occurred in France (Paris, I believe) and that it was witnessed by the French Foreign Minister (under Sarkozy) Alain Juppe (who was, in 1993, Mayor of Bordeaux. France)' also present was a member of the Italian Judiciary and a member of Italian intelligence.
3. I know Leo Emil Wanta was issued and held two Somali Diplomatic Passports. I know when Switzerland returned Wanta to the United States (after arresting him on a bogus Wisconsin tax charge) he re-entered the country using his Diplomatic Passport from Somalia. They KNEW he was a diplomat representing Somalia. Why should this matter to you? Because the Swiss arrested Wanta while he was in that nation to negotiate on behalf of your nation.

Somalia had 167 metric tonnes of gold and Ambassador Wanta took the gold certificates with him to Switzerland. The Swiss wanted to buy the gold; the Ambassador felt Somalia would be better off borrowing against it, providing immediate funds for the starving people of your nation. President Hashi named Ambassador Wanta as the Somali Central Bank Chairman and advised the Tribal Council. Wanta was arrested by the Swiss and was held incommunicado by them for 134 days before returning him to New York. No charges were ever filed against him... but the gold certificates disappeared while Wanta was held in a Lausanne, Switzerland prison. A copy of two chapters from Ambassador Wanta's official biography having to do with his and President Hashi's plans for Somalia is enclosed. I hope it will explain what happened to Ambassador Wanta and make clear that the Swiss are liable to your nation for the 167

tonnes of gold certificates stolen from the Ambassador. He is your witness that this occurred.

4. I know the Swiss totally violated the Vienna Treaties regarding Diplomatic Immunity and arrested Ambassador Wanta in Lausanne, Switzerland, on 7 July 1993. I have copies of the court transcripts involved in this matter and this was a slap in the face of Somalia as a nation and Ambassador Wanta who was trying his best to get American aid for Somalia. The plans Wanta and President Reagan had drawn up to present to the Somali Tribal Council are enclosed.

5. I know Leo Wanta was a covert intelligence operative reporting directly to the President of the United States – and Acting President Hashi also knew. Wanta was President Reagan's personal intelligence coordinator and Ronald Reagan wanted to help the Somali people... at the time, Cuba had soldiers in Somalia. It made sense for the United States to help.

The enclosed information gives a very brief overview of what happened to Ambassador Wanta and how, because "they" wanted the money he had generated when he brought down the Soviet Union Ruble, this entire scam of tax evasion in Wisconsin was created. I have all of those court transcripts, too... this man did not evade tax payments in Wisconsin or any place else. I have copies of his cancelled check paying the taxes for which he was arrested. If these projects would be of benefit to Somalia, and if any evidence exists of the appointment by Acting President Hashi of Leo Wanta as Somali Ambassador to Switzerland and Canada, then the comments in the enclosed document might make the 167 metric tonnes of Somali Gold Bullion held in Trust by AmeriTrust Corporation (USA) for Financial Stability and National Security Issues back to the table. I have no idea... I'm not a lawyer (just a retired banker who now spends a great deal of time writing).

I hope the information helps...

This however is a gross oversimplification because both occurrences are really based on a common thread, the serving of the secret interests of the World Money Changers AKA the OBN, of which the Central Banksters of the City of London are their main agents. Some insiders have referred to this international criminal cadre of illegal narcotics and weapon traffickers as the front men, the action agents for the Fourth Reich, a covert survivor of the Nazi system under Operation Paperclip. But this too is not completely accurate and does not provide the real global picture.

### **Super-Zionists AKA the NWO Super-Fascists.**

Others have claimed that this group should be called the Illuminati or the "Super Zionists", with many of them actually non-Judaics, and have also claimed that the Central Banksters are their Main Cut-Outs, shielding this group the Illuminati (a.k.a.-OBN).
