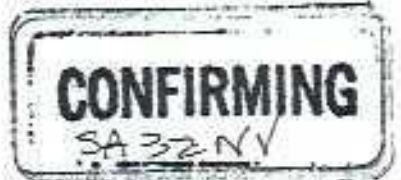

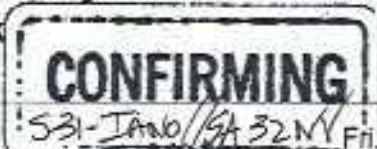

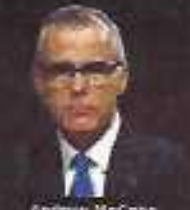

Donald Trump colluded with Russia to fix the election. This is now set in stone despite a complete lack of evidence anything of the kind actually happened. It's accepted by the "intelligence community" and the Senate. Even President Trump believes—or says—the Russians had something to do with influencing the election, defeating Hillary Clinton, and sending millions of liberal Americans into panic attacks and other mental disorders.

"As numerous intelligence and national security officials in the Trump administration have since unanimously re-affirmed, the (Intelligence Community Assessment's) findings were accurate and on point," declared committee Vice Chairman and Democrat Mark Warner (<https://www.reuters.com/article/us-usa-trump-russia-cyber/senate-panel-backs-intelligence-agencies-on-russia-trump-conclusions-idUSKBN1JT2YB>).

"The Russian effort was extensive and sophisticated, and its goals were to undermine public faith in the democratic process, to hurt Secretary Clinton (Democratic candidate Hillary Clinton) and to help Donald Trump," Warner said.

As we now know, a Russian company is responsible for flooding social media with clickbait. The idea was to make money, not get Trump elected. There wasn't a political agenda. They exploited politics across the board in search of clicks and hits.

It's true. The Russian government props up the RT news channel. The alphabet networks here are not outright owned by the government. Even so, they are in the business of reading from government scripts. Media honchos meet with government insiders during Bilderberg. They're members of the CFR and other globalist clubs that plot policy.

Putin and the Russians understand that no matter who enters the White House, most policies—especially foreign policy—remain the same. Trump has demonstrated over and over he's not out to drain the swamp and close down illegal military operations abroad. His enshrined cause—closing the border and sending illegal immigrants back to where they came from—is going nowhere in Congress. His major achievement to date is awarding the Pentagon with a huge infusion of debt dollars.

Trump has continued and expanded the wars. He is working with the Saudis to kill Yemenis. His enthusiasm for Israel has resulted in the apartheid government of that tiny country aggressively moving to kill more Palestinians in Gaza and annexing what remains of the West Bank.

The Democrat side of one party rule shares an affinity with Trump—they support the concept of never ending war, a police state at home, and kowtowing to a financial elite that is politically ambidextrous. So long as establishment Democrats and Republicans are in control, the show will go on. Trump, like Reagan before him, talked the talk on the campaign trail, but once in office it was business as usual.

It's personal for establishment Democrats. Hillary Clinton was scheduled to ascend the throne, not the outlier megalomaniac Donald Trump. The same foreign policy—and indeed the policy of separating children at the border—is essentially a continuation of Obama's policies. His administration also separated children, they just didn't cheer trump about it like Trump. It went on quietly behind the scenes while Obama talked about inclusion, diversity, and identity.

Ditto the wars. Eight years of Obama erased dissent. Many former Democrat peaceniks became reformulated neocons. They cheered as Obama killed Libyans and Syrians. Illegal wars and crimes against humanity became humanitarianism under Obama, as they were under Bill Clinton.

While the Bush neocons usually dispensed with such theatrics, they claimed invasions, sanctions, and the murder of children were worth it. They told us "creative destruction" creates democracy.

Meanwhile, we sat on the sideline as spectators while they did terrible things.

That's the crux. We are plebs and spectators, unable to determine our own destiny as a nation. The state continues to pretend it is our representative as it serves the interest of transnational banks and corporations and chips away our bedrock of liberty as spelled out in the Declaration of Independence.

Russagate is a distraction. It's partisan warfare promoted by the establishment media with its well-to-well anti-Trump propaganda. The establishment will tell whatever fairy tales it must—even if a large number of Americans refuse to accept lies as truth—as part of the effort to unseat the outsider, the uninvited braggart, the reality star president who lashes out viciously at his detractors on Twitter.

Liberals are similar to "Better Dead than Red" Republicans in the 1950s. They support confrontation with Russia. They support US and NATO troops pushed up against her border, saber-rattling with Patriot missiles and war games. They're convinced Putin is the new Hitler. It doesn't occur to them that such rhetoric and behavior, which naturally escalates, may ultimately result in their extinction.

But never mind. The DNC resistance now has renewed wind in its sails. It will push hard—even in the street with Anita sincerity—to take down this president.

Not that it matters. President Pence will pick up where Trump left off.

This is how it works. Even with farmers looking at the edges of the political facade, threatening to fully expose the inner workings of the elite, the game continues without significant interruption. Once again, Americans demonstrate their political naivety. They continue to believe leaders and parties will save them from a catastrophe the elite has set in motion.

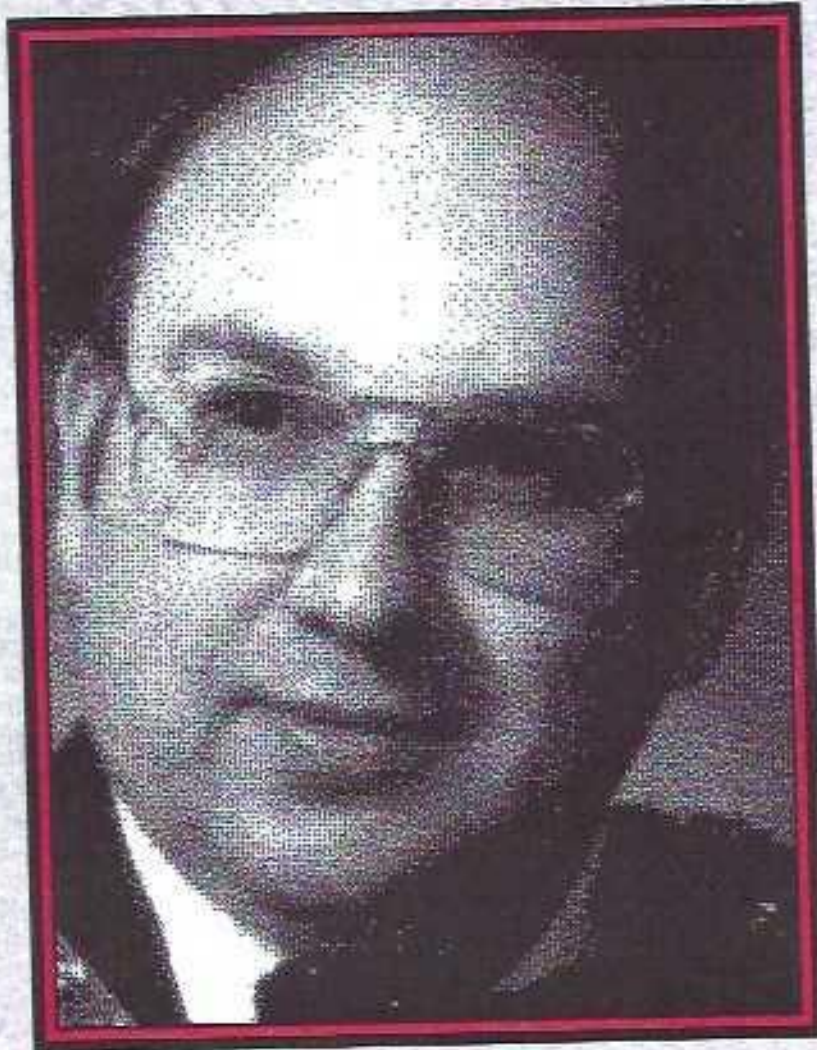

WISCONSIN TAX FRAUD AGAINST WANTA AND COURTS COVERS UP INTER ALIA THEFT OF \$18 BILLION

The Editor of *International Currency Review* has learned that Ambassador Leo Wanta has received a request from Mr Gregg T Prayzer, Chief, Central Audit Section, State of Wisconsin Department of Revenue, for payment of an illegally charged civil tax demand that has been paid three times already – in May and June 1992, and then again in July 2005. The latest request concerns a renewed demand for a Wisconsin State civil tax assessment which was paid in full by Leo Wanta's lawyer on 21st July 2005. The request, for tax which the Ambassador never owed at any time because he has not been a legal resident of Wisconsin since 1985 as he is legally a resident of Vienna, Austria, and which, as indicated, has already been paid THREE times, is purportedly based upon a decision by the Wisconsin Supreme Court, handed down in secret. The Ambassador was unaware of this decision until informed of this FOURTH request for the SAMH fraudulent civil tax assessment amount, by the Wisconsin Department of Revenue in correspondence dated 30th October 2006 and received on 2nd November 2006. The State appears to have committed a strategic error here.

This latest false civil assessment sets a precedent, of course, for anyone to receive a tax demand supposedly rubber-stamped by a kangaroo State Supreme Court even though the victim has never been informed of any such legal process – an abuse of power which not even the Barons who signed Magna Carta with King John had ever complained about.

The new abomination must be seen in the context of the millennial, open-ended financial corruption which is the subject of the accompanying special double issue of *International Currency Review*. In addition, \$18 billion worth of high-value US Treasury instruments have gone missing from the Ambassador's sealed diplomatic briefcase.

Endemic 'untaxed' official financial corruption is the immediate cause of the continuing defaults on US Treasury securities and Federal Reserve Notes (FRNs) in Europe, aggregating at least \$4.275 trillion in early November 2006 – for updates, see postings on www.worldreports.org [CLICK HERE REPORT AND ARCHIVE] – because it precipitated the spreading collapse of confidence globally, arising from the destruction by the Bush II Administration of the 'Full Faith and Credit of the United States', as its officials have continued to play fast and loose with Wanta's funds. ■

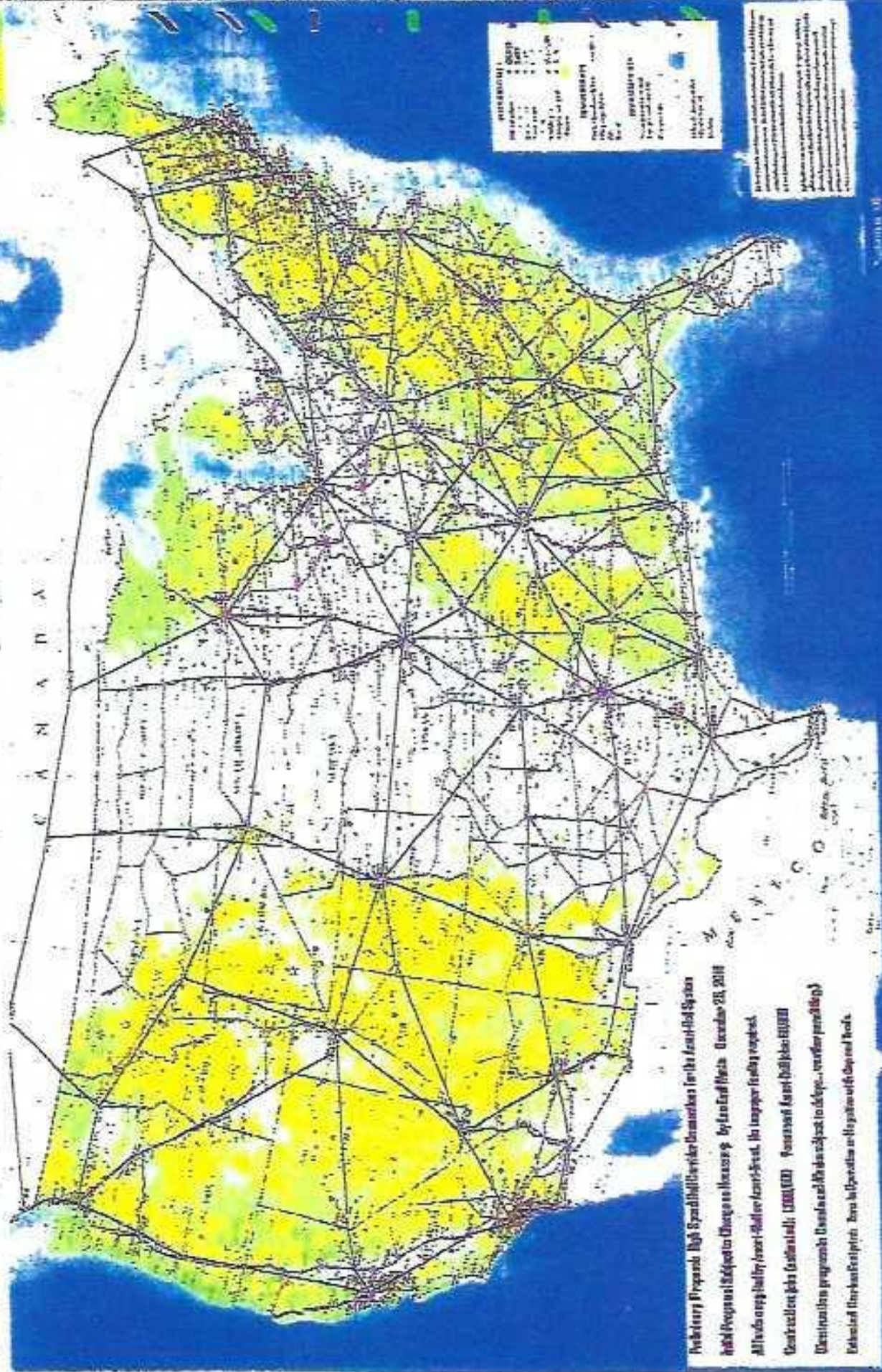

Figure A: "Return of Search Warrant" prepared and signed by Dennis M. Mengelt, Special Agent, Division of Criminal Investigation, Wisconsin Department of Justice, and dated 11th March 1994. It itemises the contents of Ambassador Leo Ervil Wanta's diplomatic/sealed briefcase which was illegally seized from him by Swiss authorities on 7th July 1993. The diplomatic briefcase has never been returned to the Ambassador. Not listed among the effects found by Dennis M. Mengelt were 18 high-value US Treasury instruments which the Ambassador was carrying in the briefcase and which have disappeared. The briefcase has never been returned because, not least, when returned it would need to contain 100% of the items that were in the briefcase when it was illegally seized from him in Lausanne on 7th July 1993. Beyond this central fact, the diplomatic briefcase was sealed and it is not within the purview of officials serving a State of the United States to examine such briefcases. The search warrant signed by the local Dane County Circuit Court Judge was beyond the Judge's powers and represented another instance of the usurpation of Federal powers by the hyper-arrogant State of Wisconsin, which has no jurisdiction beyond its borders.

Attorney Steve Epstein called me about a week ago, apparently having had a conversation with you in which you related your recollection of a conversation I had with you earlier. You apparently recounted to Mr. Epstein your recollection of the issue of the tax payment and your contention that there had been a big conspiracy involving the federal government, the state government, your attorneys and the Judge to prevent you from presenting evidence of payment or accord in satisfaction in an effort to estop the state from proceeding.

I had expressed considerable amazement at the scenario that you outlined for me, but that of course assumes that that scenario is correct. Mr. Epstein indicates that the check appears a number of times in the file, so it obviously played some role in the case and I suspect that the issue of payment or estoppel was raised by your legal counsel at some point in some context. It's probably a losing proposition for a number of reasons, but I want to make it clear that I'm not being critical of either your trial counsel or Mr. Epstein who is now undertaking the difficult challenge of dealing with your sentencing. Having known you, Leo, for probably 14 years, I know you present many very challenging legal and factual issues in all of your legal matters.

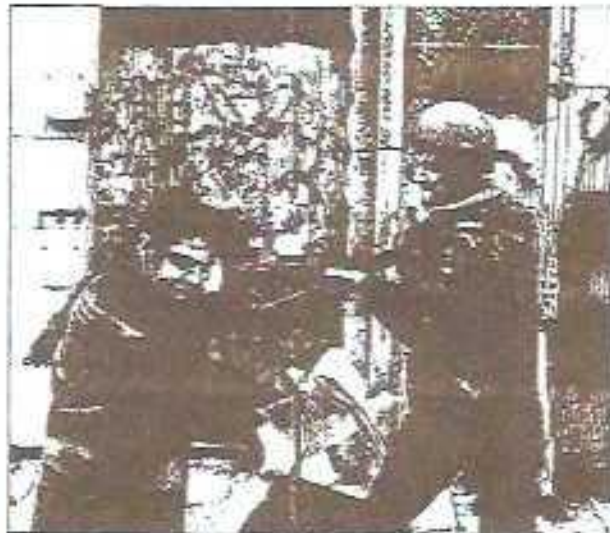
Stuck in the Promised Land

Israel: With unrest rising, many settlers want out

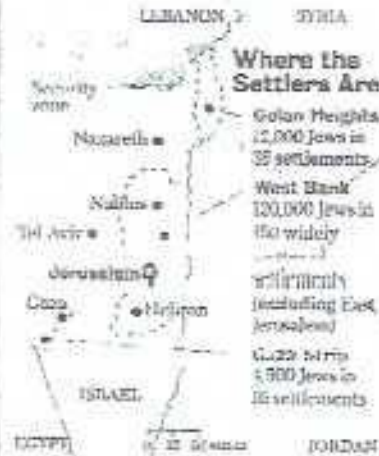
NOT EVERYONE IN THE MOUNTAIN Jewish settlements of Kiryat Arba thinks it's the promised land. "We went because of the money; it was cheap to get an apartment there," says Sarah Mahal, who moved to Kiryat Arba 10 years ago. Mahal and her husband, Avi, raising four children in a crowded place surrounded by outraged Palestinians, often thought of moving to Jerusalem. But they couldn't afford to. Then Hannah Goldstein, a Kiryat Arba resident, contacted them in Moscow worshipers in nearby Hobson, and everything changed. "My 8-year-old said to me, 'I'm afraid the Arabs will kill me now,'" recalls Sarah. The Mahals demanded government help—and with a \$275 monthly subsidy, they were able to rent a tiny apartment in Jerusalem. "I feel like a prisoner who has been freed," says Sarah.

Thousands of Jews living in other settlements deep in the Israeli-occupied West Bank and Golan Heights want to get out, too. But it's not so easy. They were lured there by government offers of huge mortgages at rock-bottom rates, at a time when Israel's leaders wanted Jews to populate Arab lands captured in 1967. The settlers bought homes that would cover almost all their expenses. Yet now that peace is preparing in those lands, the same houses have plunged in value. "Many families want to leave," says Mahal, who can't find a buyer for her apartment in Kiryat Arba. "But they don't have the money to make that move."

The trick is to survive. Palestinian shelling and bombs until the government of Prime Minister Yitzhak Rabin offers compensation, then take the money and run. Settlers read the precedent set at Yonit, the Sufa settlement returned to Egypt as part of the 1979 peace treaty. Then the government paid \$300,000 for each evacuated home, and \$75,000 to \$150,000 for other households that pulled up stakes. So far, however, Rabin has resisted pressure to offer a deal to the settlers in the West Bank and Golan. "He doesn't want them to leave now because he's still negotiating," says Hagan Meron, one of the Labor Party legislators running a hot line for settlers who want out. "Hagan says to himself, 'If they move now, the

"Palestinians will think we are weak."

That approach has left many settlers feeling like pawns in an increasingly longer and more complex game. Just last week the Islamic militant group Hamas issued a warning to Jews living in certain West Bank and Golan settlements, leave by March 10 or face increased attacks. The threat is not empty bluster. In February Hamas gunmen shot dead a pregnant woman who was traveling between Tel Aviv and the suburban-style settlement of Arzi. More recently, nervous Israeli soldiers killed an Arab resident who was driving at night—they thought the settler was a Palestinian terrorist.

So far the government is providing only minimal assistance to help relocate low-income families desperate to get out. Estimates for the cost of fully compensating most of the 185,000 settlers range up to \$10 billion. "Somebody will have to pay for it," says Meron, who suggests that Saudi Arabia could help if settlements were used to house Palestinians in the future. Washington is another likely candidate. Israel got a pledge in 1992 for \$10 billion in U.S. loan guarantees to help resettle Jewish immigrants. Rabin hasn't asked to use the money for relocating settlers, but a U.S. official in Jerusalem says Washington "would be willing to examine such a proposal if it was raised."

But where will the settlers go? Avi and Sarah Mahal moved from Kiryat Arba to an affordable apartment in Pisgat Ze'ev—a Jewish neighborhood built after 1967 in occupied East Jerusalem. Negotiations over the fate of Jerusalem aren't due to start for another two years or more. Meanwhile, bulldozers are hard at work in Pisgat Ze'ev, a burgeoning neighborhood of 30,000 Jews, clearing land for even more low-cost apartments. Until a final peace settlement is reached, nobody knows for certain where they can make a home, and who will pay the price.

Rabin's Coalition: Where's the Beef?

THE MIDDLE EAST PEACE PROCESS IS UNDER another assault last week: nonstop tension. Israeli Prime Minister Yitzhak Rabin, trying to pursue a controversial peace policy with only a minority coalition in the Knesset, needed to enter the ultra-orthodox Shas line back into his ruling group. But Shas had a price for its support: legislation that would outlaw the import of nonkosher meat. (Must Israelis don't care about the meat itself; the issue is part of the always heated struggle over how secular Israel should be.)

Rabin wanted to reinforce his Labor-led coalition ahead of his visit this week to Washington. The new meat bill is expected to become law this week, despite opposition by some leftists who found it unpalatable. The Shas bloc will probably rejoin Rabin's government. That means the peace process, at least, may stay on the menu. ■

Dear Mr. Chavez:

In accordance with your request, I am providing you with the state of Wisconsin's present position with regard to disposition of this matter by plea agreement. My offer is as follows:

- * 1. The defendant will plead guilty to each of the six counts contained in the information.
- * 2. The state will recommend (or defendant and the state will jointly recommend) that the defendant be placed on probation for a period of five years.
- 3. That as a condition of probation, defendant will be confined to the Dane County jail for a period of eight months with full credit for time served since his arrival back in the United States in November.
- 4. As a further condition of probation, defendant will cooperate fully with the Wisconsin Department of Revenue in identifying and locating all of his assets. These assets include personal assets as well as assets of any and all businesses, partnerships, corporations and other associations in which Mr. Wanta has any financial interest. This cooperation will also include Mr. Wanta providing the Department of Revenue with specific current information on the location of the approximately \$179,000.00 which he withdrew from the bank account of New Republic/USA Financial Group, Ltd., at the Banca Nazionale del Lavoro, New York City branch and forwarded it to two banks in Vienna, Austria.

The state agrees that it will bring no additional criminal tax charges against Mr. Wanta for any matters revealed in Mr. Wanta's compliance with condition 4 above.


