MEMORANDUM OPINION

THIS MATTER is before the Court on Defendants the United States of America, et al.'s, motion to dismiss Plaintiff Ambassador Leo Wanta's claim of breach of contract based on lack of subject matter jurisdiction and on Plaintiff's motion to amend his complaint. The issue before the Court is whether the Court should dismiss an alleged secret government agent's claim against the Attorney General, the Director of the Central Intelligence Agency, the Secretary of the Treasury and the Government based on lack of subject matter jurisdiction. The Court grants Defendants' motion to dismiss pursuant to Federal Rule of Civil Procedure 12(b)(1) because the Government has not waived sovereign immunity and public policy forbids the adjudication of a suit relating to matters of an alleged national security contract. The Court denies Plaintiff's motion to amend his complaint under Federal Rule of Civil Procedure 15(a) because such an action would be futile.

The matter under consideration began when Leo E. Wanta, designating himself as "stipulated petitioner for Falls Vending Service, Inc.," filed various motions challenging actions taken by the United States Bankruptcy Court for this district in a case entitled In Re: Falls Vending Service, Inc., Debtor (Case No. 83-02385). Wanta's motions are resisted by the Farmers and Merchants Bank of Menomonee Falls, a secured creditor in the bankruptcy action. Magistrate Robert L. Bittner, after a thorough examination of the matter, has recommended dismissing the action because Wanta lacks standing and also has failed to properly invoke this court's jurisdiction. I concur in the magistrate's analysis and adopt his recommendation in full.

In his written objections, Wanta contends that the magistrate's analysis of his standing is faulty because Falls Vending Service is not a legal and valid corporation, and therefore, cases holding that a corporation can only be represented by

Even if Falls Vending Service is not a corporation, [Wanta lacks standing because his affidavit testimony indicates he is only an employee of the company.] The owner of a company cannot confer standing on a non-lawyer employee by stipulation or otherwise.

Wanta's objections do not address his failure to properly invoke this court's jurisdiction. No complaint has been filed. Wanta failed to follow the proper procedures to perfect an appeal pursuant to Part 8, Rule 8001 et seq. of the United States Bankruptcy Rules. The matter must be dismissed sua sponte for lack of jurisdiction.

THEREFORE IT IS ORDERED that the action is hereby dismissed.

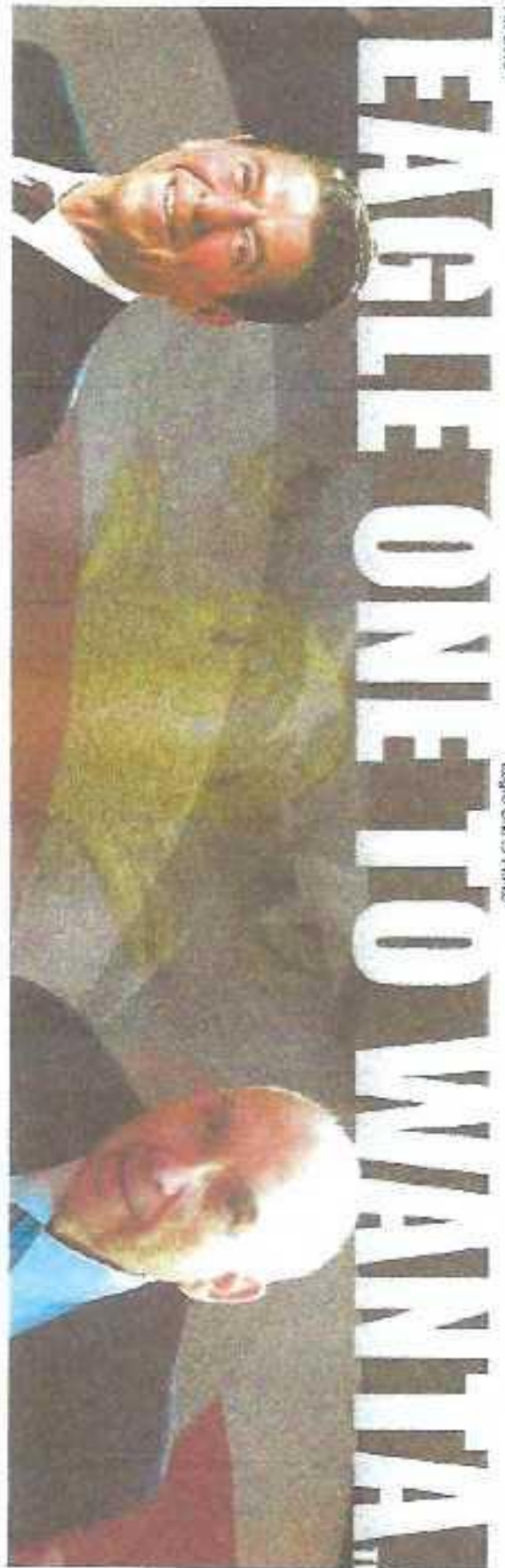

Donald Trump colluded with Russia to fix the election. This is now set in stone despite a complete lack of evidence anything of the kind actually happened. It's accepted by the "intelligence community" and the Senate. Even President Trump believes—or says—the Russians had something to do with influencing the election, defeating Hillary Clinton, and sending millions of liberal Americans into panic attacks and other mental disorders.

Even so, they are in the business of reading from government scripts. Media honchos meet with government insiders during Bilderberg. They're members of the CFR and other globalist clubs that plot policy.

Putin and the Russians understand that no matter who enters the White House, most policies—especially foreign policy—remain the same. Trump has demonstrated over and over he's not out to drain the swamp and close down illegal military operations abroad. His enshrined cause—closing the border and sending illegal immigrants back to where they came from—is going nowhere in Congress. His major achievement to date is awarding the Pentagon with a huge infusion of debt dollars.

Trump has continued and expanded the wars. He is working with the Saudis to kill Yemenis. His enthusiasm for Israel has resulted in the apartheid government of that tiny country aggressively moving to kill more Palestinians in Gaza and annexing what remains of the West Bank.

The Democrat side of one party rule shares an affinity with Trump—they support the concept of never ending war, a police state at home, and kowtowing to a financial elite that is politically ambidextrous. So long as establishment Democrats and Republicans are in control, the show will go on. Trump, like Reagan before him, talked the talk on the campaign trail, but once in office it was business as usual.

It's personal for establishment Democrats. Hillary Clinton was scheduled to ascend the throne, not the outlier megalomaniac Donald Trump. The same foreign policy—and indeed the policy of separating children at the border—is essentially a continuation of Obama's policies. His administration also separated children, they just didn't cheat Trump about it like Trump. It went on quietly behind the scenes while Obama talked about inclusion, diversity, and identity.

Ditto the wars. Eight years of Obama erased dissent. Many former Democrat neocons became reformulated neocons. They cheered as Obama killed Libyans and Syrians. Illegal wars and crimes against humanity became humanitarianism under Obama, as they were under Bill Clinton.

While the Bush neocons usually dispensed with such theatrics, they claimed invasions, sanctions, and the murder of children were worth it. They told us "creative destruction" creates democracy.

Meanwhile, we sat on the sideline as spectators while they did terrible things.

That's the crux. We are plebs and spectators, unable to determine our own destiny as a nation. The state continues to pretend it is our representative as it serves the interest of transnational banks and corporations and chips away our bedrock of liberty as spelled out in the Declaration of Independence.

Russagate is a distraction. It's partisan warfare promoted by the establishment media with its wall-to-wall anti-Trump propaganda. The establishment will tell whatever fairy tales it must—even if a large number of Americans refuse to accept lies as truth—as part of the effort to unseat the outsider, the uninvited braggart, the reality star president who lishes out viciously at his detractors on Twitter.

Liberals are similar to "Better Dead than Red" Republicans in the 1950s. They support confrontation with Russia. They support US and NATO troops pushed up against her border, saber-rattling with Patriot missiles and war games. They're convinced Putin is the new Hitler. It doesn't occur to them that such rhetoric and behavior, which naturally escalates, may ultimately result in their extinction.

But never mind. The DNC resistance now has renewed wind in its sails. It will push hard—even in the street with Antifa sincerity—to take down this president.

Not that it matters. President Pence will pick up where Trump left off.

This is how it works. Even with flames licking at the edges of the political facade, threatening to fully expose the inner workings of the elite, the game continues without significant interruption. Once again, Americans demonstrate their political naivety. They continue to believe leaders and parties will save them from a catastrophe the elite has set in motion.


If you could send me the details of the incident, including witnesses if any, we might be able to cause a formal investigation to be conducted. Kindly include specific information (what, where, when, who).

WE HAVE DISCUSSED THIS TRANSFER WITH THE UK GROUP AS RECOMMENDED BY STATE AND DEFENSE, AND CONCUR, THE WINDOW/TIMING IS APPROPRIATE IF WE ACT NOW AND WITHOUT UNNECESSARY FANFARE.

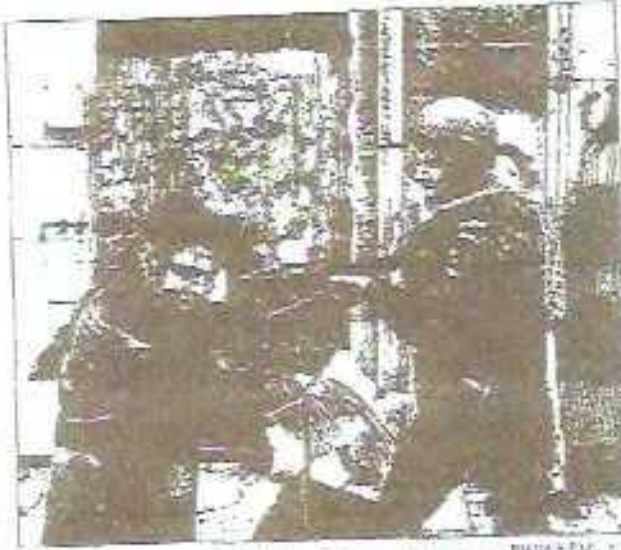

Stuck in the Promised Land

Israel: With unrest rising, many settlers want out

Not everyone in the militant Jewish settlement of Kiryat Arba thinks it's the promised land. "We went because of the money, it was cheap to get an apartment there," says Sarah Malul, who moved to Kiryat Arba 10 years ago. Malul and her husband, Avi, raising four children in a leafy plot surrounded by angry Palestinians, often thought of moving to Jerusalem, but they couldn't afford it. Then Sarah contacted a Knesset Arba resident, quoted down by Moshe Washtrop in a nearby Hebron, and everything changed. "My 70-year-old said to me, 'If instead the Arabs will kill me now,'" recalls Sarah. The Maluls demanded government help—and with a \$275 monthly subsidy they were able to rent a tiny apartment in Jerusalem. "I had the apartment who has been forced," says Sarah.



Climate of fear: Israeli soldier chats a Palestinian protester

Thousands of Jews living in other settlements long to be Israeli-occupied West Bank and Gaza territory want to get out, but that it's not so easy. They were lured there by government offers of huge mortgages at rock-bottom rates, at a time when Israel's leaders wanted Jews to populate Arab lands captured in 1967. The settlers thought they could never afford to leave Israel because the state had helped in preparing to build land for peace. The same houses have changed in value. "Many families want to leave," says Shlomo Weinstock, head of Israel's housing ministry in Kiryat Arba. "But they don't have the money to make that move."

The land is to receive Palestinian refugees and Jews until the government of former Minister Yitzhak Rabin offers compensation. Some take the money and go. Settlers recall the president set in Kiryat Arba, the main settlement returned to Egypt as part of the 1979 peace treaty. They the government paid \$20,000 for each 10,000 sq ft lot, and \$75,000 to \$150,000 for other benefits (not paid up stakes, so far). However, Rabin has received pressure to offer a deal to the settlers in the West Bank and Gaza. "He doesn't want them to leave now because he's still negotiating," says Herta Morrison, one of the senior Party legislators running a not-for-profit settlement. "Rabin says to himself, 'If they move now, the



Palestinian will think we are weak." The opposition left many settlers feeling like Jews in an unresolvable struggle. Just last week the Islamic militant group Hamas issued a warning to Jews living in certain West Bank and Gaza settlements: leave by March 15 or face increased attacks. The threat is not empty blarney to Secretary Bush's gambit and their pregnant women who was traveling between Tel Aviv and the suburban-style settlement of Ariel. Nine Israeli soldiers (including one killed) and one Palestinian (who was driving a rifle) — they thought the settler was a Palestinian terrorist.

So far the government is providing only minimal assistance to help relocate low-income families desperate to get out. Estimates for the cost of fully compensating most of the 125,000 settlers range up to \$10 billion. "Somebody will have to pay for it," says Morrison, who says that some settlements could be used to house Palestinians in the future. Washington is another likely candidate, could get a pledge in 1987 for \$10 billion in U.S. loan guarantees to help absorb Jewish immigrants. Rabin hasn't asked to use the money for relocating settlers, but a U.S. official in Jerusalem says Washington would be willing to examine such a proposal if it was raised.

But where will the settlers go? Avi and Sarah Malul moved from Kiryat Arba to an affordable apartment in Pigeon Zeev — a Jewish neighborhood built after 1967 in occupied East Jerusalem. Negotiations over the fate of Jerusalem aren't due to start for another two years or more. Mortgage lenders are hard to find in Pigeon

Zeev — a burgeoning neighborhood of 20,000 Jews. Real estate for even middle-class apartments that a half-century settlement is reached, nobody knows for certain where they can make a move, and who will pay the price.

Rabin's Coalition: Where's the Beef?

The coalition with a 68-seat majority in the Knesset is a shaky one. Rabin's coalition is made up of 68 seats, but only 47 are from the Likud party. Rabin is trying to pursue a controversial peace policy with only a shaky coalition in the Knesset. Since his back into his ruling group, but Shas has a price for its support. Rabin's coalition would outline the support of non-Orthodox Jews. (Shas doesn't care about the anti-gay issue, but it's part of the always heated struggle over how secular Israel should be.)

Rabin wanted to announce his Labor-led coalition ahead of his visit this week to Washington. The new coalition is expected to become law this week — despite opposition from some orthodox who found it unacceptable. The Shas Bloc will probably remain Rabin's governmental. That means the peace process, at least, may be the main

THE STATE OF ISRAEL IS MOST ANXIOUS TO DELIVER A4 SKYHAWKS TO THE REPUBLIC OF ARGENTINA. THESE ARE CIRCA 1973 ISSUE, USED, READY TO CRATE AIRCRAFT. IN THE DOCUMENTS PREVIOUSLY SUBMITTED FOR YOUR PERUSAL, ALL USA AGENCIES INVOLVED HAVE BEEN THOROUGHLY BRIEFED AND PERTINENT DOCUMENTS PRESENTED AS ENCLOSED. THIS SUBJECT SALE AS REPRESENTED IS VALUED IN EXCESS OF USD 350 MILLION, AMONG OTHER THINGS.

REFERENCING YOUR LETTER OF 22 APRIL 1987 (ENCLOSED), I AM MOST GRATEFUL FOR YOUR IMMEDIATE RESPONSE AND SUPPORT. IT IS MY UNDERSTANDING THAT SECRETARY GEORGE SHULTZ ONLY NEEDS TO APPROVE THIS TRANSACTION, NO USA RE-EXPORT LICENSING IS REQUIRED DUE TO 1973 ISSUE, AND ARE PRESENTLY IN ISRAEL, NO USA SHIPMENT/INVOLVEMENT WILL BE NECESSARY FROM ISRAEL TO ARGENTINA DIRECTLY.

PLEASE NOTE: THIS CIRCA 1973 SALE WAS 626, TOTAL CASH.

BASED ON NUMEROUS CONVERSATIONS WITH USA AGENCIES, NBC, WHITE HOUSE, U.S. STATE, AND OTHERS., THE TRANSFER SALE WILL BE ACCEPTABLE, BUT ALL INFORMED BELIEVE SECRETARY SHULTZ MUST APPROVE AT HIS LEVEL.

Dear Sir:

Thank you for your letter regarding the procedures governing the reporting and use of information concerning federal crimes. I have reviewed the draft of the procedures that accompanied your letter and, in particular, the minor changes made in the draft that I had previously sent to you. These proposed changes are acceptable and, therefore, I have signed the procedures.

I have been advised that a question arose regarding the need to add narcotics violations to the list of reportable non-employee crimes (Section IV). 21 U.S.C. §214(b) provides that "[w]hen requested by the Attorney General, it shall be the duty of any agency or instrumentality of the Federal Government to furnish assistance to him for carrying out his functions under the Controlled Substances Act . . .". Section 1.3(b) of Executive Order 12111 tasks the Central Intelligence Agency to "collect, produce and disseminate intelligence on foreign aspects of narcotics production and trafficking." Moreover, authorization for the dissemination of information concerning narcotics violations to law enforcement agencies, including the Department of Justice, is provided by sections 1.3(a) and (i) and 1.6(b) of the Order. In light of these provisions, and in view of the fine cooperation the Drug Enforcement Administration has received from CIA, no formal requirement regarding the reporting of narcotics violations has been included in these procedures. We look forward to the CIA's continuing cooperation with the Department of Justice in this area.

In view of our agreement regarding the procedures, I have instructed my Counsel for Intelligence Policy to circulate a copy which I have executed to each of the other agencies covered by the procedures in order that they may be signed by the head of each such agency.
