Dear Vice President Cheney:

In prior communications I have commented on my participation in the legal representation of Ambassador Leo Wanta ("Wanta"). I appreciate that receiving a letter from a person in Omaha, Nebraska may instill both concern and questions regarding the validity and authenticity of my association with Wanta and my representation that I have authorization from Wanta to explore the matters addressed in my various communications. I anticipate that one or more parties both presently and in the past assert and/or put forth some power of authority over certain business interests of Wanta. These same parties may or may not have been given authority to maintain the status quo and protect the business interests of Wanta but they do not have the approval to finalize the matters I have been addressing in my letters. Not one of these parties has the power to either cause or prevent certain assets from going to charity and/or to cause assets to be disbursed without the "power to push the button" that is controlled by Wanta. If certain of these parties "claimed" interests need to be addressed in conjunction with USG Wanta issues then Wanta will deal with the same independent of reaching a subject matter resolution. There is no reason that any such third parties need to be part of the who, what, when, where, why and/or how of any such resolution.

Wanta has asked that I advise that he and I (and not in conjunction with any legal firm I am associated with) are prepared to immediately finalize the subject matter resolution of issues referenced in my various communications. To confirm the authorization and validity of my representation of Wanta he has asked that I offer the following information that should confirm that I am authorized to speak on his behalf:

- Event incident: Preventive field operations to protect the life of President Ronald Reagan.
- Reference date: Friday, the 13<sup>th</sup>.
- Provocateurs: See filed sensitive/classified documentation "CHIEF SAMMY" information to Leo Wanta and immediately transferred to SA32NV/FBIngram.
- Confirming agents: Special Agent Glenn Speedy, U.S. Secret Service/Nashville and William LeCates former Special Agent/Resident Agent in Charge/United States Customs Service/Sector 5.

This matter can go way quietly and on a "need to know" basis only. I reconfirm the intent of the matters set forth in my letter to you dated March 27, 2002.
