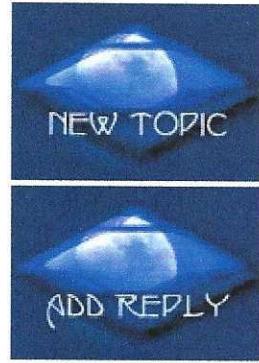

3. Despite the military coup planned against Clinton as President, referred to in our story, Clinton was never concerned. Why? Because he had reason to know that his rise to and stay in power was orchestrated with the aid of blackmail and murder. We mentioned how supposed "Independent Counsel" Kenneth W. Starr was blackmailed. Clinton benefitted from an epidemic of suspicious if not sabotaged military aircraft crashes and from the strange death of those who knew too much about Clinton and about the military coup plot against him.

One of those who knew too much and was reportedly sympathetic if not supportive of the coup, was General David McCloud, head of the Alaska Military District. He died in a sabotaged plane crash. His military colleagues are aware of the terrible details but refuse to allow a reporter to publicly identify them or take their position public. His relatives tend to agree with our details.

4. Some in the monopoly press, who talk to us off the record and we agree never to identify them as sources, contend such details as in our stories, which they believe to be true but cannot go in print or on the air with them, could well topple the U.S. government. Why? Because the ruling elite, whose faces are seldom seen, are governing us from behind the scenes in contradiction of the U.S. Constitution and laws.

5. Is there a rationale by the ruling elite for the cover up of the true nature of the bombings of the Murrah Building? They fear, supposedly, a full scale war with Iraq which now has chemical and biological weapons as well as some types of nuclear bomb devices. Furthermore, any ruckus with Iraq over the Murrah Building inevitably would involve the current German government Establishment. Why? A German counter-intelligence agent, on behalf of Iraq, supervised the U.S. domestic dissidents in the limited role outside the Murrah Building while others had already planted explosive devices INSIDE the building to go off about the same moment as the ineffective truck fertilizer bomb outside. That agent, known to the American CIA, reportedly was Andreas Strasmeier, whose elders reportedly were pro-Hitler. Little understood: German industry has supplied much of the weaponry for Iraq. And, they built a 60-foot-under-the-ground bomb shelter for Saddam Hussein as well as other super-secret buildings, machines, and weaponry for Iraq. All while Germany professes to be pro-West and pro-U.S.

Also, in our stories about the murder of Clinton White House Deputy Counsel Vincent W. Foster, Jr., we mentioned that German Counter-Intelligence [also tied to Strasmeier] in Frankfurt, had advance knowledge of a foreign team set to murder Foster. In an honest world, if McVeigh is to be severely punished for his limited role in the bombings, also deserving of major punishment would be William Rockefeller Clinton and his crony, George W. Bush, as well as the Elder Bush, George Herbert Walker Bush, for their cover up complicity in the 168 murders on behalf of Iraq.

Timothy McVeigh, a purported expert in secret code usage, cryptography, has been communicating in code with author Gore Vidal who was on an extremely short list of those McVeigh wanted to witness his supposed execution. {Study Gore Vidal's book "1876" and how it predicted the strange 2000 election. De achterzijde van het beursschandaal

1990. President Gorbatsjov probeert met allerlei staatkundige hervormingen het uiteenvallen van de Sovjet Unie te voorkomen. In de zomer van dat jaar wordt Boris Jeltsin, de voormalige burgemeester van Moskou, tot eerste president van de nog prille Russische federatie gekozen. In die onzekere periode probeert een aantal communistische die-hards het tij nog te keren door een couppoging. De coup mislukt, maar de dagen van Gorbatsjov en de Sovjet-Unie lijken geteld. Jeltsin is bereid voor te gaan bij de laatste slag met het oude regime. Hij besluit tot de geheime opbouw van een 'oorlogskas' en zoekt daarvoor steun in het Westen. Serieuze, officiële geldschutters zijn nog een beetje huiverig om te beleggen in zijn wankele federatie. Maar allerlei firma's uit het westerse zwartgeldcircuit zien grote mogelijkheden opdoemen en schieten de 'witte duif' uit Moskou te hulp.

Tampax en kuikens

Een van die firma's was de Dove Trading Company, waarin zowel Britse als Zuid-Afrikaanse en Nederlandse belangen vertegenwoordigd waren. Een van de leidinggevende figuren bij Dove was de Nederlander Dirk de Groot, alias 'de Grijze'. Een van de hoofdverdachten in het huidige Amsterdamse beursschandaal en volgens zijn echtgenote een felle anticomunist. Het huidige FIOD-onderzoek heeft aan het licht gebracht, dat zich in de schaduw van Dove Trading de Mississippi-groep schuilhield met zijn coderekeningen en zijn deelnemers uit zowel de top van de Nederlandse witteboordenwereld als de criminaliteit. Of Jeltsins vertegenwoordigers bij de onderhandelingen met de top van Dove Trading in Moskou daarvan op de hoogte waren, is twijfelachtig. Al vrij snel kwamen de gesprekspartners in de Russische hoofdstad tot een in vele opzichten fantastische deal. Dove kreeg een krediet van 140 miljard roebel op een rekening van de Interregionale Commerciële Bank in Moskou. Dove verplichtte zich van haar kant tot storting van 7,8 miljard dollar op een Zwitserse bankrekening om voor dat bedrag de Russische markt te bevoorraden. Daar stond tegenover, dat de westerse hulpverleners via een van de beruchte decreten van Jeltsin vergunning kregen om met gebruikmaking van hun boterzachte roebels zonder tussenkomst van makelaars en zonder belastingverplichtingen Russische olie, zeldzame metalen, schroot etc. op te kopen. Het duurde niet lang voor aan Russische zijde ook artikelen als nucleair materiaal, wapens, iconen, heroïne en andere leuke dingen voor de mensen in de etalage werden gezet. Het is nog niet bewezen, dat Dove Trading ook voor deze koopjes belangstelling heeft gehad. Feit is wel, dat De Groots partner op de Antillen, Greg Elias, inmiddels verdacht wordt van betrokkenheid bij de smokkel van nucleair materiaal naar Cuba. Hoe dit ook zij, om deze moderne versie van de Marshall-hulp volledig in te dekken tegen onvoorzienbare omstandigheden kwamen volgens Amerikaanse bronnen de partijen overeen, dat zij gezamenlijk een hoeveelheid Russisch goud via het zwarte circuit van de hand zouden doen. Later bleek 2000 ton te zijn verdwenen uit de

kluizen van de Russische Centrale Bank. De oude communistische clan kreeg daarvoor de zwarte Piet toegespeeld. Op 28 januari 1991 arriveerde een Russische delegatie onder leiding van Jeltsins onderminister van Handel Vladimir Kozlov in Zürich voor de presentatie van de eerste boedschappenlijst waarop onder meer Tampax en diepvrieskuikens prijken. Bij de ontmoetingen in hotel Savoy bleek Dove Trading Company zich voor de uitvoering van de deal onder meer gelieerd te hebben met de Amerikaanse "New Republic Financial Group" en de Nederlandse im- en exportmaatschappij NV Balaton. Niet lang na deze conferentie barstte de bom en kwam de affaire via de internationale pers naar buiten. Toen de kruitdamp was opgetrokken, werd het voor insiders langzaamaan duidelijk, dat de hele onderneming van De Groot en zijn kornuiten op zijn minst twee agenda's had gehad. De een behelsde het langs slinkse wegen vullen der eigen zakken en het witwassen van avontuurlijk verkregen kapitalen. De ander om de Sovjet-Unie politiek verder te destabiliseren door de roebel in een vrije val te dwingen. Die operatie werd zonder twijfel begeleid door een aantal geheime diensten. Eén daarvan was de CIA, de ander mogelijk de Mossad. Dat valt te distilleren uit het verhaal van Leo Emil Wanta, de directeur van de New Republic Financial Group en partner van De Groot in het duistere spel rond de roebel. Een verhaal dat in essentie door de FBI is bevestigd.

De CIA-connectie

De in Appleton, Wisconsin, geboren Wanta werkte naar eigen zeggen al sedert 1963 voor de Amerikaanse overheid in de schaduwwereld van misdaad en geheime diensten. De financieel expert raakte op goede voet met generaal Vernon Walters, Nixons tweede man bij de CIA en later Reagans vertegenwoordiger bij het Vaticaan. In de jaren tachtig breidden zijn werkzaamheden zich verder uit ten behoeve van de batterij aan obscure organisaties die vice-president Bush in hoog tempo uit de grond had gestampt. Ook met functionarissen uit de top van de FBI onderhield Wanta levendige contacten. Zo assisteerde hij hen begin 1981 bij de infiltratie en het opblazen van een mafiaorganisatie die zich bezighield met de onvriendelijke exploitatie van gokkasten. Eind jaren tachtig, tijdens het presidentschap van George Bush, raakte hij in nog ruiger vaarwater. Nog voordat de kompanen van De Groot hun opwachting maakten op het Rode Plein in Moskou, had Wanta daar als directeur van de New Republic Financial Group, de route die de groep internationale financiers daarna zou volgen bij de aanval op de roebel, al uitgezet. Dat het pionierswerk van de met de CIA verbonden financiële whizzkid van hoog gehalte moet zijn geweest, bleek eens temeer in december 1991. Ruim na het naar buiten komen van het roebel-schandaal in de internationale pers. Toen sloot hij namelijk opnieuw een enorme, voor hem uiterst gunstige deal met de Russische regering, waarbij werd overeengekomen dat hij voedsel zou leveren in ruil voor olie. Er werden roebel- en dollarrekeningen geopend bij de Status Credit Bank in Singapore ten name van de Asian-Europe Development Ltd., een frontfirma van de CIA. Die behoorde tot Wanta's imposante netwerk van firma's over de hele wereld, dat door hem was gesponnen voor zijn financiële manipulaties. Vaak in opdracht van de Amerikaanse overheid. Een ander bedrijf dat er deel van uitmaakte was het geheimzinnige AmeriTrust Society. Het beheerde volgens Wanta het waanzinnige bedrag van 250 miljard dollar dat

stond geparkeerd op een bankrekeningnummer in Zwitserland. De rekening was geopend in het tijdperk waarin George Bush het in het Witte Huis voor het zeggen had (1981/1992) en behoorde kennelijk toe aan het Witte Huis. Dankzij een lawine aan publicaties sedert het eerste optreden van pentiti als Dick Brenneke en Oscar LeWinter is inmiddels duidelijk geworden, dat in die Bush-periode zowel de CIA als de DIA (de Amerikaanse Militaire Inlichtingendienst) en de Mossad hun greep op de internationale wapens- en drugshandel enorm hebben versterkt. Al was het alleen maar om hun gezamenlijk geheime operaties in Nicaragua, Afghanistan en het Midden-Oosten te kunnen financieren.

De arrestatie van een ambassadeur

In het begin van de jaren negentig werd Wanta ambassadeur van Somalië in Canada. Het hoe en waarom is duister, maar dat hiervoor stevig aan diplomatieke touwtjes moet zijn getrokken, moge duidelijk zijn. In april 1993 veranderde de roebel-manipulator van functie en werd benoemd tot Somalisch ambassadeur in Zwitserland. Begin juni 1993 kreeg ambassadeur Wanta in Zwitserland een seintje uit het nog niet zo lang door de Clintons bewoonde Witte Huis om een belangrijke financiële transactie voor te bereiden die via Credit Suisse moest lopen. Zeventig miljard dollar moest van de AmeriTrust-rekening overgeheveld worden naar de Amerikaanse schatkist en 250 miljoen dollar naar de rekening van het Children's Defence Fund, waarvan Hillary Clinton voorzitter was. Begin juli liet Vince Foster, de tweede man op de juridische afdeling van het Witte Huis, een kamer reserveren in hotel De la Paix in Genève. Op 7 juli meldde Foster zich aan de balie van het luxueuze hotel. Kort daarna arriveerde Wanta met een koffertje vol aandelen aan toonder. Hij overhandigde het aan Foster en na het checken van de inhoud kreeg Wanta een onverhandelbare bankcheque toegeschoven. Na het uitwisselen van de gebruikelijke vriendelijkheden namen zij afscheid van elkaar. Het zou hun laatste ontmoeting zijn. Diezelfde dag nog werd Leo Emil Wanta door de Zwitserse politie gearresteerd op verzoek van de Amerikaanse autoriteiten. Hij zou in de periode 1982/1986 in de staat Wisconsin een belastingschuld hebben opgebouwd van veertienduizend dollar. De Somalische ambassadeur belandde in een Zwitserse cel en hoorde daar op 20 juli dat Foster, een jarenlange intimus van de familie Clinton, dood was aangetroffen in een park in Virginia met een pistool zonder vingerafdrukken in zijn hand. Gezelfmoord. Wanta werd midden november 1993 vrijgelaten. De Israëlische premier Rabin zou daarop hebben aangedrongen, omdat er door de gedwongen afwezigheid van de directeur praktische problemen waren ontstaan bij het beheer van AmeriTrust! Wanta werd uitgewezen naar de Verenigde Staten. In Wisconsin werd hij wegens zijn belastingschuld in 1994 tot 22 jaar veroordeeld. Hij liet het er uiteraard niet bij zitten, maar hield zijn mond over de affaires in Moskou en Genève. Tot september 1996. Toen schreef hij vanuit zijn detentie een brief aan Hillary Clinton. Hij maakte daarin gewag van "short term notes" die in het bezit zouden zijn van haar echtgenoot en de verkoop van goud waarbij het Internationale Monetaire Fonds betrokken zou zijn geweest. Verder wees hij op zijn eigen rol bij de destabilisering van de roebel die dankzij hem de Amerikaanse schatkist rond de 150 miljard dollar zou hebben opgeleverd. Aan het einde van de brief verzocht hij mevrouw Clinton vriendelijk ervoor te zorgen dat hij in vrijheid werd gesteld. Dat gebeurde in februari 1997.

De aanhang van prins Alexis

De verkoop van goud waarnaar Wanta in zijn brief aan Hillary Clinton verwees had zonder twijfel te maken met de verdwijning van de tweeduizend ton uit de kluisen van Jeltsins Centrale Bank. Wanta werd bij die verdwijning geassisteerd door de buitengewoon en gevormd ambassadeur van de Russische Federatie in Rome: Roberto Coppola. Volgens de Amerikaanse schrijfster Claire Sterling in haar boek Thieves' World schermde deze zwendelaar-en-gros met valse geloofsbriefen van een Johannieter Orde. Uit een Amerikaans onderzoek bleek het te gaan om de Souvereine Militaire Hospitaler Orde van St. Jan van Jerusalem, Oecumenische Orde (OSJ), die officieel was gevestigd in Den Haag. Op het oog een merkwaardig zootje ongeregeld, dat jarenlang een prins Alexis als beschermer kende. De prins was geboren in Belgisch Congo als Alex Brimeyer. Ooit was hij echter tot de overtuiging gekomen dat hij een achterkleinzoon van de laatste Russische tsaar moest zijn. Waarschijnlijker is, dat prins Alexis leed aan een chronische vorm van tropenkolder. Maar om hem simpel af te doen als een soort prins Carnaval van St. Job-in-'t-Goor en omstreken zou een misvatting zijn. Merkwaardigerwijs figureerde hij namelijk prominent in een circuit van uiterst rechtse lieden bij wie geld en macht bovenaan het verlanglijstje stonden. Een van de orderidders was bijvoorbeeld de Spanjaard Manuel Sanchez Covisa. Diens naam verscheen voor het eerst in de beginjaren zeventig in de internationale pers. Hij bleek onderdaak te hebben verleend aan twee Italiaanse vluchtelingen, die de regie hadden gevoerd bij een couppoging in Rome: prins Valerio de Borghese en Stefano della Chiaia. In 1977 haalde hij opnieuw de pers. Toen trof de Spaanse politie in de woning van Sanchez Covisa namelijk een flinke hoeveelheid goud aan die was buitgemaakt bij de opzienbarende bankroef bij de Society Generale in

Nice op 18 juli 1976. De onderneming had onder supervisie gestaan van Alberto Spaggiari. Een medewerker van Della Chiaia, die onder meer zijn sporen had verdiend bij terreurgroeperingen als de Franse OAS en de Portugese Aginter Press.

Hoofd van de Franse tak van de orde was de echte prins Jean de Broglie. Een vooraanstaand Frans politicus en intimus van de presidenten De Gaulle en Giscard d'Estaing. In 1973 kwam De Broglie in beeld bij de Franse recherche. Als directeur van een concern dat toebehoorde aan de Katholieke lekenorganisatie Opus Dei werd hij verdacht van een grootscheepse vervalsing van staatsobligaties, illegale wapenleveranties aan de christelijk/falangistische regering van Libanon en handel in strategische goederen, waaronder uranium. Voordat de justitiële val dichtklapte werd de prins op 24 december 1976 vermoord. Zijn naam dook in 1981 postuum nog eens op bij een Belgisch onderzoek naar de smokkel van in Frankrijk gestolen uraniumstaven door een bende waarvan ook een van De Broglies vroegere vertrouwelingen deel uitmaakte. In België behoorde de zakenman Gustave Ketelaers tot de top van de orde. Uit een onderzoek van een

Belgische rogatoire commissie en de recherche kwam eind jaren tachtig aan het licht, dat hij contacten onderhield met de Syrisch/Palestijnse combine van Manzur el-Khassar. Een van de sinistere complotteurs uit de kring van Oliver North in het Iran/Contraschandaal, die handelde in alles wat Allah verboden had (ondermeer uranium, wapens en drugs) en wiens naam zowel verbonden was aan de Palestijnse overval op het cruise-schip Achille Lauro als het uiteenspatten van de PanAm-Boeing boven Lockerbie. De leiding van de Italiaanse afdeling van Brimeyers orde was in handen van een nep-prins: Basilio Petrucci. Nadat hij in 1977 was overleden nam diens zoon Arnaldo de fakkel over. Deze maakte ondermeer furore door Giancarlo Parretti tot ridder van de orde te benoemen. De met de mafia verbonden Parretti heeft in de jaren tachtig en negentig samen met de met Gelli's P2-loge gelieerde Florio Fiorini en diens SASEA-consortium gigantisch huisgehouden in de internationale financiële wereld. Zoals bekend uit talloze publicaties werden zij bij hun zwendelpraktijken trouw terzijde gestaan door een aanzienlijk aantal bekende figuren uit het Nederlandse bedrijfsleven. Na de Franse bank Credit Lyonnais bijna tot faillissement te hebben gebracht sneuvelde Parretti bij zijn poging (onder andere met hulp van Petrucci) de Amerikaanse filmgigant MGM over te nemen.

Giftig water

Volgens de voormalige mafia-leider Jimmy Fratianno in zijn boek *The Last Mafioso* zou "prins" Petrucci sr. in 1976 door de mafia worden ingehuurd om zanger Frank Sinatra in aanwezigheid van een aantal hoge Vaticaanse prelaten tot ridder te slaan. In het scenario voor de plechtigheid in Las Vegas was ook een Nederlandse naam opgenomen. De vertegenwoordiger van de orde in de Verenigde Staten tegenover Sinatra: "It looks quite promising that prince Bernhard of Holland will also attend if we can arrange for his transportation". De zanger voelde blijkbaar nattigheid en zijn ridderschap werd van de agenda afgevoerd. Het zou overigens de tweede maal zijn geweest, dat prins Bernhard namens de club van Brimeyer in de VS actief was. In 1969 sloeg hij in New York de Amerikaanse oogarts dokter Morrison tot ridder als dank voor diens geslaagde medische ingreep bij Bernhards dochter, prinses Christina. De prins werd bij de plechtigheid gechaperonneerd door de neoprins Robert von Brancovan en de valse baron Von Blomberg.

Mogelijk heeft de door de FIOD van witwaspraktijken verdachte Nederlandse vermogensbeheerder Dirk De Groot bij zijn destabiliseringsoperatie in de Sovjet-Unie geen weet gehad van de betrokkenheid van het hierboven beschreven netwerk van charlatans, louche zakenlui, geheimagenten en rechtsextremisten. Zelfs niet achteraf. Maar blijkbaar was de top van het Britse effectenhuis James Capel begin 1993, toen het net rond Wanta zich langzaam begon te sluiten, wel op de hoogte geraakt van wat incriminerende aspecten van De Groots activiteiten. Zij gaf in februari van dat jaar opdracht aan haar Nederlandse dochteronderneming Van Meer James Capel om de rekeningen van De Groots onderneming ESC af te sluiten. Een reden voor dat ingrijpende besluit werd niet gegeven. Het enige wat de Britse leiding van James Capel kwijt wilde was: "The water is poisoned".

The following is a partial list of a large number of persons who have recently met their demise in suspicious circumstances who appear to have some connection to the Clintons. I stress partial because new addditions are coming in faster than closets can be found to hide the bodies in! Ms. Mahoney, for example!

THE MOST RECENT:

• Mary Mahoney - White House Intern - died 7/97

An attractive 25 year old woman, Mary was a former White House Intern for Bill Clinton working as the Assistant Manager at a Starbuck's Coffee shop in Georgetown. In the pre-trial publicity surrounding Paula Jones lawsuit, and mere days after Newsweek's Mike Isikoff had dropped hints that a "former White House staffer" was about to go public with her story of sexual harassment at 1600 Pennsylvania, gunmen entered the Starbuck's while the crew was cleaning up after closing. Mary's two associates were taken to a room and shot. Mary herself had five bullets in her. No money was taken. As of this writing, Mike Isikoff's "former White House staffer" has never appeared.

THE MOST FAMOUS:

• Vincent Foster - White House Counsel - died: 7/21/93

Found dead in Ft. Marcy Park in Washington, DC, of a supposed suicide by gunshot. A suicide note was supposedly found a few days later, torn into several pieces, in his briefcase, after his office had been entered by WhiteHouse staff and materials removed. The gun which he supposedly used to kill himself was reported to be still in his hand, but the person who first found the body reports that there was no gun at that time. Many irregularities surround the death and the investigation of it. - Foster was also from Hope, Ark., like Clinton, and also worked for the Rose Law firm. Foster had intimate knowledge of the Clintons' personal finances. Foster was involved in an investigation of their finances, and reportedly made a phone call to Hillary Clinton, in Little Rock, just hours before his death.

DEAD BODYGUARDS & MILITARY:

• Maj. Gen. William Robertson - Deputy Commanding General, V Corps, Europe

• Col William Densberger - V Corps Chief of Operations and Plans

• Col. Robert Kelly - V Corps Chief of Intelligence

• Spec. Gary Rhodes - Crew Chief

died: 2/23/93 - All were killed when their helicopter crashed in Weisbaden, Germany. No cause was ever determined. - V Corps figured prominently in the US Bosnia-Serbia peacekeeping operations, along with the carrier Roosevelt. These men, and 8 others associated with Clinton's visit to the Roosevelt all died within 4 months of each other.

• Steve Willis - Clinton bodyguard

• Robert Williams - Clinton bodyguard

• Conway LeBleu - Clinton bodyguard

• Todd McKeehan - Clinton bodyguard

died: 2/28/93 - "executed" by gunfire in the Waco, Texas assault on the Branch Davidians. - All four were examined by a "private doctor" and died from nearly identical wounds to the left temple, so-called execution style. According to Linda Thompson, videotapes and other evidence indicates that none died from guns fired by Branch Davidians.

Five Navy aviators - Clinton bodyguards/escorts:

• (names not determined) died: 3/26/93 - all died in a crash of an E-2C Hawkeye in Italy. The crash occurred shortly after the plane was "waved off" from a landing attempt on the Carrier Roosevelt, due to a "foul deck". - All five men had been Clinton's escorts during Clinton's visit to the Roosevelt 2 weeks prior. Three other men, who had flown Clinton to the Roosevelt for that visit also died later in a helicopter crash.

• Staff Sgt. Brian Haney - Clinton bodyguard

• Marine Sgt. Tim Sabel - Clinton bodyguard

• Maj. William Barkley - Clinton bodyguard

• Capt. Scott Reynolds - Clinton bodyguard

died: 5/19/93 - All four men died when their helicopter crashed in the woods near Quantico, Va. - Reporters were barred from the site, and the head of the fire department responding to the crash described it by saying, "Security was tight," with "lots of Marines with guns." A

videotape made by a firefighter was seized by the Marines. All four men had escorted Clinton on his flight to the carrier Roosevelt shortly before their deaths.

DEAD FUNDRAISERS:

- C. Victor Raiser II - National Finance Co-Chairman, Clinton for President Campaign
- Montgomery Raiser - Son of C. Victor Raiser II
died: 7/30/92 - Both men died in a private plane crash in Alaska, en route to a fishing expedition. No cause was ever determined. Five others not connected to Clinton died with them. - DeeDee Meyers described Raiser as a "major player" in the Clinton organization. Victor raiser was also chairman of Mobile Telecomm Technologies Corp., whose subsidiary, SkyTel Corp. is an international paging company used by federal police agencies such as the FBI.
- Paul Tully - Democratic National Committee Political Director
died: 9/24/92 - Found dead in a hotel room in Little Rock Arkansas of "unknown causes." No autopsy allowed. - Described by Clinton as a "dear friend and trusted advisor. Tully authored several key strategies for Clinton and the party.
- Ed Willey - Real Estate Attorney, Clinton Fund Raiser
died: 11/30/93 - Died of gunshot to the head. Body found in deep woods in Virginia. Ruled a suicide, no note was found, nor was any motive identified. - Intimately involved in several Clinton fund raising events.
- Hershell Friday - Attorney and Clinton fund raiser.
died: ??? - Killed when his plane exploded. Cause unknown.

DEAD WITNESSES:

- Jerry Parks - Head of Clinton's Guberntorial security team in Little Rock.
died: 9/26/93 - Gunned down in his car at a deserted intersection outside Little Rock. - His family reported that shortly before his death, they were being followed by unknown persons, and their home had been broken into. Parks had been compiling a dossier on Clinton's illicit activities. The dossier was stolen.
- James Bunch - Influential Texan
died: ??? - Died from a gunshot suicide, similar to Vince Foster. - Was discovered to have a "little black book" containing the names of many influential persons in Texas and Arkansas who visited certain prostitutes.
- John Wilson - Former Washington DC Council member
died: 5/18/93 - Found dead from an apparent hanging suicide - Suicide appears suspicious due to an unusual number of reports made to the media concerning his "depression". Was reported, but not proven, to have ties to the Whitewater affair.
- Bill Shelton - Arkansas state trooper and fiancee of Kathy Ferguson
died: 6/94 - allegedly committed suicide by shooting himself at the gravesite of his fiancee - Officer Shelton was the fiancee of Kathy Ferguson, who was the ex-wife of Trooper Danny Ferguson. Kathy Ferguson also committed "suicide" 6/94 when she shot herself in her living room. Oddly, next to the body were her packed bags, as if she was expecting to be going somewhere. Danny Ferguson is a co-defendant along with Bill Clinton in Paula Corbin Jones's sexual harassment suit. His ex-wife was reported as a corroborating witness for Ms. Jones.
- Kathy Ferguson - Ex-wife of Trooper Danny Ferguson
died: circa 5/94 - Died of a supposed gunshot suicide in her living room. There was a suicide note found by the body. However, friends were surprise at having noticed nothing wrong previously. And even more curious, found nearby were several packed suitcases, as if she expected she was going somewhere. She was the former wife (since changed her name) of Trooper Danny Ferguson, who is the Arkansas State Trooper alleged to have escorted Paula Corbin Jones to the hotel room for her alleged episode of sexual harassment by then-Governor Clinton. Ferguson's wife was reported as a possible corroborating witness for Ms. Jones.
- Gandy Baugh - Attorney representing Mr. Lassater in a case concerning alleged financial misconduct. died: circa 5/94 - Died in an alleged suicide by jumping out of a window of a multi-story building. - Mr. Lassater was a close associate of Gov. Clinton, and was later indicted on drug related charges, among other things.
- Dr. Ronald Rogers - Dentist from Arkanasas
Killed in plane crash as he was on his way to an interview with a "London Sunday Telegraph" reporter to reveal some Clinton dirt.
- Stanley Huggins - Partner in Memphis law firm investigating Madison Guaranty. His 300 page report has never been released.
- Florence Martin - Accountant subcontracting to CIA related to the Barry Seal case. Dead of three gunshot wounds to the head.
- Jim Wilhite - Wilhite was an associate of Mack McLarty's former firm. Wilhite died in a skiing accident on December 21, 1992.

DEAD WOMEN:

- Suzanne Coleman - Had affair with Clinton when he was attorney general.
Died of "suicide" with gunshot wound to the back of her head. No autopsy performed. Was pregnant at time of her death. Some say it was Clintons.
- Paula Grober - Clinton's speech interpreter for the deaf
died: 12/9/92 -Died in a one-car accident with no known witnesses. Her body was thrown 33 feet from the car. A very attractive women, Paula traveled extensively with Clinton from 1978 until her death.

DEAD INVESTIGATORS:

- Paul Wilcher - Washington attorney investigating government corruption
died: 6/22/93 - Found dead on a toilet in his Washington apartment. No cause of death was ever determined. - At the time of his death, he was investigating connections between the "October surprise" during the 1980 federal election campaign and drug and gun-running out of Mena, Arkansas, as well as the BATF assault on the Waco, Texas Branch Davidians. Was planning on producing a television documentary

on his findings. He had delivered a 99-page affidavit to Janet Reno three weeks before his death.

- Jon Parnell Walker - RTC investigator Mysteriously fell to his death from an apartment balcony. The same apartment which was alleged to have been a secret getaway which Foster may have visited.

DEAD COMMERCE DEPARTMENT DEATHS:

- Ron Brown - Former Chairman, DNC; Commerce Secretary

died: 5/3/96 - Ron Brown died along with 39 other people when the T-43 (a converted 737 used by the Air Force) carrying the group on a trip to Bosnia crashed while approaching the Dubrovnik airport. On the verge of being indicted and having stated publicly his willingness to make a deal with prosecutors, Ron Brown's death brought to an end the investigations into the Commerce Department. (NOTE: Also belongs under dead fundraisers)

- Barbera Wise - Commerce Department Staffer

died: 11/29/96 - As the scandals continued to swirl around the Commerce Department, and most of all about John Huang, one of Huang's associates, Barbera Wise, was found dead in her locked office at the Department of Commerce, partially nude and covered with bruises. No cause of death has ever been announced. Oddly enough, following the discovery of her body, Bill Clinton made an unscheduled return to the White House from Camp David, claiming he needed a book of poetry in order to complete his inauguration speech.

- Charles Meissner - Ass't Secretary Commerce for Intern'l Economic Policy.

died: UNK - Following Ron Brown's death, John Huang was placed on a Commerce Department contract that allowed him to retain his security clearance by Charles Meissner. Shortly thereafter, Charles Meissner died in the crash of a small plane.

THE HENRY IVES DEATHS:

- Kevin Ives & Don Henry

Initial cause of death was reported to be the result of falling asleep on a railroad track in Arkansas on August 23, 1987. This ruling was reported by the State medical examiner Fahmy Malak. Later it was determined that Kevin died from a crushed skull prior to being placed on the tracks. Don had been stabbed in the back. Rumors indicate that they might have stumbled upon a Mena drug operation.

- Keith Koney - Keith had information on the Ives/Henry deaths.

Died in a motorcycle accident in July 1988 with unconfirmed reports of a high speed car chase.

- Keith McKaskle - McKaskle has information on the Ives/Henry deaths.

He was stabbed to death in November 1988.

- Gregory Collins - Greg had information on the Ives/Henry deaths.

He died from a gunshot wound to the face in January 1989.

- Jeff Rhodes - He had information on the deaths of Ives, Henry & McKaskle.

His burned body was found in a trash dump in April 1989. He died of a gunshot wound to the head and there was some body mutilation, leading to the probably speculation that he was tortured prior to being killed.

- James Milam - Milam had information on the Ives & Henry deaths.

He was decapitated. The state Medical examiner, Fahmy Malak, initially ruled death due to natural causes.

- Richard Winters - Winters was a suspect in the deaths of Ives & Henry.

He was killed in a "robbery" in July 1989 which was subsequently proven to be a setup.

- Jordan Kettleson

Kettleson had information on the Ives & Henry deaths. He was found shot to death in the front seat of his pickup in June 1990.

MISC DEATHS:

- Stanley Heard - Chairman, National Chiropractic Health Care Advisory Committee

- Steve Dickson - Counsel to Mr. Heard

died: 9/10/93 - Both died in a plane crash outside Dulles airport, after their aircraft, rented after Heard's personal craft developed troubles, crashed while attempting an emergency landing after reporting a fire on board. - Heard, in addition to serving on Clinton's advisory council, also personally treated Clinton's mother, stepfather, and brother.

- Jim Wilhite - Vice Chairman, Arkla, Inc.

died: 12/21/92 - Died in a one-person skiing accident. - Wilhite had extensive ties with Clinton and Mack McLarty, with whom he visited by telephone just hours before his death.

Wounded or attempted murder:

- Gary Johnson - Not dead, but beaten near death and left for dead.

Had videotapes of Clinton breaking into Gennifer Flowers' apartment. His tapes were taken.

- Dennis Patrick - Court clerk.

Had millions of dollars laundered through his account at Lasater & Co without his knowledge. Four attempts on his life.

- L.J. Davis - Reporter investigating Clinton scandals.

Attacked at his hotel room in Little Rock. His notes were stolen.

- Larry Nichols - Former official at ADFA & author of "The Clinton Chronicles."

The man who broke many of the Clinton scandal stories. Several attempts on his life.
