Dear Mr. President:

As you are aware, during November/December 1989, I was approached by Dr. Hassan A. Meguid, allegedly representing a Iranian Group, as shown below;

- (a) RAFIT DOUC - Chief of Iranian Revolutionary Guards - Teheran
- (b) " TUKAN " - Chief of I.R.I.A.F. - Teheran Headquarters
- (c) Monica Bendeck - Dubai / Abu Dhabi intermediary
- (d) " HORMOS " - Teheran official of General Staff Hdqtrs

Several weeks ago in consultation with my Controller RAC William Lecates, U.S. CUSTOMS SERVICE / NASHVILLE under USA assigned cover as -

File code name ; Frank B. Ingram

File name/number ; FBI (SA 32 NV)

As I was instructed and cleared to continue communications while the " good old guys " upstairs determine the next course of action, besides running through the side door as discovered later, based on my reporting data.

Later I was requested by the Iranian group to attend a special meeting in Abu Dhabi, which is to include the Dubai Ambassador to discuss details. On March 16, 1990, I requested again USA authorization to attend, or I would not consider further communications or Iranian requests, inter alia. Based on these sensitive requests to the upstairs level personnel for USA advice and direction, I was informed that RAC Lecates would no longer be my Controller, and since " Uncle Bill " has passed away, the directive now suggested I contact Vice President Dan Quayle or President Bush, for various security reasons, among other things. The " Good Old Boys " upstairs have received all of the pertinent data and related documentation from Nashville.

Since I was NOT CONTACTED IN AMMAN early Monday thru Wednesday, this week, relative to the Iranian meeting request(s), I will " stand down " on this sensitive situation, unless I receive direction and authorization.

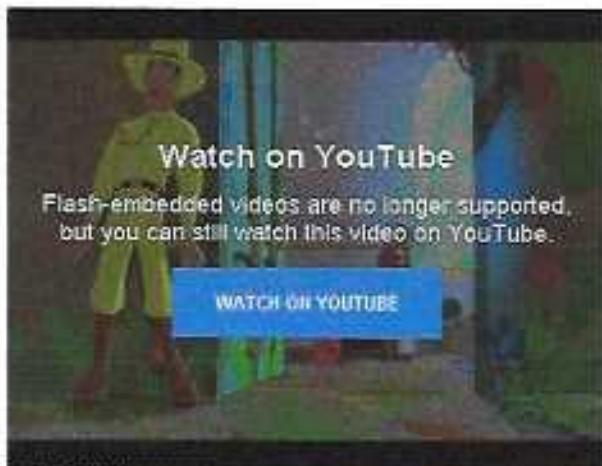

To say that Berman was in the "right place, at the right time" and was handed what may turn out to be the biggest story to ever come down the pike, is the understatement of the century.

Following Skorzeny's death on December 31, 1999, Berman gathered additional information about Skorzeny's Nazi cohorts and put the entire story together with 60 or 70 of Skorzeny's shoe box photos - into a copyrighted unpublished manuscript called The Bush Connection.

1. The Nazi Identity of George Herbert Walker Bush

2. The Assassination of Nicola Tesla

Skorzeny's role (with Reinhard Gehlen) in the assassination of Nikola Tesla (suffocation) on January 6, 1943 after tricking Tesla on January 5 into revealing the full details of his most important discoveries and then stealing his most valuable inventions, along with the contents of his safe, which were delivered to Hitler,

3. Hitler's Fake Suicide

The faked April 1945 "suicide" of Hitler in the Berlin bunker (corroborating the 1948 CIA interrogation of Gestapo Chief Heinrich Mueller, the Nordon Report, and the Russian 1946 Investigative Committee report to Stalin)

4. Nazi Gestapo Forming The CIA

Skorzeny's pivotal role in consolidating the intelligence assets of the Nazi Gestapo and the Nazi-infiltrated OSS (Office of Strategic Services) into the Central Intelligence Agency (CIA) in 1947, working with George Herbert Walker Bush (Nazi infiltrator George H. Scherff, Jr.), Nazi SS spy master Reinhard Gehlen, "Wild Bill" Donovan (compromised), and fifth columnist, Allen Foster Dulles. Skorzeny claimed central responsibility for setting up the Odessa operation to surreptitiously relocate 50,000 (FIFTY THOUSAND) Nazis into North and South America with CIA complicity and protection,

5. The Assassination of JFK

Skorzeny's claim that Reinhard Gehlen, Josef Mengele, and George H W Bush directly participated in JFK's assassination and other Nazi-inspired plots.

Don Nicoloff published a well researched treatise in two parts in April 2007 in the Idaho Observer titled "Deathbed Confessions, photos support claims that George H. Scherff(f), Jr., was the 41st U.S. president".

The historical archives indicate that "Otto Skorzeny" died in Madrid, Spain in 1975, but Skorzeny told Berman that the date was faked by the CIA, as were the "deaths" of many Third Reich notables. The Third Reich intelligence apparatus, under General Reinhard Mueller, towards the end of the war, faked many "deaths" in anticipation of losing World War II.

Washington, D.C. -- Leo Wanta, whose purchase of huge sums in Russian rubles is credited with bringing down the Soviet Union in the Cold War, will be put through a third party lunacy test in Madison, Wisconsin circuit court on Tuesday. He has successfully been declared of sound mind in two previous lunacy tests under the Wisconsin state attorney general's office. His own attorney, James Shellow of Madison, Wis., is instituting this test. Shellow says that under the rules for attorneys in Wisconsin he has to notify the court that he thinks the lunacy test should be given. Shellow admits to being a former attorney for a deceased Mafia chief in Wisconsin named Belistiari. Shellow thinks Wanta will be declared sane in the upcoming hearing on Tuesday, but Shellow claims to know nothing as to how Wisconsin was able to extradite Wanta in chains and shackles from Switzerland, where he was doing business with Swiss banks after having given up his citizenship in Wisconsin. Wanta claims that he had just been made ambassador to Switzerland and Canada when Wisconsin state officials seized him bodily in Switzerland. Wanta claims that they took his briefcase from him at that time which contained billions in Treasury bills and Promise software technical equipment which the U.S. was using to get inside information about foreign treasuries.

Although the briefcase was taken by Wisconsin authorities in 1993, it has never been returned to Wanta nor has he any knowledge of what happened to its contents.

The charge is that he owed Wisconsin originally approximately \$14,000. He claims to have paid back that amount in 1992. The state attorney general's office seized his house worth \$120,000 and sold it for \$60,000, but there is no record of this in the Department of Revenue in Wisconsin nor is there any trace of the proceeds from the sale.

Wanta was buying rubles from Russia at the request of the President, Ronald Reagan. Wanta had worked at the White House, the National Security Council, the Central Intelligence Agency and six other government agencies during his career.

He and President George Bush set up the Ameritrust account in the Credite Suisse bank for the U.S. government to use in case it needed to counter terrorists from overseas, according to Pat Cameron, Los Angeles attorney for Wanta. Wanta says that when former president George Bush sought to withdraw funds from the \$210 billion on deposit that Wanta, a co-signer of the account, refused to give his signature for the withdrawal because the funds, he said, belonged to the U.S. government, not to an individual.

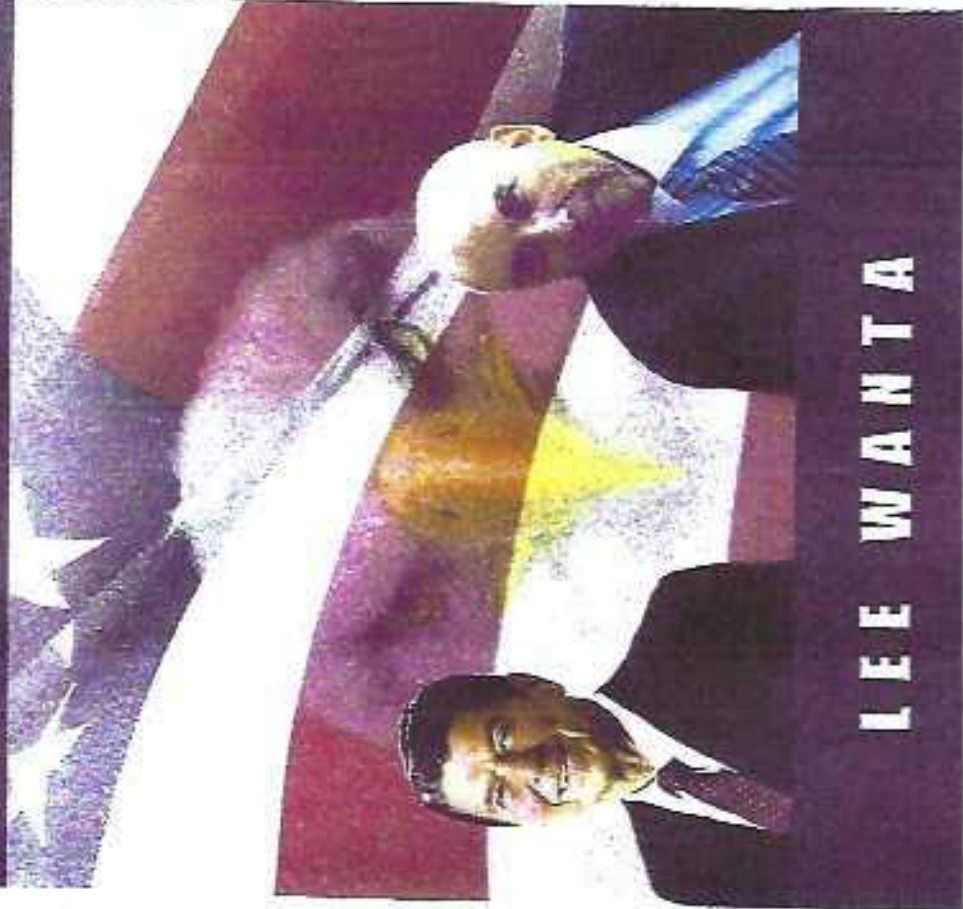




