Mnuchin is former long time Goldman Sachs executive partner with Hank Paulson and former George Soros employee and partner

Mnuchin worked for 17 years at Goldman Sachs. He later led OneWest Bank, which was sold to CIT Group in 2015. He now serves on CIT's board and is the chairman and chief executive of the private investment firm Dune Capital Management.

In a July interview with CNBC, Mnuchin said the 2010 Dodd-Frank Law, which strengthened the regulation of the finance industry, "needs to be looked at." He said there are good and bad aspects of the law, according to a profile that Bloomberg published in August. **Trump has said he wants to dismantle Dodd-Frank.**

## Steven Mnuchin: 5 Fast Facts You Need to Know

Days after the historic election of Donald Trump as the 45th president of the United States, we're beginning to hear about his possible cabinet appointments.

Among the names being floated is Steven Mnuchin, who Trump has indicated he hopes to make Treasury secretary, [according to Politico](#). Mnuchin served as Finance Chair during the Donald Trump presidential campaign, and he would be replacing the current Treasury secretary, Jacob Lew.

Here's everything you need to know about the United States' possible next Treasury secretary.

### 1. He Worked for Goldman Sachs

Much to the chagrin of many within both the Republican and Democratic parties, Trump's potential Treasury secretary pick is a 17-year veteran of Goldman Sachs, the bank which had a role in the 2008 financial crisis and which was bailed out by the United States government.

Mnuchin came to work for Goldman Sachs in part because his father, Robert Mnuchin, was a prominent Goldman Sachs banker of 30 years, [according to The New York Times](#). Mnuchin left the bank in 2002, but he would later become the head of OneWest Bank, and he currently is the chairman of Dune Capital Management, a private investment firm.

According to [The Wall Street Journal](#), when Mnuchin left Goldman Sachs, he was worth \$46 million.

## 2. He Is Also a Film Producer

Mnuchin has amassed his wealth not just through investment banking; he is also involved in the world of Hollywood.

In 2006, Mnuchin founded Dune Entertainment, a production company that later merged with Brett Ratner's RatPac Entertainment to form RatPac-Dune Entertainment. This company has a financial stake in [dozens upon dozens of](#)



popular films, including 2016 movies like *Suicide Squad*, *Batman v Superman: Dawn of Justice*, *The Accountant*, and *The Conjuring 2*. They also co-produced the upcoming movies *Fantastic Beasts and Where to Find Them* and *Assassin's Creed*. Plus, the company co-produced the highest grossing movie of all time, *Avatar*.

Two years ago, Mnuchin became the co-chairman of Relativity Media. He left the studio not long before it filed for Chapter 11 bankruptcy, [according to Variety](#).

### 3. OneWest, the Bank He Headed, Has Been Criticized For Its Foreclosure Practices

In the aftermath of the 2008 financial crisis, Steven Mnuchin and a group of investors including George Soros purchased IndyMac Bank from the Federal Deposit Insurance Corporation for \$1.5 billion. IndyMac was one of the lenders that dealt with high-risk loans and which collapsed during the housing market crash, being seized by the FDIC. [According to The Nation](#), Mnuchin and his fellow investors made a deal with the FDIC where they would purchase the bank and also receive reimbursements for the cost of foreclosing on people who had loans with IndyMac. Mnuchin later renamed IndyMac OneWest Bank.

OneWest has been criticized for cruelly foreclosing on Americans across the country, often being taken to court for their practices. For example, there was the case of Diane Yano-Horoski and Greg Horoski, a Long Island couple who bought a one-level house in the mid 1990s for \$200,000. [As reported by The New York Post](#), they refinanced their loan in 2004, but after the interest rate soared and Horoski began dealing with health problems, they had trouble making payments and they were sued by IndyMac. Their home was foreclosed, and Horoski went to court. The judge completely wiped out the couple's \$525,000 mortgage and criticized IndyBank for "harsh, repugnant, shocking and repulsive" actions. This took place while IndyBank was embroiled in another court case involving their foreclosure of an 89-year-old woman's home.

In October 2011, around the time of the Occupy Wall Street movement, protesters marched outside of Steve Mnuchin's mansion in Los Angeles, holding up signs reading "Stop taking our homes," [according to Bloomberg](#).

Over the next few years, OneWest was involved in several lawsuits and on multiple occasions settled for millions of dollars, [according to The New York Times](#). They have also received subpoenas from the Department of Housing and Urban Development, [according to The Nation](#).

Last year, Mnuchin sold OneWest Bank for \$3.4 billion.

### 4. He Has Donated to Democrats, Including Hillary Clinton

Like Donald Trump himself, Steven Mnuchin has donated to politicians on both sides of the aisle, including Trump's 2016 opponent, Hillary Clinton. [According to Bloomberg](#), Mnuchin has donated about \$7,000 to Hillary Clinton, including during her 2008 bid for the White House.

He has donated to the Republican National Committee as well, but Bloomberg reports that Mnuchin's donations to Democrats outweigh his donations to Republicans. Mnuchin told [The New York Times](#) that he donates to both sides because he has "always believed in supporting the best candidate at the time."

It's unclear to what degree Mnuchin actually agrees with Trump on certain issues. [According to Bloomberg](#), Mnuchin has had to defend Trump to his friends and family after the candidate's controversial actions. For example, over the summer, Mnuchin received a call from a Holocaust survivor he knows after Donald Trump tweeted an anti-Semitic image of Hillary Clinton surrounded by piles of money and a six-pointed star.

[Billionaire developer Richard LeFrak](#) told Bloomberg that he isn't sure Mnuchin's beliefs even line up with that of Donald Trump but that Mnuchin joined the Trump team because he saw it as a great opportunity.

"He's a guy that can recognize an opportunity and adapt to it," LeFrak said, "He's able to switch into different things."

## 5. Critics Fear He Won't Be Tough on Wall Street

Throughout his campaign, Donald Trump has positioned himself as a candidate outside of the establishment,







criticizing his rivals for taking money from Wall Street and suggesting he will end corporate loopholes that benefit wealthy bankers. This populist message appealed to his Republican reporters and even to some Democrats, who felt Hillary Clinton was too cozy with Wall Street.

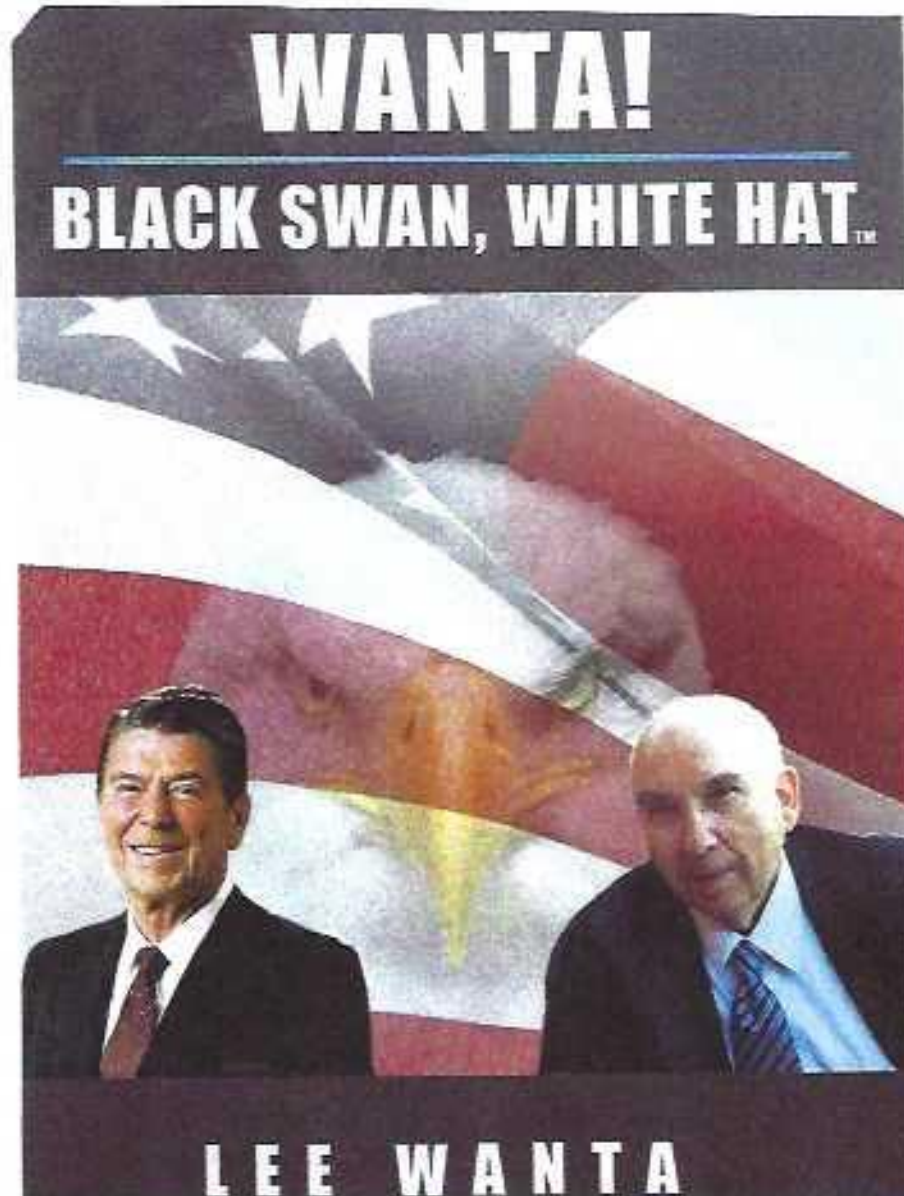
But some critics worry that the hiring of Steven Mnuchin suggests that Trump will not do anything about Wall Street after all.

"It's hard to see Mnuchin cracking down on Wall Street," Jeff Hauser, director of the non-profit Revolving Door Project, told [Politico](#). "Indeed, one imagines Mnuchin's banking agenda would be to rehabilitate Trump's reputation with Wall Street."

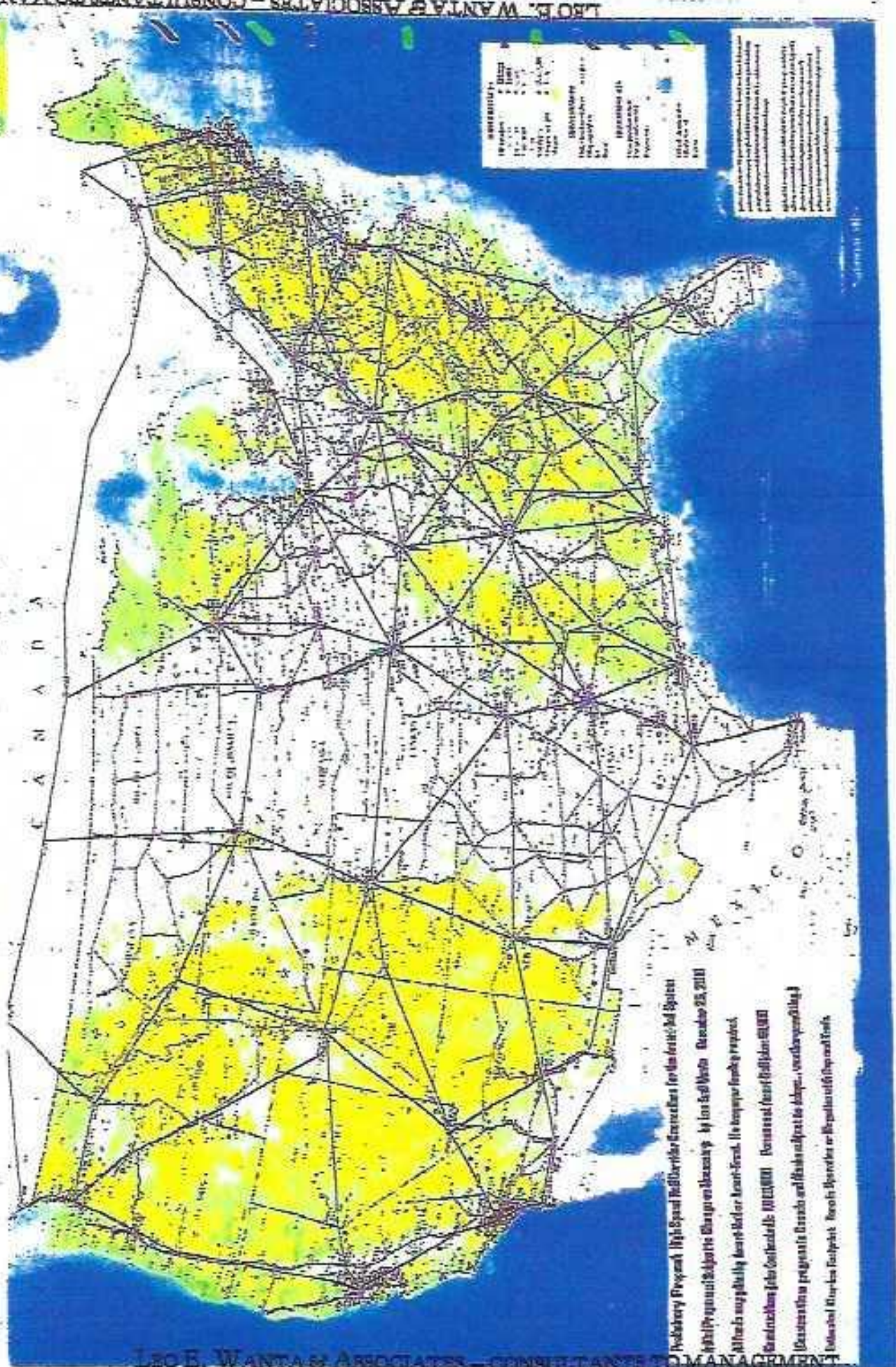

### High Speed Rail, Lee Wanta, and the missing 27 Trillion Dollars?

In the late 1980s, United States President Ronald W. Reagan gave a mandated order/directive to Leo Emil Wanta" (Presidential Executive Order No. 12333). President Reagan authorized Wanta's company, New Republic/USA Financial Group, Ltd., Jackson, Mississippi, USA (a Mississippi intelligence operations group under Title 18 USC Section 6 (b)(1)) to build or otherwise obtain a rail system capable of moving MX Mobile Missiles.

Reagan's directive had to do with an Operational Plan to lawfully purchase the Santa Fe & Southern Pacific Railroad in the U.S. Bankruptcy Court for authorized mobilization and deployment activities. One of those authorized activities involved the movement of MX Mobile Missiles to an underground storage facility at Redstone Arsenal in Huntsville, Alabama. Redstone began as a chemical weapons manufacturing facility for WWII but became the Army's focal point for rocket and space projects (including the development of the first U.S. ballistic missiles and space launch vehicles).

Ambassador Lee Wanta was asked by President Reagan to assist with the transportation of MX Missiles.

MX Missiles transported in disguise inside specially constructed Railroad Cars.

Though using an old bankrupt railroad called Santa Fe & Southern to move MX Mobile Missiles is a far cry from planning a national high-speed rail system, that is how Ambassador Lee Emil Wanta got involved in planning a national high-speed rail facility for the American people. It began as a means to quickly and efficiently move MX Mobile Missiles and ended as the dream of an engineer who could see the long-term benefits to his nation if such a system were implemented. For those who have no idea how far-sighted President Ronald Reagan and his intelligence team were, a mid December 2013 news story might help you understand. It's about Russia and an announcement made by President Vladimir Putin. These paragraphs were included in the Associated Press news article:

"Russia is developing a new intercontinental ballistic missile mounted on a railway car in a bid to counterbalance

prospective U.S. weapons, a senior military officer has said.  
 "Colonel General Sergei Karakayev, the chief of the military's Strategic Rocket Forces, said in remarks carried by Russian news agencies on Wednesday that the new weapon would be much easier to camouflage than its predecessor. The Soviet-designed railway missiles were scrapped in 2005.  
 "Karakayev said the Yars missile intended for the project was much lighter than the Soviet-built system and could be put inside a regular refrigerator car unlike its predecessor, which required a heavier and bigger car that could be detected by enemy intelligence."  
 All Putin is doing today is a mirror image of what Reagan and Wanta were doing back in the 1980s and 90s. There is a long and not-so-glorious history for a high-speed rail program that has yet to be implemented in the United States... but let's start at the beginning.  
 Wanta purchased the Federal Land Bank Building in Jackson, Mississippi.

The direct mandated order that Lee Wanta got from President Reagan told him to purchase the Federal Land Bank Building in Jackson, MS, which would be used for logistics and satellite food. The funds to buy the building and the Santa Fe & Southern Pacific Railroad came from the Department of Defense to Wanta's company, New Republic. The money was placed in Deposit Guaranty Bank in Mississippi and the credit cards for field operations were issued by Merrill Lynch to the New Republic/USA Financial Group.

If you have read Chapter 9 of Wanta's biography, WANTA! Black Swan, White Hat (1) (available at Amazon.com Kindle), you are aware that the prosecuting attorney in Wanta's civil/criminal tax evasion kangaroo trial, I. Douglas Haag, a Wisconsin Assistant Attorney General, made much to-do about a \$500,000 deposit made to the Mississippi bank, informing Wanta's civil tax evasion jury the funds were Wanta's personal property, but then misrepresented them as evidence of his guilt as a tax evader in the State of Wisconsin.  
 Wanta is wrongly set up in one of the biggest miscarriages of justice ever.

These funds, of course, came from the Department of Defense and represented nothing of the kind... but Haag had Wanta in a box. The money had been provided to purchase a railroad that would be used to haul MX Mobile Missiles to defend the nation. The railroad and building for which the funds were provided both were linked to a highly secret mandate from the President of the United States and Wanta could not make that information public at his phony criminal trial for tax evasion. Instead, he had to eat a 22-year prison and parole sentence.  
 At the time of Wanta's Mississippi attempt to purchase the Santa Fe & Southern Railroad for moving the MX Mobile Missiles to appropriate locations for the national defense of the country, the Central Intelligence Agency (for which Vice President George Herbert Walker Bush had been Director until becoming Vice president under Reagan) was America's primary intelligence agency. Because Reagan believed that the CIA was totally corrupted, he and Wanta were in the process of implementing a new intelligence agency called Intelligence Services Agency (ISA) which would have put the CIA into competition with the ISA for its survival. Lee Earl Wanta was to be the Assistant Director of the new intel-ops group... one of the reasons he was targeted as someone who needed to be "taken down."  
 High Speed Rail (HSR) blocked by Political Cronyism.

As is almost always true in the world of political cronyism, the CIA was threatened by the presence of the new ISA group and was probably behind the failure of the acquisitions program - the railroad and the Federal Land Bank Building - to implement President Reagan's plans. The result: the CIA did not want the MX Mobile Missiles being moved around by the Department of Defense via Wanta's company - a Title 18 USC Section 6 (Line 1.1) intelligence gathering corporation. They wanted to control the operation complete with "set-aside allocations" and other financial motivation to be enjoyed by the participants at the expense of American taxpayers.

Today's politics include guaranteed employment for well-known public employees called upon to perpetrate fraud upon the people of America while being paid by those very same people... they get set-aside allocations (like university positions funded by the government) and other revolving door professional courtesies like honorariums that bring with them power and position.  
 Surely you've noticed how the doors at Goldman Sachs swing open to place Henry Paulson as Secretary Treasury and how the government doors swing open so Robert Rubin can join Goldman Sachs... or how easily Janet Napolitano walked into her new job in California's University System.  
 Reagan's and Wanta's ISA made no such concessions to politicians and bureaucrats and so completing the mission was made impossible for Wanta. To make sure completing the mission was impossible, Wanta was put in prison in Switzerland - no charges were ever filed during his 134 day prison stay in Levensau's du Bois prison. They just kept him in an isolated dungeon cell likely built about the time Rome fell.  
 High Speed Rail (HSR) can provide Civil Defense capabilities not otherwise possible.

The public was to be told that the rail system Wanta was told to purchase was that people could quickly be moved to safety when the need arose... a hurricane evacuation route for Florida, Georgia, Alabama,



Mississippi and Texas and that high-speed rail filled that need nicely. The hard core reason that justified the costs involved was, however, national defense: the movement of MX Mobile Missiles to critical locations.

So there you have that's the synopsis of why Putin is, in December 2013, taking advantage of the original plan for Mobile MX Missiles born during the Reagan Administration under the management of Secret Agent Lee Earl Wanta... a plan that would have saved us from the USSR at that time. Wanta was working in concert with General James A. Abrahamson, Central Intelligence Director William Casey, former Central Intelligence Director William Colby, and Reagan's Attorney General, William French Smith. Gen. Abrahamson was Director for the F-16 Multinational Air Combat Fighter Program at Aeronautical Systems Division before being assigned Administrator for the Space Transportation System, and was responsible for the nation's space shuttle program. In 1980, he assumed the duties of Deputy Chief of Staff for Systems, Air Force Systems Command Headquarters.

And there you have the reason behind the birth of high-speed rail and the many positive ways it can be used for the good of the people to escape natural (and other) disasters rather than being trapped in big cities and forced to face possible death... and, of course, as is always in the very busy mind of Secret Agent Leo Wanta, the national defense.

What is this national high-speed rail system that is so high on Leo Wanta's list of things that America needs done so the Constitutional Republic can be restored? Is it something we should do? First, it's not a "should do" thing - it's a MUST DO because HSR will increase employment and the career opportunities - full-time, well-paid jobs with full benefits - will help stabilize economic recovery nationally, and do it quickly. Well, if it's done properly and is a privately-owned, national project rather than another cronyism project of either political party, economic recovery will stabilize nationally.

Building a high-speed rail system will cause local, state and federal tax revenues to stop their drop into oblivion. Is there a city or town that didn't think the gravy train would go on forever - and are suffering mightily from their over-spending and lack of saving for economic downturns? How many cities in California alone have gone bankrupt? That disease of bankruptcy has spread to Detroit - with Chicago next? How many municipal bonds are at risk as this is being written? Far more than you're hearing about is the answer to that question. Who do you think will be asked to pick up the tab for these failed cities?

**Other major nations have High Speed Rail including France, Japan and China.**

The rest of the world is passing America by in the world of transportation. This isn't about winning a competition, it's about increasing our capacity to produce and compete with other nations to sell American goods effectively both nationally and internationally. Japan implemented its first HSR train in the mid-1960s. On any given day in France, more than 450 high-speed rail trains are running. In France, they are known as TGV (Train à Grande Vitesse). French HSR offers about 150 destinations and the trains travel at 200 miles per hour. The TGV Atlantic carries over 40,000 passengers each day.

China has opened more than 42 high-speed rail lines and has the world's biggest train network, with 56,000 miles (91,000 kilometers) of passenger rail. Even with so much traditional and high-speed rail access, trains are overloaded with passengers and cargo.

Chinese rail technology dominates that nation's foreign diplomacy, extending the country's regional influence as well as addressing its growing energy demands. During this same time, US Transportation Secretary Ray LaHood played Tinker Toys with Amtrak, thinking he can hornswoggle the American people into accepting the equivalent of Amtrak's Acela line as "high-speed rail" - which it is not. The U.S. Government appears to want to charge American taxpayers for the larger costs of high-speed rail, but provide instead the same failed system that keeps Amtrak in the red by a billion plus dollars every year.

**Amtrak is old, inefficient, slow and is government owned and controlled.**

Amtrak is the National Railroad Passenger Corporation and it is 40 years old. It is government owned and controlled. It is Union operated and employs more than 20,000 workers and its CEO is appointed by the President of the United States... a political appointment. The Amtrak budget is allocated by Congress (and it is thus dependent upon its friendly relations with Congress - keeping elected officials happy for its existence - do I hear echoes of "cronyism" here?).

Does this sound like the best possible expertise source to build a new, high-tech rail project? Amtrak can't even run its own company in a business-like manner. In fiscal year 2010, Amtrak earned \$2.51 billion and expensed \$3.74 billion... a net \$1.2 billion loss. The Amtrak system is antiquated, bloated and inefficient and its total cost to taxpayers for its 40 years of service is \$50 billion.

Yet, Amtrak which has absolutely no experience in the world of high-speed rail is the expertise source selected by the Obama Administration. It was the expertise source for George W. Bush, too - and Bill Clinton and George H.W. Bush. Why? Remember those "set-aside allocations" we discussed above? Since Ronald Reagan left office, both elected politicians and unelected bureaucrats can control the goodies handed out by a government-controlled entity.

No cronyism would be allowed by President Reagan and his

Wanta and Ronald Reagan were determined there would be no set-aside allocations, no cronyism - no favors given to former college roommates to develop the Obamacare computer software, no \$520 million loan losses to Solyndra. He was a major Solyndra backer and was heavily involved in soliciting donations for Obama's 2008 presidential campaign. People talk about the cost of high-speed rail, but it is tens of billions less costly than the alternative - expanding highways and airports to accommodate population growth. And, the environmental advantages to HSR are phenomenal - far better than jets, buses and cars. People who think it's costly to build a high-speed rail system need to check with Boeing to find out the cost of building jet airplanes (that carry far fewer people) for the airline industry. Of course, the government doesn't own the airlines - yet - but wants to own high-speed rail. And the airlines don't want the competition of a well-run high-speed rail line and lobby effectively to prevent Lee Wanta from gaining access to his own funds that will make it possible for him to build such a system for the American people. 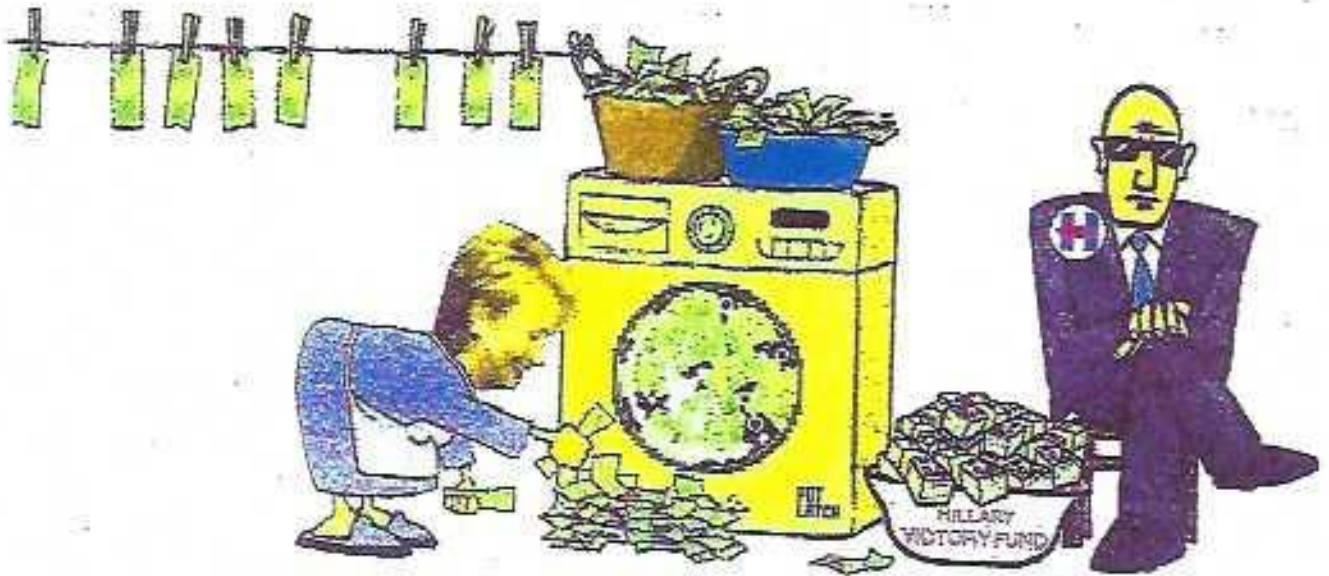

# 'I give you 24 hours to resign': 1st OPCW chief on how John Bolton bullied him before Iraq War

The first OPCW chief, who tried to bring Iraq and Libya into the organization, told RT how US foreign policy hawk **John Bolton threatened him over his refusal to resign prior to the 2003 Iraq War.**

**Jose Bustani, the first director-general of the global chemical weapons watchdog Organization for the Prohibition of Chemical Weapons (OPCW), sat down with RT and revealed how **John Bolton, a Bush-era official and now Donald Trump's pick for National Security Adviser, bulldozed the way for the 2003 Iraq invasion.****

**Bustani, a Brazilian diplomat, led the organization from 1997 until 2002, when he was ousted after falling out of favor with the US. At the time, he was trying to convince Iraq and Libya to join the organization, meaning that the two countries would have been obliged to dispose of all chemical weapons if they had any.**

**He said that according to reliable intelligence he had as director-general, *"it was obvious that during the first Iraq War everything had been destroyed [by Iraq],"* and there was *"nothing left for Iraq to be accused of possessing chemical weapons."***

In 2001, OPCW inspectors examined Iraqi facilities, and it was *"a successful operation,"* after which Bustani's informal dialogue with the Iraqis and Libyans about joining the organization made a breakthrough, he recalled.

**But diplomatic efforts and peacemaking did not sit well with Washington, because *"they had plans already to take some action – military action – against Iraq,"* Bustani claims. Shortly afterwards, the Bush administration began to aggressively lobby for his removal, and it became *"a tragic story"* for him, he said.**



*"I got a phone call from John Bolton – it was first time I had contact with him – and he said he had instructions to tell me that I have to resign from the organization, and I asked him why," Bustani told RT. "He said that [my] management style was not agreeable to Washington."*

He resolutely refused to resign, only to see Bolton again at OPCW headquarters in The Hague several weeks after the phone conversation. *"He came to my office and said: 'You have to resign and I give you 24 hours, this is what we want. You have to leave, you have to resign from your organization, director-general.'"*

Bustani said he *"owed nothing"* to the US, pointing out that he was appointed by all OPCW member states. Striking a more sinister tone, Bolton said: *"OK, so there will be retaliation. Prepare to accept the consequences. We know where your kids are."*

According to Bustani, two of his children were in New York at the time, and his daughter was in London. He told Bolton: *"My family is aware of what's going on, so [they're] prepared to face consequences."* The reply shocked Bolton, who then left the office.

On April 21, 2002, a special meeting was finally held in The Hague, and Bustani's **removal** was carried out by a vote of 48–7, with 43 abstentions. The diplomat said



those who abstained were from developing countries, and that his own government in Brazil *"left me behind."*

*"He's not a man you can have a dialogue with,"* Bustani said when asked about his opinion on the newly-appointed National Security Adviser. *"On the basis of my own experience, I don't believe that Mr. Bolton is capable of being a National Security Adviser to any government of the United States."*

Bolton, who was Under Secretary of State for Arms Control and International Security in the Bush administration from 2002-2004, and ambassador to the UN, *"has prejudices, he made a number of announcements that are worrisome,"* including on North Korea, Iran, and Syria.

The latter is critical, Bustani says, *"because it could be a new Iraq with much more serious consequences with impact on the whole Middle East today."*

*"And I believe that, as a result of the Iraqi invasion, for example, you have today Daesh [Arabic acronym for Islamic State (IS, formerly ISIS)] and... different fanatic Islamic movements" tearing the region apart.*

## What's Wrong with Trump's New National Security Advisor

Beyond the general concerns regarding the nomination of John Bolton as National Security Advisor, **there is also the specific issue of his impending access to the most highly classified intelligence information that the United States possesses.**

There are a number of reasons why Bolton should be denied a clearance, including his **well-known record of abusing subordinates** at State Department and colleagues at the United Nations. **Bolton also has a close personal relationship with Israel and its government that may have included divulging classified information.** The Israeli connection is particularly sensitive because Bolton is beholden to casino billionaire Sheldon Adelson, who has funded his activities since he left State Department in 2006. And Bolton knows how to return a favor, approving of Adelson's suggestion to detonate a nuclear bomb in the



Iranian desert, just to warn them what might be coming. Adelson, a major GOP donor, was displeased with Rex Tillerson and H.R. McMaster, and to have been instrumental in their removal. Both men supported the nuclear agreement with Iran and both are now gone. McMaster was also targeted as "anti-Israeli" for having opposed moving the US Embassy from Tel Aviv to Jerusalem.

**Bolton's regard for Israel has included unauthorized disclosure of classified information when he was Undersecretary of State for Arms Control and International Security. He collaborated with the Israelis, often without the State Department being aware of what he was doing, to justify a US attack on Iran. The strategy to bring about a war included diplomatic pressure, crude propaganda, and the production of fabricated evidence by Mossad.**

Bolton was technically under the supervision of Secretary of State Colin Powell, but he violated existing State Department regulations by **taking a series of secret trips to Israel in 2003 and 2004.** Thus, when Secretary of State Colin Powell was saying administration policy was not to attack Iran, **Bolton was working with the Israelis to lay the groundwork for a new war.** During a February 2003 visit, Bolton assured Israeli officials in private meetings that he had no doubt the United States would take down Saddam Hussein, before dealing with Iran and Syria.

During multiple trips to Israel, Bolton had unannounced meetings, including with the head of Mossad, Meir Dagan, without the usual reporting cable to the Secretary of State. Those meetings clearly dealt with a joint strategy on



how to bring about political conditions for an eventual US strike against the Iranians.

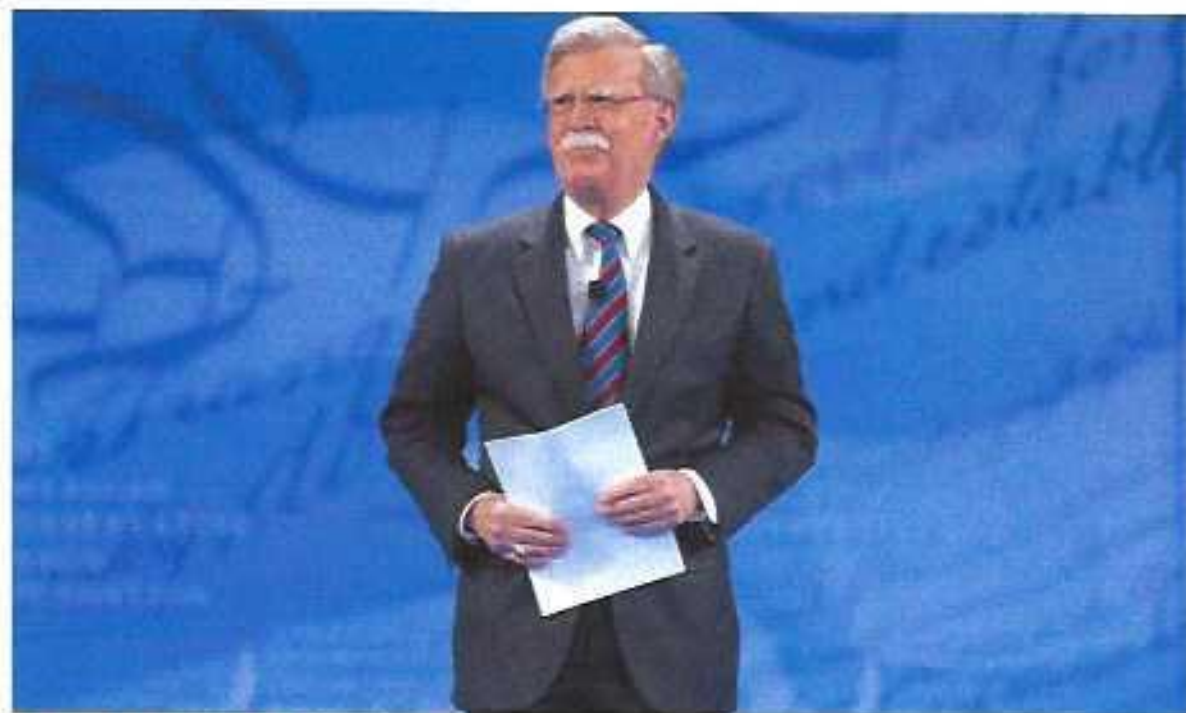
**John Bolton, while serving as US ambassador to the United Nations, also went behind his boss's back to supply Israel with crucial information on American plans at the U.N. so as to redirect US policy.** Dan Gillerman, who served as Israel's Ambassador to the U.N. in 2006 when Bolton was US ambassador has described how "in more than one case, **Ambassador Bolton called me and alerted me to the fact that his mission—the United States mission to the U.N.—was about to vote against Israel and asked that I alert the prime minister, who at that time was Ehud Olmert.** In more than one case the prime minister called the president, who was then George W. Bush, and got him to overrule the State Department."

**Bolton would regularly reach out to the Israelis to subvert positions being supported by the US government, as in August 2006 when the U.N. Security Council was considering Resolution 1701, with the purpose of ending a month-long war between Israel and Hezbollah in southern Lebanon. Bolton warned the Israelis what Secretary of State Condoleezza Rice was planning to support the initiative.** Gillerman reports that "In that case John Bolton got in touch with me at about 8 o'clock in the evening, which was 3 in the morning in Israel, calling to say '**You have to call your prime minister and tell him that Condi Rice sold you out to the French.**'"

**Given what John Bolton did when last in office, he should never again be allowed to have access to classified information since he would clearly abuse that**



**privilege to satisfy his own agenda.** That President Trump will undoubtedly grant Bolton access to all sensitive information is discouraging, particularly as the new Advisor, supremely sure of himself and possessing a proclivity to do what he considers expedient without regard for consequences, cannot be relied to do the right thing when it comes to national security. **He should never be granted a clearance to use top level intelligence and should never be placed in a position of authority that would permit him to do mischief.** Unfortunately, urging President Trump to reverse the Bolton decision because of the grave damage it will inevitably do to the United States is not likely to be received favorably by the White House.

## John Bolton: Trump's Volatile Neocon Surrogate in



## the White House

John Bolton, Donald Trump's choice to be the US National Security Adviser, has long been a surrogate for former Vice President Dick Cheney. In almost every sense, Bolton mirrors the war-hawk policies advocated by Cheney before, during, and after his stint as George W. Bush's vice president.

Bolton was the only US ambassador to the United Nations never to have been confirmed by the US Senate. George W. Bush took advantage of the Senate's recess to confer upon the extreme war-hawk a recess appointment. It was Bush's way of paying back Bolton for serving as one of the Bush campaign's disruptive attorney- surrogates during the 2000 Florida presidential vote recount.

Wherever Bolton sees a conflict in the world he, like Cheney, sees an opportunity for US military engagement. Bolton is a standard neo-conservative – someone who, like Cheney, dodged the Vietnam draft but is all-too-willing to commit US troops to foreign battlefields. While at the UN, Bolton and his openly gay assistant and diplomatic valet, Richard Grenell – tapped to be Trump's ambassador to Germany – were known for their constant inability to get along with other delegations, save for one, Israel. Bolton infamously got into heated arguments with the British ambassador over procedures and rules in the Security Council.

While an official in the Reagan administration's US Agency for International Development (USAID), Bolton, according to divorce papers served by his ex-wife, allegedly forced his wife to engage in group sex activities at New York's Plato's Retreat, a swingers' sex club, in the 1970s and 80s. A decade later, while an attorney for USAID contractor International Business & Technical Consultants Inc. (IBTCI), USAID, Bolton harassed a female USAID contractor who was working in Kyrgyzstan. According to the contractor, Melody Townsel, Bolton made her life miserable during their time together in Russia.

Townsel told the "Dallas Observer" in May 2005 the following about Bolton's antics: "[John Bolton] began chasing [me] through the halls of a Russian hotel – throwing things at me, shoving threatening letters under my door and, generally, behaving like a madman." Townsel added that this "went on for two weeks, during which time Bolton routinely visited me... to pound on the door and shout threats." Bolton also falsely told Townsel's colleagues that she "was under federal investigation for misuse of funds and that she was bound for federal prison." Townsel said Bolton made "unconscionable comments about my weight, my wardrobe... and my sexuality, hinting that I was a lesbian (for the record, I'm not)." "Time" magazine and the "Toronto Star" corroborated Townsel's version of events, even as right-wing propaganda mouthpieces like radio's Rush Limbaugh called her a liar. In a case of likes attracting one another, Bolton's sexist attitude toward women and his insulting demeanor toward subordinates are likely what first attracted Trump to the walrus-mustached former ambassador to the UN.

Former Secretary of State Colin Powell privately warned a few Republican senators during Bolton's confirmation hearing in 2005 that Bolton was not suited to be the American ambassador to the UN because his former top diplomat for arms control had problems with those who disagreed with him. Former chief of the State Department's Bureau of Intelligence and Research (INR) Carl W. Ford, Jr. was even blunter when he testified before the Senate Foreign Relations Committee that Bolton was a "quintessential kiss-up, kick-down sort of guy" and "a serial bully." In the end, the Senate – including Democrats and Republicans – could not



bring itself to confirm someone as unqualified and dangerous as Bolton for the UN post.

But Trump sees nothing wrong with Bolton as National Security Adviser. Bolton reportedly plans to conduct a purge of White House National Security Council staffers deemed by him to be disloyal to Trump and prone to leaking information to the media. However, when it comes to leaks, Bolton has several of his own in his dossier.

During the Bush presidency, while Bolton was still serving as Undersecretary of State for Arms Control and International Security, he is believed responsible for taking part in the leak of national security information from the INR and the Central Intelligence Agency.

In 2003, Bolton, who had virtually declared war on INR, was working closely with Vice President Cheney's staff, including Chief of Staff Scooter Libby, David Wurmser, and John Hannah, as well as Karl Rove, to craft propaganda justifying the war against Saddam Hussein in Iraq.

Bolton was part of the Bush administration cabal that outed the identity of CIA non-official cover (NOC) agent Valerie Plame Wilson and her Brewster Jennings & Associates cover firm. Plame's identity was disclosed by Bolton and his friends in retaliation for her husband, Joe Wilson, a former Deputy Chief of Mission in Baghdad and a former ambassador to Gabon, penning an op-ed in *The New York Times* that debunked Bush's spurious claim that Iraq received "yellow cake" uranium from Niger. By exposing Plame and Brewster Jennings, Bolton put into jeopardy NOCs around the world, agents who were critical to the CIA's clandestine missions, including identifying networks used for the trafficking of weapons of mass destruction (WMD).

Exposure by Bolton, Rove, Libby and others of the Brewster Jennings & Associates counter-WMD operation also resulted in the exposure of allied intelligence NOCs and private business assets working for British and German intelligence agencies, who were assisting the CIA in its efforts to counter the flow of WMDs. The foreign agents worked for Britain's MI-6 (Secret Intelligence Service) and MI5 (Security Service) and the German *Bundesnachrichtendienst* (BND). The German counter-WMD operation concentrated on the smuggling of nuclear material from the former Soviet central Asian states. The British agents, using "trading company" fronts, had close contacts with assets in Iran, North Korea, the United Arab Emirates, Libya, Ukraine, China, India, Pakistan, and Russia.

Bolton also misused National Security Agency intercepts for political purposes. As National Security Adviser, Bolton will have access to all-source intelligence, including NSA communication intercepts. In 2005, Senator Christopher Dodd (D-CT) revealed during Bolton's Senate Foreign Relations Committee UN ambassador nomination hearing that Bolton requested transcripts of 10 NSA intercepts of conversations between named US government officials and foreign persons. Later, it was revealed that US companies [also treated as "US persons" by NSA] were also identified in an additional nine intercepts requested by Bolton. The requests for NSA intercepts by Bolton were as suspicious as those requested more recently by Trump's son-in-law Jared Kushner, apparently for no valid reason other than curiosity or something more sinister.

The following NSA intercepts were among those requested by Bolton and his neo-con cabal in Cheney's office:

- ◆ Secretary of State Colin Powell and Deputy Secretary of State Richard Armitage and their conversations with their counterparts and officials around the world;



- ◆ Assistant Secretary of State for Near Eastern Affairs William Burns and his telephone conversations with International Atomic Energy Agency director general Mohammed el Baradei and Britain's top non-proliferation official William Ehrman (Bolton was frozen out of negotiations between Burns, Britain, and Libya over the stand down of the Libyan weapons of mass destruction program;
- ◆ Burns's conversations with Syrian Foreign Minister Farouq al Shara over charges by Bolton that Syria possessed WMDs and conversations between Burns and former chief UN Iraq weapons inspector Hans Blix;
- ◆ Various phone calls made by Chairman of the President's Foreign Intelligence Advisory Board Brent Scowcroft;
- ◆ US Special Envoy on North Korea Charles "Jack" Pritchard and his telephone conversations with US ambassador to South Korea Thomas Hubbard, Assistant Secretary of State for East Asian Affairs James Kelly, and Richard Armitage;
- ◆ New Mexico Governor Bill Richardson and his telephone conversations with Secretary of State Powell and North Korea's deputy UN ambassador Han Song Ryol [confirmed personally by Richardson to the author];
- ◆ Phone conversations between Senate Foreign Relations Committee Chairman Joseph Biden and his Iranian counterpart, Majlis foreign affairs chair Mohsen Mirdamad;
- ◆ Phone calls between Biden, his staff, and William Burns and Undersecretary of State for Political Affairs Marc Grossman;
- ◆ Former President Jimmy Carter's phone conversations with Cuban officials before and during his May 2002 trip to Cuba (Carter said he found no evidence to support Bolton's claims of Cuban biological weapons development).

Bolton's multiple requests for NSA "raw SIGINT" or signals intelligence evoked the following response from then-NSA director Michael Hayden in an internal NSA memo:

"(U) US law and policy present more serious issues. EO [Executive Order] 12333 recognizes that electronic surveillance is so intrusive that we have established very specific rules to prevent unreasonable intrusion into privacy. EO 12333 tells us that information derived from electronic surveillance is not to be shared unless two criteria are met: US person information has been minimized so as to uphold 4<sup>th</sup> Amendment protections from unreasonable search and the information provided is of inherent intelligence value.

(U//FOUO) Much of the above would delight many of *those who have been clamoring for more extensive access to our databases and other SIGINT derived information*. [Emphasis added] These folks usually couch such views in the form of a request for 'raw SIGINT'—a formulation that usually connotes little knowledge about our discipline and even less likelihood that any kind of sharing with them would lead to something useful!

(U//FOUO) When I press for an explanation of what these folks mean by 'raw SIGINT' (usually accompanied by an explanation on my part of our production processes: access, collection, processing, translating, analyzing, reporting), I'm finally told that what they really want are English language transcripts of intercepted communications. They often seem surprised when I



report that that usually that doesn't help us much in terms of dealing with the volume of modern communications and in fact would probably add to our workload. And to those who might have linguists in appropriate languages, I also point out that no one would be served by 'amateur night' with inexperienced analysts second-guessing our linguists about the meaning of guarded conversations in obscure dialects laced heavily with allegorical Koranic references and spoken by interlocutors who seem to easily confuse the 'is' with the 'ought to be.'"

Bolton represents the worst American diplomatic face that Washington ever displayed to the world. The Senate rejected him to be America's ambassador to the UN. The National Security Adviser position does not require Senate confirmation.
