# What Is the Truth About Leo Wanta?

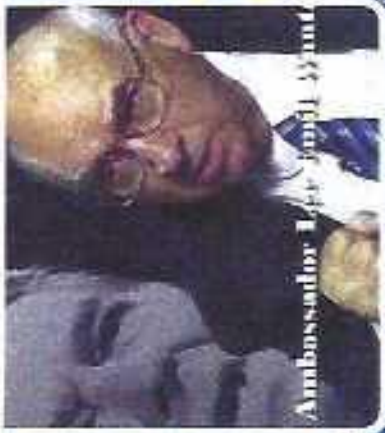

Washington, D.C. — Leo Wanta, whose purchase of huge sums in Russian rubles is credited with bringing down the Soviet Union in the Cold War, will be put through a third party lunacy test in Madison, Wisconsin circuit court on Tuesday. He has successfully been declared of sound mind in two previous lunacy tests under the Wisconsin state attorney general's office. His own attorney, James Shellow of Madison, Wis., is instituting this test. Shellow says that under the rules for attorneys in Wisconsin he has to notify the court that he thinks the lunacy test should be given. Shellow admits to being a former attorney for a deceased Mafia chief in Wisconsin named Belistiari. Shellow thinks Wanta will be declared sane in the upcoming hearing on Tuesday, but Shellow claims to know nothing as to how Wisconsin was able to extradite Wanta in chains and shackles from Switzerland, where he was doing business with Swiss banks after having given up his citizenship in Wisconsin. Wanta claims that he had just been made ambassador to Switzerland and Canada when Wisconsin state officials seized him bodily in Switzerland. Wanta claims that they took his briefcase from him at that time which contained billions in Treasury bills and Promise software technical equipment which the U.S. was using to get inside information about foreign treasuries.

Although the briefcase was taken by Wisconsin authorities in 1993, it has never been returned to Wanta nor has he any knowledge of what happened to its contents.

The charge is that he owed Wisconsin originally approximately \$14,000. He claims to have paid back that amount in 1992. The state attorney general's office seized his house worth \$120,000 and sold it for \$60,000, but there is no record of this in the Department of Revenue in Wisconsin nor is there any trace of the proceeds from the sale.

Wanta was buying rubles from Russia at the request of the President, Ronald Reagan. Wanta had worked at the White House, the National Security Council, the Central Intelligence Agency and six other government agencies during his career.

He and President George Bush set up the Ameritrust account in the Credite Suisse bank for the U.S. government to use in case it needed to counter terrorists from overseas, according to Pat Cameron, Los Angeles attorney for Wanta. Wanta says that when former president George Bush sought to withdraw funds from the \$210 billion on deposit that Wanta, a co-signer of the account, refused to give his signature for the withdrawal because the funds, he said, belonged to the U.S. government, not to an individual.

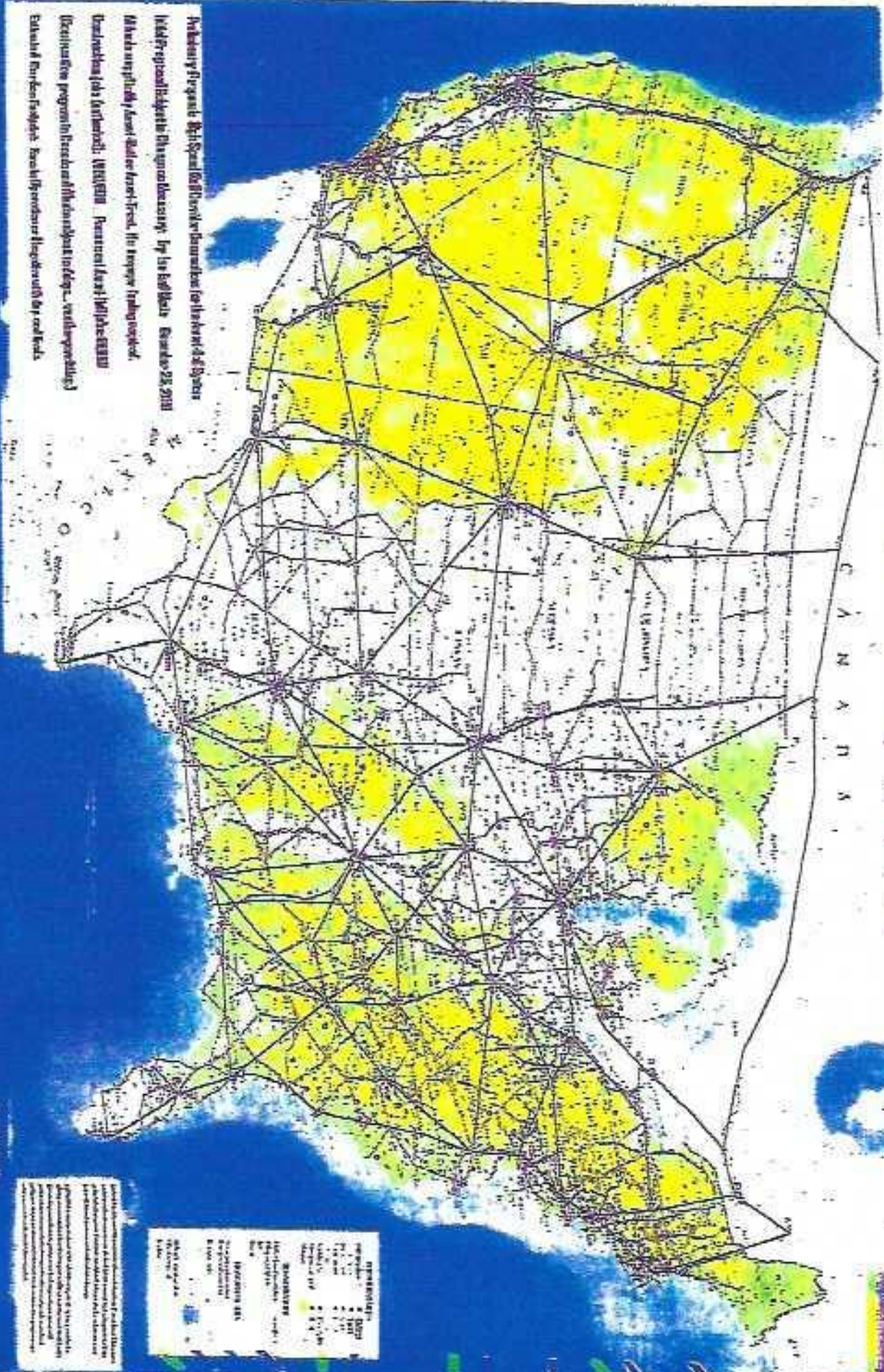

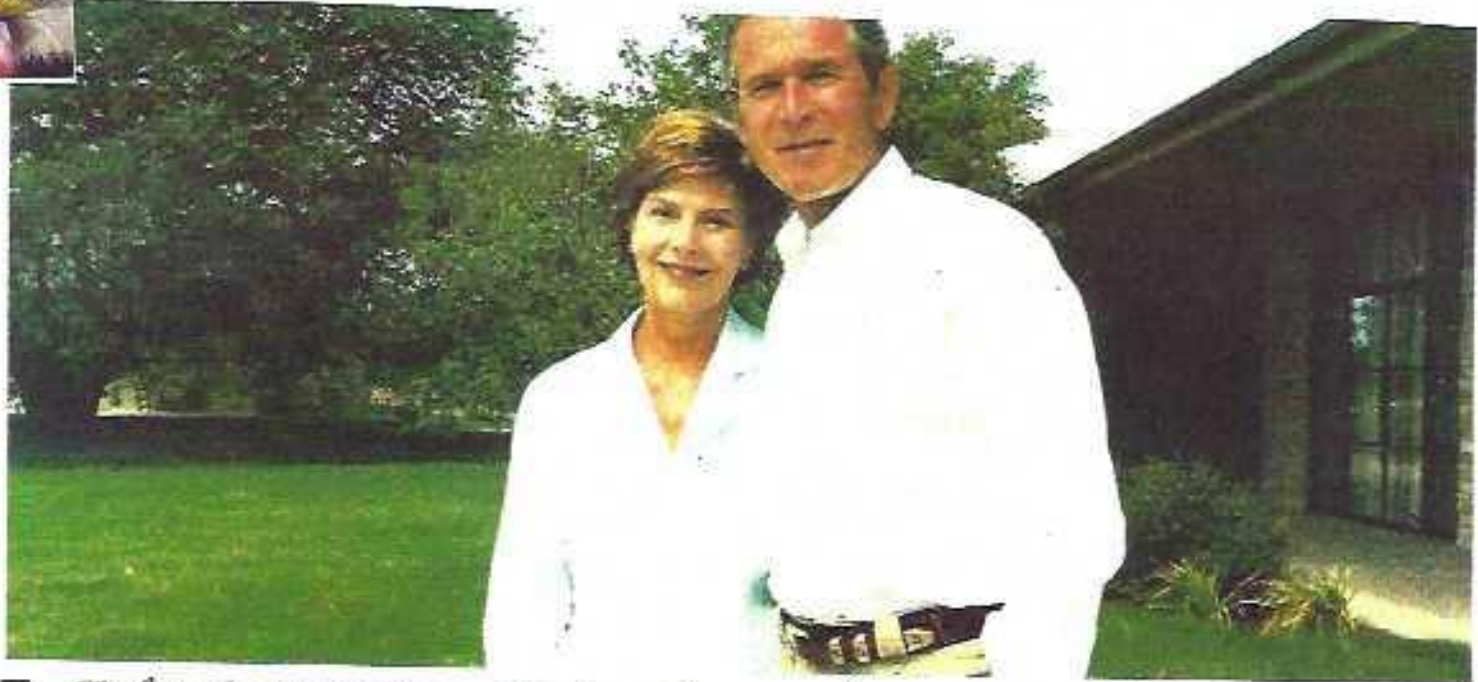

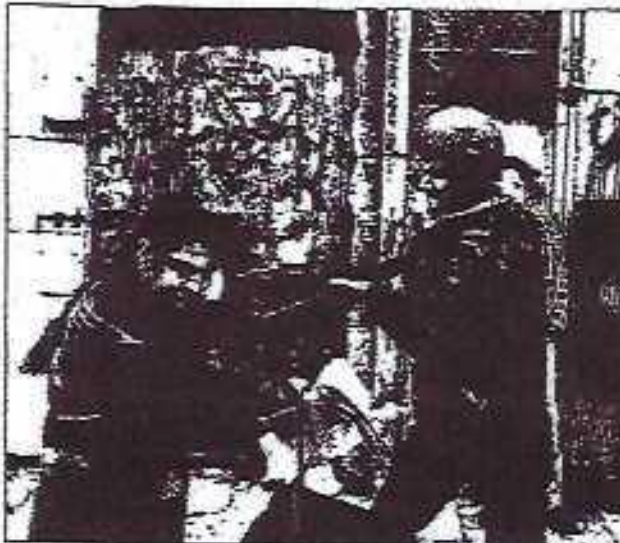
# Stuck in the Promised Land

Israel: With unrest rising, many settlers want out

**N**OT EVERYONE IN THE MIL-  
lions Jewish settlement of  
Kiryat Arba thinks it's the  
promised land. "We went be-  
cause of the money: it was  
cheap to get an apartment  
there," says Sarah Malul, who  
moved to Kiryat Arba 10 years  
ago. Malul and her husband,  
Avi, raising four children in  
a fearful place surrounded  
by enraged Palestinians, often  
thought of moving to Jerusa-  
lem. But they couldn't afford  
to. Then Ilanah Goldstein, a  
Kiryat Arba resident, gunned  
down 24 Muslim worshippers in  
nearby Hebron, and everything  
changed. "My 8-year-old said  
to me, 'I'm afraid the Arabs will  
kill me now,'" recalls Sarah.  
The Maluls demanded govern-  
ment help—and with a \$275  
monthly subsidy, they were  
able to rent a tiny apartment in  
Jerusalem. "I feel like a prisoner who has  
been freed," says Sarah.

Thousands of Jews living in other settle-  
ments deep in the Israeli-occupied West  
Bank and Gaza Strip want to get out, too.  
But it's not so easy. They were lured there  
by government offers of huge mortgages at  
rock-bottom rates, at a time when Israel's  
leaders wanted Jews to populate Arab  
lands captured in 1967. The settlers bought  
homes they could never afford in Israel  
proper. Yet now that Israel is preparing to  
trade land for peace, the same houses have  
pinged in value. "Many families want to  
leave," says Malul, who can't find a buyer  
for her apartment in Kiryat Arba. "But they  
don't have the money to make that choice."

The trick is to survive Palestinian stones,  
bullets and bombs until the government  
of Prime Minister Yitzhak Rabin offers  
compensation, then take the money and  
run. Settlers recall the precedent set at  
Yamit, the Sinai settlement returned to  
Egypt as part of the 1979 peace treaty. Then  
the government paid \$300,000 for each  
evacuated farm, and \$75,000 to \$150,000  
for other households that pulled up stakes.  
So far, however, Rabin has resisted pres-  
sure to offer a deal to the settlers  
in the West Bank and Gaza. "He doesn't  
want them to leave now because he's still  
negotiating," says Hagai Meiron, one of  
two Labor Party legislators running a hot  
line for settlers who want out. "Rabin  
says to himself: 'If they move now, the

Palestinians will think we are weak."

That approach has left many settlers feel-  
ing like pawns in an increasingly danger-  
ous game. Just last week the Islamic mili-  
tant group Hamas issued a warning to Jews  
living in certain West Bank and Gaza set-  
tlements: leave by March 15 or face in-  
creased attacks. The threat is not empty  
bluster. In February Hamas gunmen shot  
dead a pregnant woman who was traveling  
between Tel Aviv and the suburban-style  
settlement of Ariel. More recently, nervous  
Israeli soldiers killed an Ariel resident  
who was driving at night—they thought the  
settler was a Palestinian terrorist.

So far the government is providing only  
minimal assistance to help relocate low-  
income families desperate to get out. Esti-  
mates for the cost of fully compensating  
most of the 125,000 settlers range up to \$10  
billion. "Somebody will have to pay  
for it," says Meiron, who sug-  
gests that Saudi Arabia could  
help if settlements were used to  
house Palestinians in the fu-  
ture. Washington is another  
likely candidate. Israel just  
pledged in 1992 for \$10 billion in  
U.S. loan guarantees to help ab-  
sorb Jewish immigrants. Rabin  
hasn't asked to use the money  
for relocating settlers, but a  
U.S. official in Jerusalem says  
Washington "would be willing  
to examine such a proposal if  
it was raised."

But where will the settlers  
go? Avi and Sarah Malul moved  
from Kiryat Arba to an af-  
fordable apartment in Pisgat  
Ze'ev—a Jewish neighborhood  
built after 1967 in occupied East  
Jerusalem. Negotiations over  
the fate of Jerusalem aren't due  
to start for another two years or  
more. Meantime, bulldozers  
are hard at work in Pisgat

Ze'ev, a burgeoning neighborhood of  
30,000 Jews, clearing land for even more  
low-cost apartments. Until a final peace  
settlement is reached, nobody knows for  
certain where they can make a home, and  
who will pay the price.

## Rabin's Coalition: Where's the Beef?

**T**HE MIDDLE EAST PEACE PROCESS CLAIMED  
another casualty last week: numbing  
news. Israeli Prime Minister Yitzhak  
Rabin, trying to pursue a controversial  
peace policy with only a minority coalition  
in the Knesset, needed to entice the ul-  
tra-orthodox Shas bloc back into his ruling  
group. But Shas had a price for its support:  
legislation that would make the import of  
nonkosher meat. (Most Israelis don't care  
about the meat itself; the issue is part of the  
always heated struggle over how secular  
Israel should be.)

Rabin wanted to reinforce his Labor-led  
coalition ahead of his visit this week to  
Washington. The new meat bill is expected  
to become law this week despite oppo-  
sition by some leftists who found it unpal-  
atable. The Shas bloc will probably rejoin  
Rabin's government. That means the peace  
process, at least, may stay on the menu. ■

Figure A: "Return of Search Warrant" prepared and signed by Dennis M. Mengelt, Special Agent, Division of Criminal Investigation, Wisconsin Department of Justice, and dated 11th March 1994. It itemises the contents of Ambassador Leo Emil Wanta's diplomatic/sealed briefcase which was illegally seized from him by Swiss authorities on 7th July 1993. The diplomatic briefcase has never been returned to the Ambassador. Not listed among the effects found by Dennis M. Mengelt were 18 high-value US Treasury instruments which the Ambassador was carrying in the briefcase and which have disappeared. The briefcase has never been returned because, not least, when returned it would need to contain 100% of the items that were in the briefcase when it was illegally seized from him in Lausanne on 7th July 1993. Beyond this central fact, the diplomatic briefcase was sealed and it is not within the purview of officials serving a State of the United States to examine such briefcases. The search warrant signed by the local Dane County Circuit Court Judge was beyond the Judge's powers and represented another instance of the usurpation of Federal powers by the hyper-arrogant State of Wisconsin, which has no jurisdiction beyond its borders.



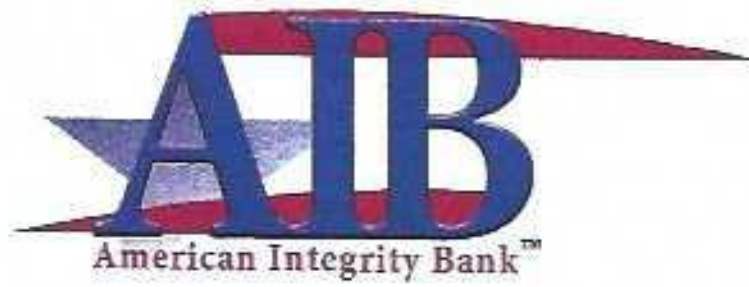

## Congress, White House strike Puerto Rico deal

### Bill would help restructure debt

WASHINGTON - House Republicans and Democrats reached a rare, election-year deal with the White House to try to rescue Puerto Rico from \$70 billion in debt as millions of Americans in the cash-strapped U.S. territory struggle with the loss of basic services.

A revised House bill introduced late Wednesday would create a board to help manage the territory's financial obligations and restructure some debt. Negotiations between the Obama administration and House Speaker Paul Ryan's office helped finalize the legislation.

It is a "big, but tough bipartisan

compromise," Treasury Secretary Jack Lew said.

Ryan, R-Wis., said the legislation would avoid a taxpayer bailout.

Puerto Rico, hit hard in a decade-long recession, already has missed several payments to creditors. A \$2 billion installment, the largest yet, is due July 1.

The island's businesses have shuttered, schools lack sufficient resources like electricity and some hospitals are limiting treatment of drugs. Puerto Rico's governor used a state of emergency this week to protect one public agency from lawsuits.

Further complicating Puerto Rico's outlook is the Zika virus, which has hit the territory of 3.5 million people hard. More than 700 cases have been reported. Zika can cause severe birth defects.

Like U.S. states, Puerto Rico cannot declare bankruptcy. The legislation would allow the controlled board to oversee negotiations with creditors and

the courts over reducing some debt.

The compromise "achieved a restructuring process that can work," House Democratic leader Nancy Pelosi said.

A vote could happen next week in the Natural Resources Committee. The panel's chairman, Rep. Rob Bishop of Utah, had to cancel a vote last month amid objections from both parties.

Bishop and Ryan have worked to win over conservatives who worry the rescue might set a precedent for financially ailing states. Democrats, too, had to be persuaded the control board wouldn't be too powerful and debt restructuring too difficult.

Some of the House's most conservative Republicans appear willing to support the deal. Republican Rep. Russ Labrador, R-Alaska, a native Puerto Rican and member of the fiscally conservative Stevedena Caucus, spoke favorably of the effort.
