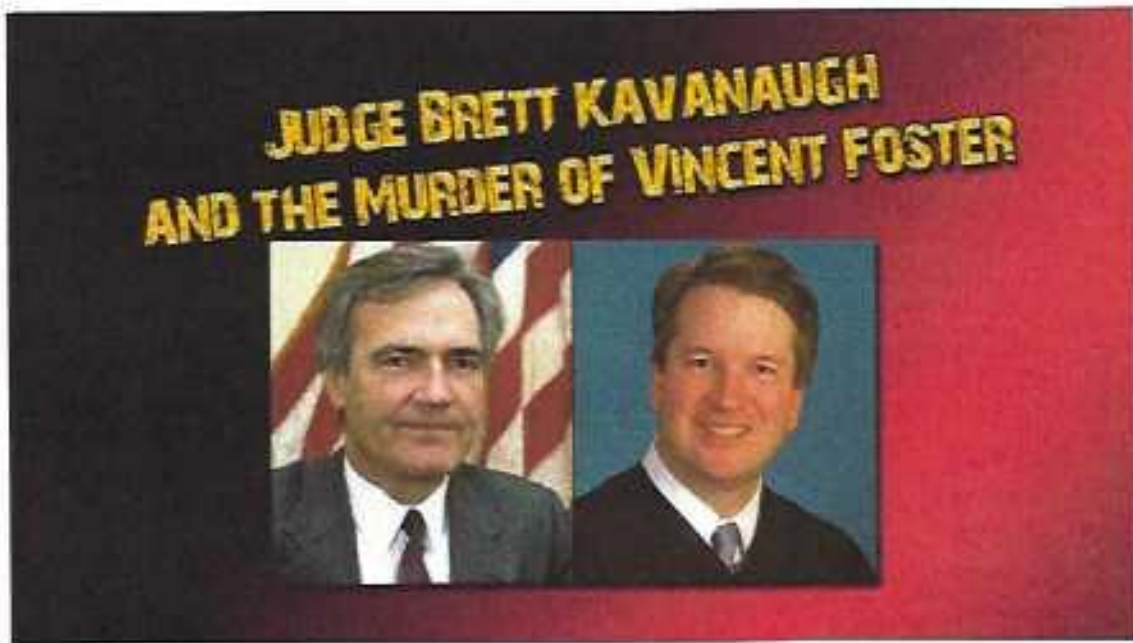

## Judge Kavanaugh's long Washington history gives Senate much to review

Judge [Brett M. Kavanaugh](#) has perhaps the longest Washington pedigree of any of the people who were on President Trump's short list for the Supreme Court, having worked at the highest levels of the White House under President George W. Bush.

He clerked for Justice Anthony M. Kennedy — the man he now seeks to succeed — and **served on special counsel Kenneth W. Starr's team in the 1990s.**

That long history will give the Senate plenty to review as it looks to confirm Judge [Kavanaugh](#) to the high court.

He has been through the process before, having won confirmation to the U.S. Circuit Court of Appeals for the District of Columbia on a 57-36 vote in 2006.

**His nomination process then was dominated by his record in the Bush administration.**

He has since added 12 years of service and more than 300 opinions on the appeals court.

Some social conservatives have worried that Judge [Kavanaugh](#), if he reaches the high court, would follow in the footsteps of Chief Justice John G. Roberts Jr., who is viewed as being among the more moderate of Republican-appointed justices.

But Justin Walker, a former clerk of both Justice Kennedy and Judge [Kavanaugh](#), said Judge [Kavanaugh](#) has authored a number of opinions defending religious liberty.

While on the D.C. Circuit, the judge ruled against upholding the Affordable Care Act's contraceptive mandate, upheld prayer before a presidential inauguration and said a court can begin sessions with "God save the United States and this honorable court."

Mr. Walker also said the judge is a staunch defender of the Second Amendment, dissenting in a case where he argued that originalism and the Supreme Court's precedent suggest Americans have the right to own a semi-automatic rifle.

"He has not been hesitant to take very strong stands in defense of conservative legal principles," Mr. Walker said.

But liberals point to a 2009 Minnesota Law Review article by Judge [Kavanaugh](#) that has come under scrutiny since he was picked as one of the president's front-runners to the Supreme Court.

**In the article, the judge contends presidents should be exempt from time-consuming investigations and litigation that distracts from national security issues and ill serve the public interest.**

With Mr. Trump's campaign under investigation for suspected collusion with Russian officials during the 2016 campaign season, the progressive Alliance for Justice argues that Judge [Kavanaugh](#) would not stand up to the commander in chief, citing his 2009 article.

**"Kavanaugh's personal writings show that he would allow Donald Trump's abuses of power to go unchecked," the organization said.**

Judge [Kavanaugh](#)'s recent ruling against an illegal immigrant teen seeking an abortion is also a point of contention for liberals because the case could likely come before the Supreme Court during the next term.

The teen, who was in government custody, demanded that the government facilitate the abortion by providing transportation and care afterward.

Judge [Kavanaugh](#) ruled against the teen, saying the government should have had more time to place the teen with a sponsor who could help with the abortion decision.

The full D.C. circuit overruled Judge [Kavanaugh](#)'s decision. He penned a dissent.

**A Yale graduate**, Judge [Kavanaugh](#) clerked for several federal judges.

The 53-year-old is married with two daughters and is an active member at his Catholic church.

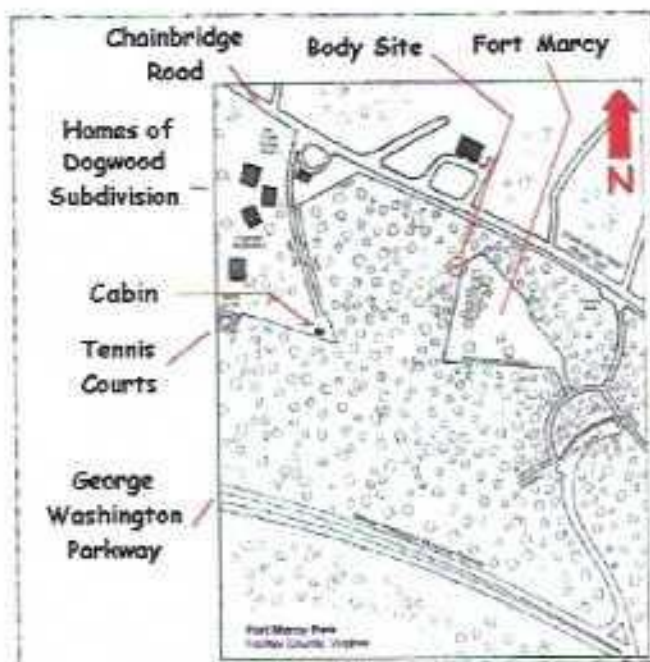

There is discussion of **Judge Napolitano** however, as a possible Attorney General when Trump finally decides to give Sessions the heve-ho. Former US Attorney **Anthony McCarthy** is another Giuliani would push to clean house at the Sessions-Rosenstein DOJ where cover up of the Clinton's and Obama's crimes seems to be first priority.

If Kavanaugh is the nominee, "this will be a very critical topic of questions from members of the Senate," said Stephen Thaler, professor of constitutional law at the University of Texas School of Law. "He is a staunch defender of executive prerogative. The question is how far he would go in cases really testing whether there is any limit to that theory."

Akhil Amar, a professor of constitutional law at Yale University and a friend of Kavanaugh, said his views were "not out of the mainstream or unusual."

"But it might appeal to a president who believes very much in presidential power because Brett Kavanaugh very much understands presidential power and respects it," Amar said.

Kavanaugh declined to comment.

Trump said Friday that he has narrowed his list of Supreme Court finalists to five candidates, including two women, and plans to announce his pick on July 9. Kavanaugh is among those believed to be a contender, one White House adviser said Friday.

The 38-year-old judge was not on Trump's original list of Supreme Court candidates released during the campaign, but the White House added his name in

When Kavanaugh was sworn in during a Rose Garden ceremony, Justice Kennedy administered the oath.

Since then, Kavanaugh has written nearly 300 opinions during his three years on the U.S. Court of Appeals for the D.C. Circuit, often supporting presidential power and legal restraint of government agencies.

Kavanaugh "has taken a very aggressive approach and would transfer a great deal of power to the president and withhold a good deal of power from administrative agencies," said Lisa Heinzel-Randle, a Georgetown University law professor who was a high-level Environmental Protection Agency official during the Obama administration.

A number of Kavanaugh's opinions litigiously into Trump's thinking.

Kavanaugh has been a leading defender of the government's position when it comes to prosecuting terrorism suspects through military commissions and taken a strict view of international law. He declared unconstitutional the structure of a consumer watchdog agency, finding it gave too much executive control to a "single unelectable, unelected director" in a decision rendered earlier this year by his colleagues.

When the court on which he serves struck a personal investment ban in federal courts to access abortion services, Kavanaugh objected, writing for the party that created a new right for abortion-related claims to "restrictive abortion on demand." And in one of many challenges to gun-control laws in the nation's capital, Kavanaugh said he would have struck down the city's regulations banning certain semi-automatic long guns.

Washington, D.C. — Leo Wanta, whose purchase of huge sums in Russian rubles is credited with bringing down the Soviet Union in the Cold War, will be put through a third party lunacy test in Madison, Wisconsin circuit court on Tuesday. He has successfully been declared of sound mind in two previous lunacy tests under the Wisconsin state attorney general's office. His own attorney, James Shellow of Madison, Wis., is instituting this test. Shellow says that under the rules for attorneys in Wisconsin he has to notify the court that he thinks the lunacy test should be given. Shellow admits to being a former attorney for a deceased Mafia chief in Wisconsin named Belistiari. Shellow thinks Wanta will be declared sane in the upcoming hearing on Tuesday, but Shellow claims to know nothing as to how Wisconsin was able to extradite Wanta in chains and shackles from Switzerland, where he was doing business with Swiss banks after having given up his citizenship in Wisconsin. Wanta claims that he had just been made ambassador to Switzerland and Canada when Wisconsin state officials seized him bodily in Switzerland. Wanta claims that they took his briefcase from him at that time which contained billions in Treasury bills and Promise software technical equipment which the U.S. was using to get inside information about foreign treasuries.

Although the briefcase was taken by Wisconsin authorities in 1993, it has never been returned to Wanta nor has he any knowledge of what happened to its contents.

The charge is that he owed Wisconsin originally approximately \$14,000. He claims to have paid back that amount in 1992. The state attorney general's office seized his house worth \$120,000 and sold it for \$60,000, but there is no record of this in the Department of Revenue in Wisconsin nor is there any trace of the proceeds from the sale.

Wanta was buying rubles from Russia at the request of the President, Ronald Reagan. Wanta had worked at the White House, the National Security Council, the Central Intelligence Agency and six other government agencies during his career.

He and President George Bush set up the Ameritrust account in the Credite Suisse bank for the U.S. government to use in case it needed to counter terrorists from overseas, according to Pat Cameron, Los Angeles attorney for Wanta. Wanta says that when former president George Bush sought to withdraw funds from the \$210 billion on deposit that Wanta, a co-signer of the account, refused to give his signature for the withdrawal because the funds, he said, belonged to the U.S. government, not to an individual.
