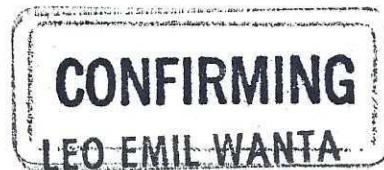

 A visit to Fort Marcy--built on President Lincoln's orders--takes one back to a critical period in our history when rivers of blood were spilled in order to preserve this unique experiment of ours--this government where justice would reign supreme, and no man, no group of men, no matter how powerful or highly placed, would be exempt from public accountability. With the "investigations" of the Park Police, the FBI, Fiske, and Starr, this tiny square of land may yet become the symbol of a cover-up conducted by people who have, with the help of the press, placed themselves above the law.

### TIMELINE OF EVENTS

#### 1993

##### January 20

William J. Clinton inaugurated forty-second president of the United States. Foster joins White House staff as deputy White House counsel.

##### January 23

Clinton withdraws his nomination of Zoe Baird for the post of attorney general. Shortly after, his second choice, Kimba Wood, is also withdrawn from consideration.

##### May 8

Foster gives commencement address at University of Arkansas.

##### May 19

Clinton administration fires longtime employees of the White House travel office.

##### June 4

Lani Gunier, Clinton's choice for assistant attorney general for civil rights, is withdrawn. She was vetted by Foster.

##### June 17

*Wall Street Journal* editorial, *Who is Vincent Foster?*, appears.

##### June 24

A second *Wall Street Journal* editorial entitled *Vincent Foster's Victory* appears.

##### July 3

White House management review of the travel office firing released. Associate counsel William Kennedy is criticized.

##### July 15

Senator Robert Dole calls for appointment of special counsel to investigate the travel office firings.

July 16

Foster and wife, Lisa, leave for weekend on Eastern shore of Maryland.

Freeh offered job as FBI director at White House meeting with Clinton.

July 17

Early morning meeting at Justice Department with FBI director William Sessions. Attorney General Reno, Nussbaum, and Hubbell tell Sessions to resign or be fired. Sessions refuses.

July 18

Foster calls Clinton attorney James Lyons. They agree to meet on Wednesday, July 21.

July 19

Hubbell meets with Chief of Staff McLarty to talk about Foster's state of mind.

Hubbell meets with Foster.

President Clinton fires FBI director William Sessions. Deputy director Floyd Clarke named acting director.

Clinton calls Foster at home and invites Foster to join him, Hubbell, and Bruce Lindsey for a private White House showing of the movie *In the Line of Fire*. Foster declines but agrees to meet Clinton on Wednesday.

July 20

Freeh nominated as FBI director at Rose Garden ceremony.

Foster makes repeated efforts to speak with William Kennedy by phone but fails.

Warrant issued for offices of David Hale's Capital Management Services in Little Rock.

Foster found dead at Fort Marcy.

July 21

Secret Service officer Bruce Abbott observes Craig Livingstone suspiciously carrying documents from the area of Foster's office.

Park Police investigators arrive at White House but are denied access to Foster's office or the right to conduct interviews.

Autopsy conducted on Foster by deputy medical examiner for Northern Virginia.

July 22

White House counsel Nussbaum conducts search of Foster's office.

Williams and counsel aide Thomas Castleton remove Clinton's papers from Foster's office and store them in closet located in Clinton's residential quarters.

July 23

Foster buried in Hope, Arkansas.

July 26

Associate White House counsel Stephen Neuwirth finds torn note in Foster's office briefcase.

July 27

Lisa Foster views note at 2:30 PM.

Susan Thomases and the Clinton's personal attorney Robert Barnett arrive at the White House. Barnett takes possession of the Clinton's personal papers that were found in Foster's office.

6:29 PM. Webster Hubbell arrives at White House residence and meets with Hillary Clinton. Susan Thomases is already in the residence. Both Hubbell and Thomases leave together at 8:20PM.

7:00 PM. Reno and Deputy Attorney General Philip Heymann arrive at White House and are informed of note.

8:00 PM. Park Police notified of note.

#### July 29

Park Police interview Lisa Foster for first time.

#### August 5

Park Police conclude investigation, rule death a suicide.

#### August 9

FBI concludes investigation into the torn note.

#### August 10

Justice Department press conference chaired by Heymann. Park Police chief Robert Langston and FBI special agent in charge for Washington Robert Bryant announce results of inquiries. Contents of torn note revealed to press. Officials decline to release Park Police report.

#### August 15

*Washington Post* reveals that Park Police report says that Nussbaum, Williams, and Thomasson conducted late-night entry into Foster's office on the night of the death.

#### August 16

Park Police hand-delivered the Colt revolver found in Foster's hand to the ballistics laboratory of the Bureau of Alcohol, Tobacco and Firearms. This is the first time the gun is tested.

#### December 20

*Washington Times* reports that Clinton aides removed Whitewater papers from Foster's office on night of death.

### **1994**

#### January 9

Senator Daniel Patrick Moynihan calls for appointment of special counsel to probe Whitewater.

#### January 20

Robert Fiske appointed special counsel by Janet Reno.

#### January 27

*New York Post* report by Christopher Ruddy details doubts of paramedics at the death scene about Foster's "suicide."

#### January 28

*Wall Street Journal* files lawsuit against the Justice Department for not releasing the Park Police report completed on August 5, 1993.

#### February 2

William Sessions issues a statement to *New York Post* that his firing by President Clinton "compromised" the FBI's role in the Foster death case.

#### February 23

Special Counsel Fiske's investigators begin interviewing first paramedics at the death scene.

#### March 5

White House Counsel Bernard Nussbaum tenders his resignation.

#### March 14

A page one *New York Daily News* story by Mike McAlary entitled *Case Closed* reports that Fiske had concluded Foster's death a suicide at the park.

Webster Hubbell offers his resignation as associate attorney general.

#### April 4



The FBI begins a search and "excavation" for the missing bullet at Fort Marcy.

*Wall Street Journal* story by Ellen Joan Pollock reports that Fiske has concluded Foster committed suicide.

#### May 9

Fiske's investigators interview Lisa Foster for the first time.

First significant FBI laboratory and forensic reports relating to death case completed. Others completed by mid-June.

#### June

A team of four independent pathologists reviews Foster case for Special Counsel Fiske.

#### June 30

Fiske releases his report on Foster's death, concluding that Foster killed himself at Fort Marcy.

President Clinton signs re-authorized Independent Counsel law.

#### July 29

Senate Banking Committee holds one day of hearings into Foster's death.

#### August 5

Three-judge panel created by newly authorized independent counsel statute selects Kenneth W. Starr as independent counsel. Fiske inquiry ends.

#### September

Starr hires Mark H. Tuohey III as Washington deputy, as well as assistant U.S. attorney Miquel Rodriguez to be lead prosecutor reviewing matters relating to Foster's death.

#### October

Prosecutor Russell G. Hardin resigns from Starr's Little Rock office over matters relating to Webster Hubbell.

#### December 6

Hubbell pleads guilty to fraud and tax evasion charges and agrees to cooperate with Starr.

#### December 13

Associate White House counsel Jane Sherburne writes White House "Task List" memo identifying White House concerns over scandals, including Foster's death.

### **1995**

#### January 3

Senate Banking Committee releases report agreeing with conclusions made by Fiske.

#### January 5

Starr's office begins grand jury proceedings into Foster's death.

#### January 6

A Scripps Howard wire story by Lisa Hoffman appears on the front page of *Washington Times* claiming that Starr has closed his review of Foster's death and has concluded the death a suicide.

#### March

Rodriguez and his assistant resign.

#### April 27

The Western Journalism Center releases report prepared by two former New York City police homicide experts. The report concludes that murder cannot be ruled out and Foster's body had been moved to the park.

#### May 3

Christopher Ruddy's story in *Pittsburgh Tribune-Review* reports that Rodriguez resigned over policy dispute in Foster case.

June

Starr hires O.J. Simpson defense expert Henry Lee and the San Diego medical examiner Dr. Brian Blackbourne to review Foster's death.

June 28

Hubbell sentenced to twenty-one months, of a possible ten-year sentence, for fraud and evasion charges. Starr admits Hubbell reneged on his agreement and failed to cooperate.

July

White House publishes and distributes a 331-page file called "Communication Stream of Conspiracy Commerce." The file deals largely with issues pertaining to Foster's death.

July 6

House Speaker Newt Gingrich publicly states there will be hearings on Foster's death.

July/August

Senate Banking Committee now chaired by Senator D'Amato holds hearings into actions of White House aides involving Foster's office.

August 14

Senator D'Amato publicly states that questions remain on the Foster death.

August 22

Dr. Lee testifies as defense expert for O.J. Simpson.

September 1

Starr's deputy Mark Tuohey resigns and joins Washington law firm representing the Rose Law Firm before Starr's office and Congress.

September 3

Profile of Lisa Foster appears in *The New Yorker*. Lisa states that she accepts official conclusions.

Mid-September

Starr begins two-month FBI search for the bullet at Fort Marcy Park.

October 8

Mike Wallace segment on *60 minutes* reports the Foster case is closed.

October 22

Ambrose Evans-Pritchard reports in the London *Sunday Telegraph* that Fort Marcy witness Patrick Knowlton claims the FBI falsified his testimony in their report.

October 25

Strategic Investment and James Dale Davidson hold press conference announcing the findings of three handwriting experts that the torn note is a forgery.

December

Banking Committee threatens to hold White House in contempt for not turning over notes written by William Kennedy.

**1996**January 1

Lisa Foster marries U.S. District Court Judge James Moody, a Clinton appointee.

March

Starr hires Memphis federal prosecutor Steve Parker to review Foster death case.

March 25

Starr's most cooperative witness, David Hale, pleads guilty to lying to the SBA and is sentenced to twenty-eight months, of a possible fifty-seven month sentence. Hale receives stiffest sentence to date for any sentenced in the scandal.

April 21

*New York Times* reports that Starr will soon be releasing report concluding Foster committed suicide.

May 28

Little Rock jury convicts Jim and Susan McDougal and Arkansas governor Jim Guy Tucker of bank fraud and conspiracy charges.

July

Internal Revenue Service begins audit of the Western Journalism Center.

July 28

*60 Minutes* re-airs October 1995 segment on Foster. Wallace states that Starr will issue report closing the case by the end of the summer.

October 22

*USA Today* reports that Starr's Foster report delayed due to "several unforeseen complications."

November 5

Clinton reelected to second term.

November 12

Witness Patrick Knowlton files suit in federal court alleging the government violated his civil rights.

November 21

Hubbell appears before Starr's grand jury in Little Rock, which begins investigating various payments made to Hubbell shortly before he signed a plea agreement with Starr's office.

December 2

Starr appears on *Newsweek* cover and gives exclusive interview. Magazine reports Starr had concluded Foster killed himself at Fort Marcy.

December 4

*Washington Post* reports that James Carville has launched a grassroots campaign "to discredit Kenneth W. Starr."

**1997**

February 13

Hubbell exits prison after seventeen months and defiantly says he will not cooperate with Starr or inquiries into campaign financing abuses.

February 17

Pepperdine University announces Starr will step down as independent counsel by August 1 to become dean of its law school.

February 21

Starr says he made a mistake by giving a resignation date of August 1 and will stay on as independent counsel.

February 23

Jack Nelson reports in *Los Angeles Times* that Starr had completed a "voluminous report" on Foster's death, concluding suicide.

April 25

Court of Appeals for the Eighth Circuit rules against White House claims of attorney-client privilege involving notes taken by government lawyers assisting Hillary Clinton.

May 12

White House appeals circuit court ruling to Supreme Court.

June 23

Supreme Court refuses to hear Clinton administration appeal on notes made by government lawyers during their conversations with Hillary Clinton.

### **VINCE FOSTER'S LAST DAY**

**July 20, 1993**

**8:00 AM**

Foster leaves home for work. Drives daughter to work and son to Metro station.



9:00 AM

Foster attends counsel's office daily staff meeting.

9:27 AM

Foster attends Rose Garden ceremony. President Clinton introduces Louis J. Freeh, his nominee for the directorship of the FBI.

9:40 AM

Rose Garden ceremony ends.

9:50 AM

Deborah Gorham states Foster arrived at counsel suite.

10:30 AM

Foster leaves his office for unknown location.

Approx. 11:30 AM

Foster returns to the office and stops in at Nussbaum's office. Nussbaum offers congratulations for the apparent success of the nominations of Louis Freeh and Ruth Bader Ginsburg to the Supreme Court.

12:00 PM

Linda Tripp, Nussbaum's assistant, says that Foster asked her to get his lunch from the White House cafeteria.

Approx. 12:30 PM

White House claims Foster eats lunch in office.

1:00 PM

Foster leaves White House counsel's office.

Approx. 1:00 PM

Secret Service officer John Skyles sees Foster exit West Wing. Last sighting of Foster alive.

Approx. 4:30 PM

Motorist Patrick Knowlton drives into Fort Marcy's parking lot and sees dark brown Honda with Arkansas plates.

Approx. 5:15 PM

A couple, identified as Mark and Judy, drive a white Nissan into Fort Marcy's lot. The couple observes two men in and around the Honda.

5:30 PM

Confidential Witness claims he entered the parking lot driving a white utility van. Witness said he found Foster's body in front of the second cannon. Witness then drove to nearby parkway headquarters to notify authorities.

5:59 PM

Park service employee Francis Swann calls Fairfax County 911 notifying them of a possible dead body in Fort Marcy.

6:03 PM

Swann makes second call to Park Police.

6:10 PM

Fairfax Fire and Rescue personnel and Park Police officer Kevin Fornshill arrive at Fort Marcy.

Approx. 6:15 PM

Dead body located in Park. Fornshill radios Park Police headquarters and notifies them of a "suicide" in the park.

Approx. 6:30 PM

Park Police investigators and supervisors begin to arrive at park.

6:37 PM

Fairfax personnel leave park to return to firehouse.

7:40 PM

Fiske reported that Dr. Donald Haut, the medical examiner, arrived at Fort Marcy Park to view the death scene.

8:02 PM

Fairfax ambulance arrives at park to pick up body and bring it to morgue.

8:17 PM

Ambulance leaves Fort Marcy.

8:30 PM

White House claims that Secret Service is first notified of Foster's death.

Ambulance arrives at Fairfax Hospital.

Hillary Clinton's plane makes unscheduled stop in Little Rock returning to Washington from West Coast trip.

Approx. 8:45 PM

Park Police investigators Cheryl Braun and John Rolla clear scene at Fort Marcy and exit park.

8:45 PM

Park Police "Evidence/Property Control Receipt" shows police investigator Braun retrieved two rings of keys from Foster's front pocket. (Braun states she was at morgue at the time.)

9:00 PM

President Clinton appears on CNN's *Larry King Live* program from White House Library.

Approx. 9:00 PM

Senior White House aides claim to be first notified of the death.

Between 9:00 and 10:00 PM

Craig Livingstone and William Kennedy identify Foster's body at morgue.

Park Police investigators Rolla and Braun drive to morgue to retrieve Foster's car keys.

9:25 PM

Foster's Honda towed from Fort Marcy Park.

9:45 PM

White House claims Hillary Clinton first notified of death.

9:55 PM

White House claims it confirmed Foster was dead.

10:00 PM

Clinton leaves King program, takes elevator to White House residential quarters. Mack McLarty informs Clinton of Foster's death.

Park Police arrive at Foster's Georgetown home and notify family of death.

10:13 PM

Hillary Clinton calls Maggie Williams and informs her of death.

10:45 PM

Nussbaum arrives at White House counsel's suite.

10:48 PM

Patsy Thomasson arrives at White House. Thomasson, Nussbaum, and Williams enter Foster's office. Williams observed by Secret Service officer Henry O'Neill exiting Foster's office with documents.

11:00 PM

Clinton arrives at Foster home.



11:41 PM

Officer Henry P. O'Neill sets security alarms in the White House counsel's suite after Thomasson, Nussbaum, and Williams have left.

11:45 PM

Clinton leaves Foster home.

#### WHITE HOUSE NOTIFICATION TIMELINE

1:00 PM

Foster last seen alive exiting White House West Wing.

Approx. 5:45 PM

Confidential Witness claims he discovered Foster's body in park.

5:59 PM

Park service employee Francis Swann calls Fairfax County 911 to notify them of a possible dead body.

Approx. 6:00 PM

Arkansas Trooper Larry Patterson arrives in his Little Rock apartment and receives a phone call from Trooper Roger Perry informing him of Foster's death. Patterson said the call came no later than 6:00 PM EST.

6:03 PM

Swann, after calling 911, hangs up and notifies Park Police.

Approx. 6:15 PM

Body of unknown male found in Fort Marcy Park. Park Police officer transmits radio call of "suicide" in park.

Approx. 6:35 PM

Paramedics return from death scene to parking lot. Paramedic Richard Arthur claims he saw Park Police entering Foster's car in search of identification.

6:40 PM

Fairfax Fire and Rescue workers exit park to return to station house.

Approx. 6:45 PM

Fairfax Fire and Rescue workers arrive at station house. Rescuers report to station supervisor Lieutenant William Bianchi that a White House official was found dead in park.

7:00 PM

Latest possible time former state police commander Lynn Davis claims he was notified of Foster's death by Trooper Perry.

Approx. 7:00 PM

Park Police senior investigator Cheryl Braun claims she first entered Foster's Honda in search of identification. She claims she was still unaware of deceased's name. After finding Foster's White House identification, Braun asks Lieutenant Watson to call shift commander Lieutenant Gavin to notify him of death.

Approx. 7:15 PM

According to a *New York Post* report, White House administrative chief David Watkins is paged at Georgetown theater and notified of death.

Approx. 7:30 PM

Braun discovers that Lieutenant Gavin was not called by Watson. She calls Gavin herself to notify him of Foster's death.

Approx. 7:40 PM

Gavin calls White House and notifies Secret Service of Foster's death.

Approx. 7:50 PM

Deputy Chief of Staff Bill Burton calls Gavin to confirm death.

8:00 PM

Latest possible time Trooper Roger Perry claims he was notified of Foster's death by Helen Dickey at the White House. Perry says likely came earlier.

Approx. 8:00 PM

According to grand jury testimony, Gayle Kennedy, put her two children to bed when call came notifying her husband William Kennedy of Foster's death.

Approx. 8:15PM - 8:30PM

According to his FBI statement, William Kennedy first was called by Craig Livingstone and notified of Foster's death.

Approx. 8:30 PM

Lead Park Police investigator testified under oath that for the first time he enters Foster's Honda in search of Foster's identification and only then was White House notified.

8:30 PM

According to a Secret Service memo and the White House, this is the exact time when the Park Police in the person of Lieutenant Gavin first notified the White House of Foster's death. According to the Secret Service, the first official notified by the Secret Service was David Watkins sometime after 8:30.

Approx. 8:45 PM

CNN makeup artist preparing president for *Larry King Live* overhears the president being informed about the finding of a document in Foster's office.

9:00 PM

*Larry King Live* begins.

Approx. 9:05 - 9:15 PM

Senior White House aides, including McLarty, Lindsey, Livingstone, and Gearan, first claim they learned of Foster's death.

9:55 PM

White House claims that Livingstone and Kennedy made positive identification of Foster at morgue.

10:00 PM

Clinton departs King program and takes elevator to residential quarters. Once there, McLarty informs him of Foster's death.

10:06 PM

Dickey claims she made call to her father, after which she called Arkansas governor's mansion and spoke to Perry informing him of death.

Washington, D.C. --- Leo Wanta, whose purchase of huge sums in Russian rubles is credited with bringing down the Soviet Union in the Cold War, will be put through a third party lunacy test in Madison, Wisconsin circuit court on Tuesday. He has successfully been declared of sound mind in two previous lunacy tests under the Wisconsin state attorney general's office. His own attorney, James Shellow of Madison, Wis., is instituting this test. Shellow says that under the rules for attorneys in Wisconsin he has to notify the court that he thinks the lunacy test should be given. Shellow admits to being a former attorney for a deceased Mafia chief in Wisconsin named Belistiari. Shellow thinks Wanta will be declared sane in the upcoming hearing on Tuesday, but Shellow claims to know nothing as to how Wisconsin was able to extradite Wanta in chains and shackles from Switzerland, where he was doing business with Swiss banks after having given up his citizenship in Wisconsin. Wanta claims that he had just been made ambassador to Switzerland and Canada when Wisconsin state officials seized him bodily in Switzerland. Wanta claims that they took his briefcase from him at that time which contained billions in Treasury bills and Promise software technical equipment which the U.S. was using to get inside information about foreign treasuries.

Although the briefcase was taken by Wisconsin authorities in 1993, it has never been returned to Wanta nor has he any knowledge of what happened to its contents.

The charge is that he owed Wisconsin originally approximately \$14,000. He claims to have paid back that amount in 1992. The state attorney general's office seized his house worth \$120,000 and sold it for \$60,000, but there is no record of this in the Department of Revenue in Wisconsin nor is there any trace of the proceeds from the sale.

Wanta was buying rubles from Russia at the request of the President, Ronald Reagan. Wanta had worked at the White House, the National Security Council, the Central Intelligence Agency and six other government agencies during his career.

He and President George Bush set up the Ameritrust account in the Credite Suisse bank for the U.S. government to use in case it needed to counter terrorists from overseas, according to Pat Cameron, Los Angeles attorney for Wanta. Wanta says that when former president George Bush sought to withdraw funds from the \$210 billion on deposit that Wanta, a co-signer of the account, refused to give his signature for the withdrawal because the funds, he said, belonged to the U.S. government, not to an individual.

Hubbell meets with Foster.



President Clinton fires FBI director William Sessions. Deputy director Floyd Clarke named acting director.

Clinton calls Foster at home and invites Foster to join him, Hubbell, and Bruce Lindsey for a private White House showing of the movie *In the Line of Fire*. Foster declines but agrees to meet Clinton on Wednesday.

#### July 20

Freeh nominated as FBI director at Rose Garden ceremony.

Foster makes repeated efforts to speak with William Kennedy by phone but fails.

Warrant issued for offices of David Hale's Capital Management Services in Little Rock.

Foster found dead at Fort Marcy.

And Foster's car and his car keys were not at Fort Marcy Park.

And the FBI contacted the Secret Service about their planned Foster death investigation at the White House.

And the Foster family is interviewed by police for over an hour and everyone says he was not depressed or taking medication.

#### July 21

Secret Service officer Bruce Abbott observes Craig Livingstone suspiciously carrying documents from the area of Foster's office.

Park Police investigators arrive at White House but are denied access to Foster's office or the right to conduct interviews.

And FBI agents were first to arrive at the White House on July 21st and FBI agents removed evidence from Foster's desk before the locks were changed. FBI agents also conducted interviews in the Old Executive Office Building on the White House campus which is where the majority of the White House Counsel's offices are located including William Kennedy and Craig Livingstone.

Autopsy conducted on Foster by deputy medical examiner for Northern Virginia.

And the autopsy was moved up and began before the police arrived in violation of Standard Operating Procedure. The tongue, neck wound, and official entrance wound were removed before police arrived. X-ray results were explained to police but then officially did not turn out and also were not taken(?)

#### July 22

White House counsel Nussbaum conducts search of Foster's office.

Williams and counsel aide Thomas Castleton remove Clinton's papers from Foster's office and store them in closet located in Clinton's residential quarters.

#### July 23

Foster buried in Hope, Arkansas.

#### July 26

Associate White House counsel Stephen Neuwirth finds torn note in Foster's office briefcase.

#### July 27

Lisa Foster views note at 2:30 PM.

Susan Thomases and the Clinton's personal attorney Robert Barnett arrive at the White House. Barnett takes possession of the Clinton's personal papers that were found in Foster's office.

6:29 PM. Webster Hubbell arrives at White House residence and meets with Hillary Clinton. Susan Thomases is already in the residence. Both Hubbell and Thomases leave together at 8:20PM.

7:00 PM. Reno and Deputy Attorney General Philip Heymann arrive at White House and are informed of note.

8:00 PM. Park Police notified of note.

And July 28 the NY Times prepares the next day edition with a story from an anonymous source that Foster was taking medication for depression. Thus the NYT knew this before the police, FBI or the WH ???
