## THE CIA'S MERLIN OPERATIONAL MODEL

On 23rd December 2006, the United Nations Security Council unanimously approved an amended European draft resolution calling for a ban on trade with Iran in goods related to its nuclear and ballistic missile programmes. The draft text ordered all countries to prohibit the supply of specified materials and technology which could be used in these operations. An annexe to the draft listed individuals and organisations involved in nuclear armaments and missile programmes which were to have their assets frozen. On the very same day, the Iranian régime led by the intelligence operative serving as Iran's President, Mahmoud Ahmadinejad, said that it would massively upgrade its uranium enrichment capabilities. Mohammed Ali Hosseini, the Foreign Ministry spokesman, stated that Tehran would implement its plans to install and bring onstream 3,000 uranium enrichment centrifuges located at the central Iranian city of Natanz, where 164 centrifuges are currently operational. But this stand-off has a revealing and disturbing history. In 2000, the CIA used a Russian nuclear scientist 'defector' from the old Arzamas-16 nuclear weapons plant to convey nuclear weapons trigger blueprints to the Iranian Mission to the I.A.E.A. located in Vienna.

### NORTH KOREA RECEIVES \$75 MILLION

On 11th October 2006, just two days following its nuclear weapons test, the North Korean Communist régime received \$75 million of US intelligence 'Black Ops' funding. The payment was facilitated and authorised by the Bush II White House.

Its purpose? To say 'thank you'. *Unspoken*: 'You are doing an excellent job in furthering our 'hidden' covert global dialectical strategic deception objectives, as we push full-speed ahead towards the realisation of our remit to set up controlled antagonisms and divisions around the world, in pursuit of our Illuminati global hegemony blueprint'.

These of course are being furthered by the contrived stand-off between radicalised Islam and the 'United States of Israel', in conformity with the blueprint for the 'third global calamity' developed by the nineteenth century Illuminati Magus, Albert Pike, who was possessed, as is quite obvious from reading his demonic work *'Morals and Dogma of the Ancient and Accepted Scottish Rite of Freemasonry, Prepared for the Supreme Council of the Thirty-Third Degree (Mother Council of the World) for the Southern Jurisdiction of the United States and published by its Authority, entered according to Act of Congress in the year 1871, by Albert Pike himself, In the Office of the Library of Congress, at Washington, and Entered according to Act of Congress in the year 1906, by The Supreme Council of the Southern Jurisdiction, A.A.S.R.U.S.A., in the Office of the Librarian of Congress, at Washington'*.

orchestrated from the Dachau HQ, which is the primary contemporary locus of the Nazi Pan-German *Abwehr* (counterintelligence) *apparat* and also the primary continuum of the Gehlen Organisation – all of which is carefully exposed, with voluminous source references, in *'The New Underworld Order'*.

It was the Pan-German *Abwehr* which developed the quasi-masonic Muslim Brotherhood after the Pan-Germans had been defeated in the First World War, to undermine British influence (of which they were insanely jealous) in the Middle East. Without labouring the point here, the most important exposé of the Illuminati – the classic work entitled *'Proofs of a Conspiracy'* published in 1798 by Professor John Robison, of Edinburgh University, explained that 'Weishaupt had long been scheming for the establishment of an Association or Order, which, in time, should govern the world'.

The Pan-German hegemonists have systematically used the scourge of the Illuminati (as explained in *'The New Underworld Order'*) as cover for their idolatry: control of the whole world. They naturally saw the parallel idolatry of the British as a dangerous threat to their long-range plans and, being (as Germans) permanently unable to accept defeat – just as George Bush II (of German extraction, originally, being in fact a Scherff) is unable to contemplate the reality that his disastrously ill-advised and reckless adventure in Iraq has been a catastrophe – they have 'continued the war by other means' (Lenin) ever since. Having successfully infiltrated the feckless British establishment, weakened by the massive loss of manhood in the First World War, and having undermined British will and control throughout the world, the Pan-Germans have applied the identical mentality to the other key component of 'the Main Enemy', the United States. They have done this by means of long-range infiltration (going back many generations) and, most recently, by placing their *agentur* in the highest official posts, such as that of the Presidency and the Director of Central Intelligence. Specifically, the Pan-German *Abwehr* chief, Admiral Canaris, was not hanged naked at Flossenbürg on 9th April 1945, as promulgated by the Nazi underground propaganda *apparat* from the German Geopolitical Centre in Madrid, but melted into the Nazi diaspora – surfacing in the later 1940s along with a large cadre of 'former' Nazis, who made their headquarters in unsuspecting Oklahoma City.

It is there that David Boren, a 'right-wing' former legislator who had to resign because of paedophilia allegations and then moved seamlessly into the top slot at Oklahoma University, presided over the secret that the files for this Nazi cadre were held in the Murrah Building, scene of the 'Oklahoma Bombing' in 1995. At the head of this cadre, and of the entire Nazi Continuum apparatus, was none other than Admiral Canaris, who had long since adopted the

assumed name of **Samuel Randall Pittmann**, and who travelled freely between the United States and Germany under that assumed name.

When Canaris-Pittmann fell ill in 1974, his place was assumed by Dr Henry ('Henny') Kissinger, a multiple agent whose well-known Soviet codename BOR belies the fact that he is a Deutsche Verteidigungs Dienst (DVD) operative. Dr Kissinger, in turn, persuaded President Ford (a.k.a. the pornographer Leslie Lynch King Jr.) to dismiss William Colby, the incumbent Director of Central Intelligence, and to replace him with George H. W. Bush Sr. (not his real family name, which is Scherff), both as DCI and in his capacity as 'successor' to Canaris and Kissinger at the head of DVD, Dachau.

It has since become clear that the East German intelligence service, STASI, has provided the DVD with long-range cover, and that key STASI operatives – such as the recently deceased Marcus Wolf, and the STASI operative who has intermingled with US intelligence, the Hungarian operative Eva Teleki – were/are DVD agents, working in accordance with the Nazi Continuum's two primary themes:

1. *'Für uns, ist der Krieg niemals vorbei'* ('For us, the war never ended'); and
2. *'We intend to build the Thousand-Year Reich on the ruins of the United States'*.

Authority for the above will be found (a) among documents seized from the Nazis by the Allies in 1945, and (b) in the text of the so-called *'Madrid Circular Letter'*, intercepted by the Allies during the early 1950s *en route* from the Nazis' German Geopolitical Centre, Madrid (established there early in the Second World War for long-range strategic planning purposes). The Editor believes that this information was suppressed during the Cold War frenzy period, which was itself originally triggered by Nazi General Reinhard Gehlen, who managed to persuade the gullible Americans that defeated Nazi Germany needed to be co-opted in order to provide the West with 'a bulwark against the East', and to swallow the lie that Nazism had been defeated with the destruction of Hitler's Germany. As was later to occur when the Americans 'personalised' the Iraqi Ba'athists in the format of Saddam Hussein, it was much too readily accepted in Washington that the destruction of the régime equated to the annihilation of the hegemony ideology that inspired it.

And if it is protested that the Iraqi Ba'athist régime was a creation of the Nazi Continuum (which is true), the fact that it was overthrown by military attacks fronted by American 'Nazis' will induce confusion *only* among those who have not yet understood that the Devil is the author of lies and confusion, so that *these evil people ALWAYS turn against their own*. A proper understanding of this, as well as of the dialectical methodology, is a *sine qua non* for any comprehension of today's world.



**ENCOURAGING ENEMIES WHILE OPPOSING THEM**

Since the key *modus operandi* of all compartmentalised, synarchical components of the Illuminati is always to maximise the potential of strategic deception and lies, it is no surprise to find that this principle applies across the board – *even in respect of dealings with overt enemies*. For the Illuminati characteristic of greatest permanent significance is **double-mindedness**: running a deluded 'war party' in parallel with a controlled 'peace party' simultaneously, or (as the CIA is doing *today*) encouraging Communism in Latin America. (This can be seen from the ideologically crass propaganda spewed out by the Agency's South End Press, based in Cambridge, MA, home of Yale College, the notoriously subversive seat of the German-originated 'Skull and Bones', or 'Brotherhood of Death', from which the likes of the Bushes and Borens of this world sprang, and which the Editor exposes in his new book as providing a crash course in demonic infestation: whereas Freemasonry is a lifelong *cul-de-sac* which leads 'chosen ones' (as opposed to the lower 'Porch Brethren') towards infestation by, and worship of, Lucifer, and entrapment in a world of darkness.

Given this Luciferian background, we must cease to be surprised at the fact that the United States, being today the Illuminati's paramount revolutionary power (as well as its failing military enforcement arm), simultaneously *demonises* and yet *assists* its selected enemies, for dialectical geopolitical control purposes. The payment, authorised by President Bush Jr.'s White House, of \$75 million to the North Korean dictatorship two days after its nuclear test on 9th October, followed by further assistance which is too sensitive to report at the moment, represented just another stage in a prolonged process of US assistance to the North Korean nuclear programme.

On 7th July 1993, Leo Emil Wanta, the United States' top intelligence operative and paymaster, was 'taken down' when the Soviets implemented their 'Blowback' response to Wanta's orchestrated Financial Warfare operation against the 'former' Soviet Union, in which key Soviet figures, led by Mikhail Gorbachëv and Vladimir Putin (the GRU operative who orchestrated the 'collapsible Communism' operation in the East European countries) accepted large 'facility payments'. This response was coordinated by Marc Rich (a.k.a. Hans Brand, a top DVD operative) whose power and influence in Switzerland was such that he was able to procure Wanta's illegal arrest and 134-day incarceration inside a filthy Swiss prison, during which time attempts were made by the Swiss authorities to murder him. Specifically, Wanta, who does not eat cheese, gave his portion of cheese to a fellow prisoner, who died shortly afterwards. Leo Wanta was released after an intervention by the Israeli Prime Minister, Yitzhak Rabin, extradited in shackles to

the United States, arraigned before Judge Allyce Ross in a US Court in Brooklyn, released, and then illegally re-arrested on a trumped-up charge by New York police, who insisted they were doing a favour for the State of Wisconsin, the Governor of which (Tommy Thompson) was conspiring with the Soviets' White House agent, William Clinton, to ensure that Wanta would be 'put away' for 22 years on the trumped-up charge of having failed to pay Wisconsin State back tax amounting to \$14,129, which he had already paid twice (and which has been paid a third time, in July 2005, and has since been demanded a fourth time (on 30th October 2006). The objects of this operation were to take this honest man off critical operations, and to steal the vast sum of \$27.5 trillion with which he had been entrusted, raised from 200+ international banks, on White House authority for use to fund the 'post-Cold War global security environment'.

Among the operations which were left in limbo as a consequence, was a cooperative arrangement with András Szasz, the KGB Chief in Budapest, with whom Wanta had been engaged in cooperative financing operations. While these achieved positive results, a primary underlying motivation was that András Szasz had another partner, **George Soros**, with whom he was financing the export of sensitive Motorola chips that were being manufactured at a special plant in Singapore, with a sister plant in Pyongyang. The chips were destined for application in the North Korean nuclear weapons programme, and the finance was provided by Mr Soros via an Isle of Man company known as Viola Trading Limited. So here we have further concrete evidence of the CIA's assistance to the North Korean nuclear programme, disguised as a rogue US intelligence operation. Leo Wanta's investigation into this scandal in the interests of US national security was of course destabilised (as were many other operations, especially a crucial operation for Somalia), when he was 'taken down' in the Soviet 'Blowback' operation coordinated with the Clinton White House – with the Wisconsin Department of Revenue providing cutout false tax demand services for the White House.

Likewise, during the Falklands crisis in 1982, the United States straddled both sides of the conflict. Having incited the (Nazi) Argentine Government to lust after and to seek control of the Falklands, so that the United States could exploit its relationship with Argentina to gain control of any emerging oil resources in Falklands waters, the US Secretary of State of the day, the duplicitous General Alexander Haig, was forced to 'switch' when the British Government led by Margaret Thatcher threatened dire consequences for the so-called 'British-American special relationship' if the United States did not abandon its clandestine support for Buenos Aires.



### THE MERLIN OPERATION

In February 2000, a Russian defector controlled by US intelligence was activated to convey a US nuclear bomb blueprint to the Permanent Mission of the Islamic Republic of Iran to the International Atomic Energy Agency (IAEA). The drawings he was carrying were technical designs for a TBA 480 high-voltage block, also known as a 'firing set' for a Russian-designed nuclear weapon. The technical knowledge he was carrying represented the means to create a perfect implosion capable of triggering a nuclear chain reaction within the confines of a spherical core of modest proportions. This device effectively delineated the large, advanced nuclear powers from Third World countries seeking to join the nuclear club.

The Russian defector had been coerced into carrying out this operation by the CIA. The Agency's primary cover was that the transfer of nuclear technology was being effected by a Russian, affording the CIA 'deniability' in the event that anything went wrong. Naturally, being an operative himself, the Russian defector will have known this. Note also that reports of this operation refer to this man as a 'defector', notwithstanding that 'the enemy was abolished' with the so-called *rapprochement* between the 'former' USSR and the West. The CIA had passed the nuclear blueprints to the Russian defector and had ordered him to Vienna to either sell or give them to the Iranian representatives to the IAEA.

The CIA appeared to be enabling the Iranians to overcome critical hurdles standing in the way of their obtaining nuclear weapons of mass destruction. The Russian was a nuclear engineer who had 'defected' some years earlier and had been incorporated within the CIA's resettlement programme. Like many of these KGB-GRU operatives, a secret CIA report asserted that the Russian was 'a known handling problem due to his demanding and overbearing nature'. The report elaborated that, nevertheless, this man was a 'sensitive asset' who could be used in 'a high-priority covert action program'.

Having become an American citizen, he was paid \$5,000 a month. When an intelligence 'asset' accepts such funding, he lays himself open to the prospect that he will be used for one or more sensitive operations when the time is appropriate, and that if he 'messes' up, his life expectancy will be shortened. The operation which the Russian asset was duly summoned to undertake was given a suitably demonic name, MERLIN, and his assignment was to present himself as a needy nuclear scientist who would do anything, including sell nuclear secrets, to a 'Black' régime. Both the Russian and his CIA handler thought they had been set up (as is usual in this evil milieu), or even that the assignment could be a rogue operation. The handler told his Russian asset that the purpose of the operation was simply to gather intelligence on the stage the Iranians had reached with their nuclear weapons development programme. It was not an illegal operation to transfer nuclear weapons technology to Iran. The defector had previously worked at the Soviet Arzamas-16 plant.

### THE TRIPLE-CROSS

To enhance the CIA's cover, the blueprints that the Russian was to convey, by whatever means became available, into the hands of the Iranians, had been obtained from the Arzamas complex and had been obtained by the CIA from another Soviet defector. The defector arrived in Vienna without any back-up, to minimise the possibility of the CIA's rôle being exposed, while the US Embassy in Vienna was not even informed, as the operation was a 'Special Access Program' (SAP) controlled by the National Security Council – the 'Leninist' entity operating technically below the Presidency but which in fact occupies the same status as similar security council arrangements in all overtly Communist countries.

Finding himself stranded in Vienna with a sealed envelope containing the nuclear trigger blueprints, the Russian agent decided to open the envelope. He slipped a letter inside in which he hinted at what he had deduced – that the blueprints had been doctored by US experts so that if the designs were followed, something would malfunction. This is a familiar technique used by the CIA. For instance, a US Office of Naval Intelligence (ONI) operative is known to have penetrated an office at the Russian Ministry of Defence in 2000 and to have substituted a key printed circuit for what he described as a 'Sony Play Station' printed circuit. In other words, in this case, the Russian warned the Iranians, to whom he succeeded in delivering the envelope, that the nuclear blueprints had almost certainly been compromised.

A few days after the Russian defector had managed to convey the envelope containing the blueprints and his inserted 'warning' letter, the National Security Agency at Fort Meade, which monitors the databases of airlines worldwide, thereby checking day and night on the travel plans of foreign officials and others targeted by US intelligence, established that an Iranian official in Vienna had suddenly booked flights to Tehran and had flown home. This indicated to the Americans that the blueprints had probably been conveyed to Tehran.

While the CIA may thus have fed false technical information to the Iranians, the doctored information was lodged in blueprints which were themselves *bona fide*. Given that the Iranians, extensively advised and tutored by foreign powers led by the Russians, are far from stupid or ignorant, the flaws in the blueprints will have been identified – leaving the blueprints (minus the doctored information) otherwise intact.

The obvious knee-jerk judgment must be that such operations by US intelligence, which are thought to have been repeated against other countries, are reckless in the extreme – as indeed they are. But what really lies behind such diabolical behaviour? One doesn't need a first class degree in nuclear science to recall that, since double-mindedness is the primary characteristic of these Luciferians, built within the deception is another deception. While purporting to sabotage Iran's nuclear programme, the Americans were transferring Soviet technology to Tehran, in fulfilment of Albert Pike's blueprint. ■
