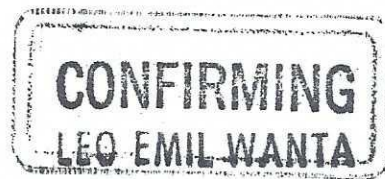

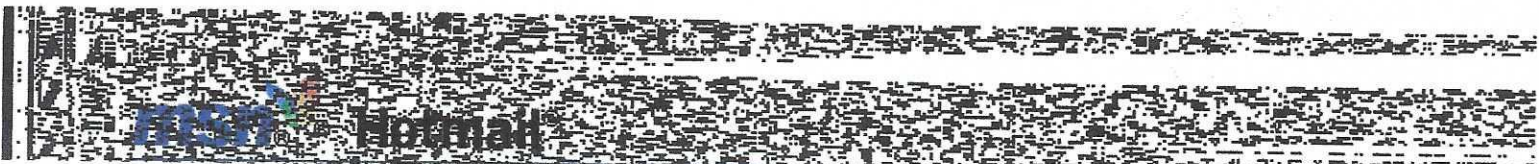

### Failure to pay taxes is charge

Leo Wanta is a man of international intrigue, no matter whose story you believe.

Depending on who is doing the talking, Wanta is either a CIA and U.S. customs agent, or he is a crook who has defrauded business people throughout the world.

Wanta, 53, was charged Tuesday in Dane County Circuit Court with failing to pay more than \$200,000 in state income taxes from 1986 to 1989. He claimed diplomatic immunity from prosecution.

Assistant Attorney General Judith Schultz said the state has been attempting to get Wanta into court voluntarily since early 1992.

Meanwhile, Schultz said, Wanta has been arrested for fraud in Singapore; Bangkok, Thailand; and in Geneva, where he told Swiss officials he was a Somali ambassador and was a friend of Al Gore.

Wanta was deported from Switzerland last month and arrested upon his return to the United States.

In a sometimes rambling speech in court, Wanta called the charges a "sham and a fraud" and insisted he had never been arrested for the crimes Schultz claimed. He said he is a legitimate businessman who lives in Vienna, Austria, and owns a corporate home in Appleton. He originally gave jail officials a Toronto address.

He was held in the Dane County Jail on \$90,000 cash bail.

## American questioned on gun ring

TOP immigration officials at the Manila International Airport yesterday began tracking down an American national believed in possession of vital documents linking several government officials to a gunrunning syndicate which supplies high-powered weapons to a secret organization known to be "anti-government."

Miguel Ramos, airport immigration intelligence chief, dispatched a team of crack investigators to look into the mysterious disappearance of Leo Wanta, 46, president of an American firm dealing in "highly confidential matters" in Manila minutes after he was prevented from boarding a San Francisco-bound jet at the airport the other night.

Efforts to locate Wanta, who could shed more light on allegations that a rebel group in Manila had been building up its forces in preparation for staging a *coup d'etat* to topple the present government, had proved futile.

The last known address of Wanta was at the Manila Inter-Continental Hotel in Makati. A check with the hotel management, however, showed that he had not checked in since he was ordered by the immigration officials to stay in the country.

A similar check at the Manila Mandarin Hotel showed that Wanta had already checked out last Friday.

Immigration officers said Wanta was included in the hold-departure list of the immigration com-

mission. The order was issued last July 15 by Associate Commissioner Joshua San Pedro.

San Pedro reportedly issued the hold order after the Manila Mandarin Hotel management asked him to prevent Wanta from leaving the country without settling his debt with the hotel.

Wanta, a passenger of Philippine Airlines flight No. 106, was scheduled to leave for the US last Friday.

Investigation showed that he had already been cleared for boarding by immigration officer Susan Baltazar when it was found out that his name was in the hold-order list.

Baltazar and several intelligence officers rushed to the Philippine Airlines Mabuhay Room at the airport where they found Wanta who was told he could not leave the country.

The surprised Wanta asked the immigration officials to allow him to

call the US Embassy in Manila.

During his conversation with an officer at the Embassy, Wanta said he possessed classified documents on negotiations his company had with a "group" in Manila.

The immigration officials who were beside Wanta at that time told *The Manila Times* that Wanta had referred to an arms deal with a secret military group in Manila.

The immigration of-

officials also, said Wanta mentioned the names of two officials in the country's military establishment who, he said, are his close associates while he was being escorted out of the passengers' waiting lounge.

Immigration officials said they had ordered Wanta to stay in the hotel where he was billeted so that he could be easily located.

However, the immigration agents could not find him in the hotel where he last stayed.

Subject: ASSASSINATION OF PRESIDENT JOHN F. KENNEDY  
NOVEMBER 22, 1963

Our Miami, Florida, Office on November 23, 1963, advised that the Office of Coordinator of Cuban Affairs in Miami advised that the Department of State feels some misguided anti-Castro group might capitalize on the present situation and undertake an unauthorized raid against Cuba, believing that the assassination of President John F. Kennedy might herald a change in U. S. policy, which is not true.

Our sources and informants familiar with Cuban matters in the Miami area advise that the general feeling in the anti-Castro Cuban community is one of stunned disbelief and, even among those who did not entirely agree with the President's policy concerning Cuba, the feeling is that the President's death represents a great loss not only to the U. S. but to all of Latin America. These sources know of no plans for unauthorized action against Cuba.

An informant who has furnished reliable information in the past and who is close to a small pro-Castro group in Miami has advised that these individuals are afraid that the assassination of the President may result in strong repressive measures being taken against them and, although pro-Castro in their feelings, regret the assassination.

The substance of the foregoing information was orally furnished to us by George Bush of the Central Intelligence Agency and Captain William Koonals of the Defense Intelligence Agency on November 23, 1963, by Mr. W. T. Forsyth of this Bureau.
