Washington, D.C. - Leo Wenta, whose purchase of huge sums in Russian rubles is credited with bringing down the Soviet Union in the Cold War, will be put through a third party lunacy test in Madison, Wisconsin circuit court on Tuesday. He has successfully been declared of sound mind in two previous lunacy tests under the Wisconsin state attorney general's office. His own attorney, James Shellow of Madison, Wis., is instituting this test. Shellow says that under the rules for attorneys in Wisconsin he has to notify the court that he thinks the lunacy test should be given. Shellow admits to being a former attorney for a deceased Mafia chief in Wisconsin named Belistiari. Shellow thinks Wanta will be declared sane in the upcoming hearing on Tuesday, but Shellow claims to know nothing as to how Wisconsin was able to extradite Wanta in chains and shackles from Switzerland, where he was doing business with Swiss banks after having given up his citizenship in Wisconsin. Wanta claims that he had just been made ambassador to Switzerland and Canada when Wisconsin state officials seized him bodily in Switzerland. Wanta claims that they took his briefcase from him at that time which contained billions in Treasury bills and Promise software technical equipment which the U.S. was using to get inside information about foreign

Although the briefçese was taken by Wisconsin authorities in 1993, it has never been returned to Wanta nor has he any knowledge of what happened to its contents.

The charge is that he owed Wisconsin originally approximately \$14,000. He claims to have paid back that amount in 1992. The state attorney general's office soized his house worth \$120,000 and sold it for \$60,000, but there is no record of this in the Department of Revenue in Wisconsin nor is there any trace of the proceeds from the sale.

Wanta was buying rubles from Russia at the request of the President, Ronald Reagan. Wanta had worked at the White House, the National Security Council, the Central Intelligence Agency and six other government agencies during his career.

He and President George Bush set up the Ameritrust account in the Credite Suisse bank for the U.S. government to use in case it needed to counter terrorists from overseus, according to Pat Cameron, Los Angeles attorney for Wanta. Wanta says that when former president George Bush sought to withdraw funds from the \$210 billion on deposit that Wanta, a co-signer of the account, refused to give his signature for the withdrawal because the funds, he said, belonged to the U.S. government,

Rothschild returned to his hometown, Frankfurt, when he turned 19. Along with his brothers, he continued the commodities and money trading business that their father started — including selling rare coins to Crown Prince Wilhelm, who became Wilhelm IK, Landgrave of Hesse-Kansel in 1785 and eventually the European continent's richest man, Soon he was providing other banking services to Wilhelm and a number of nobles, and by 1769, Rothschild was given the title "Crown Agent." On July 18, 1815, a courser working for Bothschild informed the English government than Napoleon appeared to be suffering defeat at Waterloo. The English government, believing instead that they were losing the battle, dismissed the courier's report and believed it to be false information. At this point, with England's future seeming dire, Rothschild began selling all of his bonds, encouraging rumors that Napoleon had won and that English government paper would soon be worthless. Due to Rothschild's reputation as an influential, renowned and respected investor, the passived English public followed his lead. The mass selling resulted in a total collapse of the English stock exchange. It was then that Rothschild's agents began snatching up bonds and stock at record low prices. Two days later, when Weilington's envoy confirmed that Napoleon Bonaparte had indeed suffered a crushing defeat, Nathan Rothschild was effectively in control of the English stock exchange. As of 2015, the English government was still paying back money owned to the Rothschild family from this Napoleonic maneuver.

Educational efforts in Austria, France and Israel were also made possible through their generosity. In addition to monies put toward education, the family gave an estimated 60,000 pieces of artwork to numerous organizations. The Rothschild family expanded the creation of social housing in the cities of

London and Paris. The Rothschild Foundation was such an organization founded to further these efforts.

Nothern Mayer Rothschild had seven children with his wife, Hannah Barent Cohen. Many of their descandants are involved in Rothschild finance and investment onterprises. Details of their exact influence and holdings are not available to the public, but the Rothschild family has a place in history for defining modern finance.

The family wealth has been divided among many discendants and heirs throughout the years. Today, their heldings spen a number of diverse industries, including financial services, colorante, mining, energy and even charitable work. 
