#### Dear Erin:

Thank you for taking time to discuss various topics concerning Ambassador Wanta. I thought it may be helpful for you to have documentation to assist your understanding and potential research.

During our conversation you asked a question about my background. I am a graduate of Creighton Law School and the only time I have actively practiced law was my first job upon graduation from law school. After graduation and passing the Nebraska and Colorado exams I received an appointment as an AUSA in Denver. I have been doing business in Asia for many years. I am attaching Exhibit A that is a summary presentation of my most recent China endeavors.

You also raised the matter of the legal issues between Ambassador Wanta and the State of Wisconsin. I am providing simplified information that should lead a reasonable person to believe there is more to what occurred in the State of Wisconsin than meets the eye on a surface investigation. If after reading what I provide you question what you may have heard regarding the case in Wisconsin I assure you that "you ain't seen or heard nothing yet".

The tax case instituted by the State of Wisconsin against Ambassador Wanta concerns 1988 and 1989 State of Wisconsin personal tax matters. Ambassador Wanta having terminated his residency in Wisconsin filed no returns in 1988 and 1989. In June of 1991 Ambassador Wanta was in the State of Wisconsin and as a result of contact by a State Revenue agent, and in cooperation with his estranged wife, he filed personal tax returns and made no entry where the State of Wisconsin requires a line item entry of a taxpayers 1040 IRS filing amount. Attached to his 1989 State of Wisconsin personal tax filing (filed in June of 1991 referenced above) he attached a letter from the IRS dated April of 1991 informing him that he had no 1040 taxes due. I have attached a copy of the letter from the IRS to this letter and marked the same Exhibit B.

I have also attached a document from the records of the Wisconsin Department of Revenue that I have marked Exhibit C. This document comes from the computers of the State of Wisconsin and was produced in 1995. If you look at the line where I have drawn an arrow you will note that for 1986 –1989 the statement reflects a tax liability of Ambassador Wanta of \$00.15. If you can read the

other entries you will note that the entries make reference to Falls Vending. The only association Ambassador Wanta had with Falls Vending is in the capacity of an undercover law enforcement officer. As a result of his and other undercover work a major organized crime family out of Milwaukee was convicted of various crimes.

I have also attached a letter marked Exhibit D from the State of Wisconsin Department of Revenue dated February 18, 1999 addressed to one of the legal staff working on behalf of Ambassador Wanta. The Exhibit D letter makes reference to <a href="mailto:no-taxes-due">no-taxes-due</a>, a social security number and a DPP# (Diplomatic Passport). Following Exhibit D is Exhibit E that is a statement of taxes due issued less than one month after the Exhibit D letter. The Exhibit E letter has the same social security number as the Exhibit D letter and different than the Exhibit D letter claims \$700,000 plus in taxes due. It is also noted that the date for the claimed taxes in the Exhibit E letter is 1983 and this relates back to Falls Fending. Ambassador Wanta started undercover work at Falls Vending in 1982. As a last point for background information on the Wisconsin case I submit for logical evaluation the verifiable fact that at the time of Ambassador Wanta re-entering the USA in November of 1993 he had in his possession eighteen (18) "One Billion Dollar Each" US Treasury instruments. These instruments were in the possession of the court when Wanta made an initial appearance before a U.S. District Court in New York. New York confirms that they these documents along with other personal and business items of Ambassador Wanta were forwarded to the State of Wisconsin.

The Exhibits and explanation referenced above concerning the Wisconsin case are just at the tip of the iceberg. I am of the opinion that if a question is raised regarding the participation of Ambassador Wanta in any Congressional information gathering, investigation or debriefing that I be given an opportunity to answer questions and explore "safe" and "apolitical" avenues to neutralize any such concerns that may surface as questions concerning the Wisconsin case.

The balance of the documents attached to this letter concern intel-op communications advising of various matters. I submit that confirmation of the factual integrity of the communications has been verified through passage of time. I request that you note the dates and subject matter of information provided. Now evaluate the present participation of Americans furthering the attack on terrorist activity in the Philippines. I would note for your information that although the attached intel-op oriented communications appear after 9/11 there are substantial sets of documents being sent from Asia to USG officials as early as March of 2001.

I appreciate that this is lot of information to absorb. I am not sending information that I also think is pertinent in regard to many issues surrounding Somalia. At some time in the future I may approach you to look at additional information on the Somalia matter.

If you have additional questions or require additional information please feel free to contact me at any time. If my line is busy send an e-mail message and I will be back to you quickly. Thank you for your interest and concern with the issues I have raised.






