Dear Dr. Peterson:

I enjoyed our conversation this morning and appreciate your concern for Leo Wanta. As I indicated in our conversation, I have requested on behalf of Ameritrust Corporation, Inc. information concerning an account in Banque Alliance in Geneva, Switzerland. I am sending for your information a copy of my letter and a copy of their response.

It is totally puzzling to me how the State of Wisconsin can continue the miscarriage of justice foisted upon Leo. The young attorney that was appointed by the court to represent him sounded initially like he was all fired up to do something. Subsequently, he would not even talk to me, and according to Leo, he joined with the Attorney General to have Leo committed. I am appalled that there are no Wisconsin attorneys who are willing to step in and vigorously represent Leo, even though they cannot be paid up front and must rely on payment subsequently.

I am told that whenever the attorneys there hear that there may be large sums in banks and that Leo has an interest in these large sums that they demand an immediate large retainer, which is impossible for Leo to obtain at the present time. As a result, Leo has now been in jail for more than a year and has never been tried on any charges.

Leo claims that the federal government is at least partially responsible in conjunction with the State of Wisconsin for keeping him out of circulation. It sure seems like that is possible, and as I indicated, even I have been investigated by the FBI because I am acquainted with Leo and think that he is okay.

I trust that you will accurately portray in your testimony, if it comes to that, precisely what you believe to be the truth regarding Leo's competency. Your cooperation is appreciated.

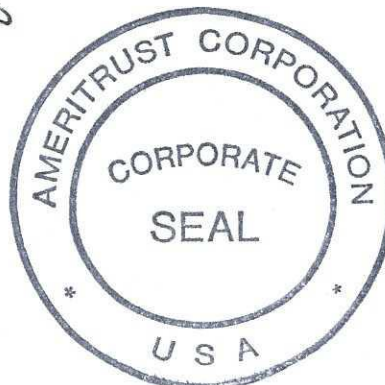

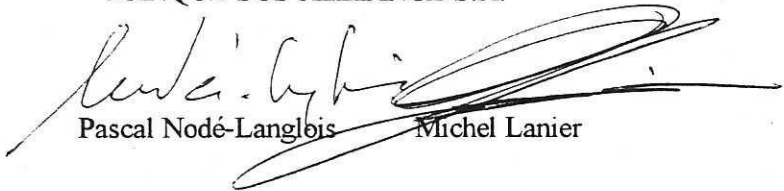

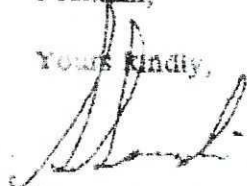
Mrs Benney provided that I would be required to send you this letter to receive an answer from your goodself regarding the facts of this case.
