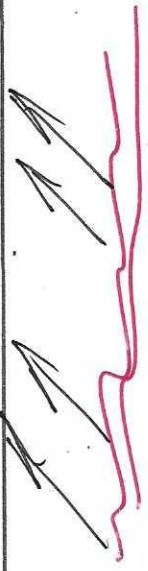

Purpose of Form.—Use this form to tell the payer, middleman, broker or barter exchange that you are a nonresident alien or foreign entity that is not subject to U.S. information return reporting or backup withholding rules. Beginning January 1, 1984, payers of interest, brokers, and barter exchanges may have to withhold 20% of each payment or transaction if payees do not tell the payer or broker their correct taxpayer identification number or if they fail to report the interest as income on their U.S. Federal income tax return. Also, payments to these account holders are generally not subject to U.S. reporting requirements.

Interest Payments.—Interest paid to you is not subject to the new withholding or reporting requirements if you are not a U.S. citizen or resident, or if you are a foreign corporation, partnership, estate or trust. Use this form to notify the payer of your foreign status.
