(ANTIWAR.COM (https://news.antiwar.com/2019/03/01/pompeo-us-will-defend-philippines-military-in-south-china-sea/)) — In comments on Friday, Secretary of State Mike Pompeo confirmed (https://www.reuters.com/article/us-philippines-usa/pompeo-assures-philippines-of-us-protection-in-event-of-sea-conflict-idUSKCN1QI3NM) that the US still considers the 1951 Philippine-US Mutual Defense Treaty to be fully intact, and would adhere to it in the event Philippines forces come under fire in the South China Sea.

US officials have repeatedly made clear that they intend to support the Philippines militarily in the South China Sea. Pompeo singled out China as a threat to Philippine sovereignty, and cited their island-building as a problem.

This comes after Philippine DM Delfin Lorenzana has been pressing the US for a review of the treaty, and clarification of what the US would actually do if the Philippines suddenly come under attack.

It's not clear that's what Philippine President Rodrigo Duterte wants, however. Duterte has said (https://news.antiwar.com/2016/12/29/philippines-president-rebukes-usgoals-in-region/) he doesn't care about China's island-building, and doesn't have any problem with China's behavior in the region. He's also expressed concern that the US interest in confronting China in the South China Sea might suck the Philippines into an American war.





MEMORANDUM OPINION

Defendants.

THIS MATTER is before the Court on Defendants the United States of America, et al.'s, motion to dismiss Plaintiff Ambassador Leo Wanta's claim of breach of contract based on lack of subject matter jurisdiction and on Plaintiff's motion to amend his complaint. The issue before the Court is whether the Court should dismiss an alleged secret government agent's claim against the Attorney General, the Director of the Central Intelligence Agency, the Secretary of the Treasury and the Government based on lack of subject matter jurisdiction. The Court grants Defendants' motion to dismiss pursuant to Federal Rule of Civil Procedure 12(b)(1) because the Government has not waived sovereign immunity and public policy forbids the adjudication of a suit relating to matters of an alleged national security contract. The Court denies Plaintiff's motion to amend his complaint under Federal Rule of Civil Procedure 15(a) because such an action would be futile.

Stuck in the Promised Land


Israel: With unrest rising, many settlers want out

OT EVERYONE IN THE MILitant Jewish settlement of Kiryat Arba thinks it's the promised land. "We went because of the money; it was cheap to get an apartment there," says Sanih Malul, who moved to Kiryat Arba II) years ago. Malul and her husband, Avi. raising four children in n tearful place surrounded by unraged Palestinians, often thought of moving to ferusalem. But they couldn't afford to. Then Baruch Goldstein, a Kiryal Aria resident, gormed duwn 20 Muslim worshipers in nearby Hebron, and everything changed. "My h-year-old said to me. I'm afraid the Arabs will kill me now." recalls Saruh. The Maluls demanded government help-and with a \$275 manthly subsidy, they were able to rent a tany apartment in

Thousands of Jews living in other settlements deep in the Israeli-occupied West Bank and Chiza Strip want to get out, too. that it's not so easy. They were lured there by government offers of huge mortgages at rack-bottom rates, at a time when Israel's leathers wanted Jews to populate Arab salars captured in 1967. The scalers benglit names they could never allord in Israel support het now that Israel is preparing to trade land for neace, the same houses have plunged in value. "Many families want to leave," says Malal, who can't find a bayer for her agartment in Kirvat Arba, "Rut they don't have the money to make that choice."

The trick is to survive Pulestinian stones. builters and bombs until the government of Prime Minister Vitzhak Rubin offers commensation, then take the money and run. Settlers recall the precedent set at Yamit, the Smal settlement returned to Egypt as part of the 1979 peace treaty. Palestinians will think we are weak!" That approach has left many sculers feeling like powns in an increasingly dangerous game, just last week the Islamic militant group Hamas issued a warning to Jews living in certain West Bank and Gaza settlements: leave by March 15 or face incrensed attacks. The threat is not empty bluster. In February Hamas ganmen shot dead a pregnant woman who was traveling between Tel Aviv and the suburban-style settlement of Ariel. More recently, nervous Israelt soldiers killed to Ariel resident who was driving at night - they thought the settler was a Palestinian terrorist.

MEMORANDUM OPINION

THIS MATTER is before the Court on Defendants the United States of America, et al.'s, motion to dismiss Plaintiff Ambassador Leo Wanta's claim of breach of contract based on lack of subject matter jurisdiction and on Plaintiff's motion to amend his complaint. The issue before the Court is whether the Court should dismiss an alleged secret government agent's claim against the Attorney General, the Director of the Central Intelligence Agency, the Secretary of the Treasury and the Government based on lack of subject matter jurisdiction. The Court grants Defendants' motion to dismiss pursuant to Federal Rule of Civil Procedure 12(b)(1) because the Government has not waived sovereign immunity and public policy forbids the adjudication of a suit relating to matters of an alleged national security contract. The Court denies Plaintiff's motion to amend his complaint under Federal Rule of Civil Procedure 15(a) because such an action would be futile.
