U.S. Federal Reserve now tied to Bernard Madoff Ponzi Scheme

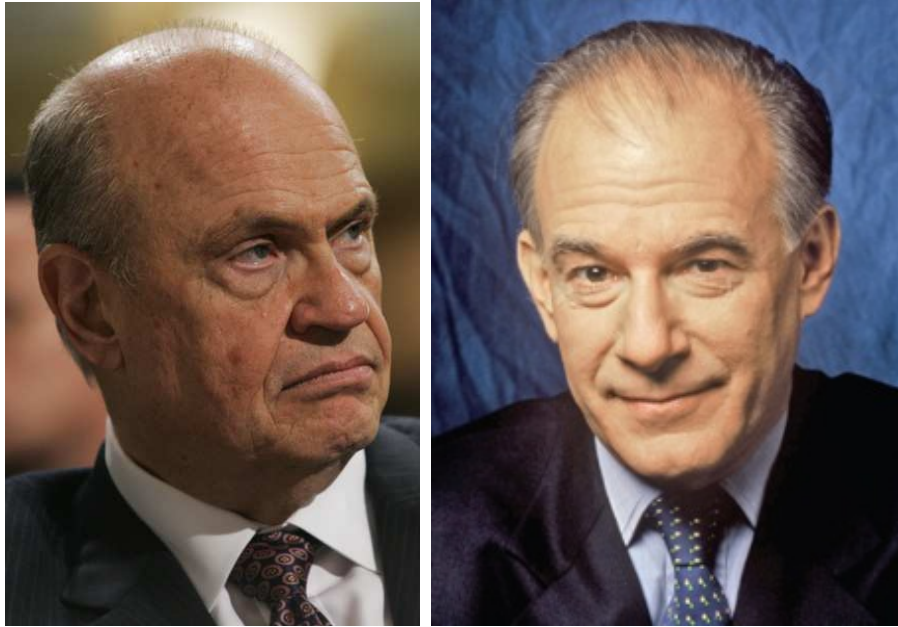
This spying, which began in February of 2001, was partially outsourced to Israeli owned companies, Odigo and Comverse.
