Dear Solicitor General Olson:

I am co-counsel with Steven D. Goodwin representing Ambassador Leo E. Wanta in the referenced action. My purpose for writing is to explore the opportunity of obtaining your cooperation, assistance and suggestions in structuring a resolution of my client's disputes and differences with the State of Wisconsin and the United States Government. My approach to a resolution may be an oversimplification of both political and non-political issues encompassing my clients past and present association with the United States Government. Irrespective of the complexity of the various issues facing my client and his association with the United States Government I respectfully suggest that my approach would appear to place all concerned parties in a "win/win" position.

During the President Clinton administration and additionally during the current President Bush administration there have been several attempts and overtures of settlement through a variety of mechanisms. In the recent time period there has been reference to issuance of either a "Pardon" or "Amnesty". It would appear to me neither of these mechanisms nullifies the State of Wisconsin disputes unless cooperation can be obtained from appropriate officials in the State of Wisconsin. Considering conflicts between Republican and Democratic Party agendas matters dealing with my client may become a "ping pong ball" topic of dispute. To cut right through all the history and complexity of topics that may arise in discussing my client I suggest that the pending action before the Supreme Court affords my suggested "win/win" for all parties. Potentially and maybe most importantly I suggest that the "win/win" would be most beneficial to the current administration including friends and associates of the current administration.

A synopsis of my conceptual resolution would entail the following:

- An endorsement by the USG of my client's claim of Diplomatic Immunity.



- Past actions and claims by the State of Wisconsin would fall by the wayside, as there would be no basis for jurisdiction over my client.
  - Simple document acknowledgement by my client reaffirming his oath and National Security Act conditions of employment and association with the USG.
  - Directive from the Executive Offices (presumably the Vice President) notifying my client that he must remain silent and all actions and/or inactions by any and all parties over the past approximately ten years have been in the interest of national security and my client shall cease and desist from having conversations without the express approval of appropriate parties.
  - The parties on a "need to know" only basis implement terms and conditions of retirement of my client and terms and conditions of relationship dissolution.

I accept that it may be overly presumptuous of me to suggest reasons why issues and concerns with my client should be settled. Hopefully persons in position of leadership and authority both past and present would and/or will have their own reasons. I note that consistent with communications to other parties my client remains loyal to both the United States and the present and past Bush administrations.

I am available at your convenience to explore any and all suggestions and recommendations proffered either by yourself and/or other members of the administration.

Once again we bring to the attention of you and your court the fact that there is evidence that is vital to the defense of Leo E. Wanta that should be entered into the case. You and your court should require that a new trial be held and a proper defense allowed for the defendant Wanta, especially now that he has a new attorney and in light of this new evidence. Conduct yourself according to the law.

Dear Mr. Chavez:

In accordance with your request, I am providing you with the State of Wisconsin's present position with regard to disposition of this matter by plea agreement. My offer is as follows:

- \* 1. The defendant will plead guilty to each of the six counts contained in the information.
- \* 2. The state will recommend (or defendant and the state will jointly recommend) that the defendant be placed on probation for a period of five years.
3. That as a condition of probation, defendant will be confined to the Dane County jail for a period of eight months with full credit for time served since his arrival back in the United States in November.
4. As a further condition of probation, defendant will cooperate fully with the Wisconsin Department of Revenue in identifying and locating all of his assets. Those assets include personal assets as well as assets of any and all businesses, partnerships, corporations and other associations in which Mr. Wanta has any financial interest. This cooperation will also include Mr. Wanta providing the Department of Revenue with specific, current information on the location of the approximately \$179,000.00 which he withdrew from the bank account of New Republic/USA Financial Group, Ltd., at the Banca Nazionale Del Lavoro, New York City branch and forwarded it to two banks in Vienna, Austria.
5. The state agrees that it will bring no additional criminal tax charges against Mr. Wanta for any matters revealed in Mr. Wanta's compliance with condition 4. above.


