

8. The parties' assets, their interests therein, the values thereof, and their encumbrances and debts are found to be as set forth in the first joint petitioner's financial disclosure form, and as supplemented by the second joint petitioner's form on file herein.

9. The parties' Marital Settlement Agreement is found to be fair and reasonable, is approved in its entirety, and is incorporated herein and is attached to the judgment of this Court.

#### CONCLUSIONS OF LAW AND JUDGMENT

10. Divorce. The marriage between the first joint petitioner, Joanne E. Wanta, who resides in Eau Claire, Wisconsin, and is by occupation a secretary, and the second joint petitioner, Leo E. Wanta, who resides in Eau Claire, Wisconsin, and is by occupation a businessman, is dissolved, and the parties are divorced effective immediately on the 3rd day of November, 1995, except as the parties are informed by the Court that under Section 765.03(2), Stats.:

It is unlawful for any person, who is or has been a party to an action for divorce in any court in this state, or elsewhere, to marry again until six months after judgment of divorce is granted, and the marriage of any such person solemnized before the expiration of six months from the date of the granting of the judgment of divorce shall be void.

11. Maintenance Payments.

Maintenance has been waived by the parties and none is ordered.

12. Marital Settlement Agreement. The parties' Marital Settlement Agreement dated October 16, 1995, is fully set forth and appended to this judgment and made a part hereof.

13. Noncompliance. Disobedience of the court orders is punishable under Chapter 785, Stats., by commitment to the county jail or house of correction until the judgment is complied with and the costs and expenses of the proceedings are paid or until the party committed is otherwise discharged, according to law.

14. Entry of Judgment. The Clerk of Court per Sec. 806.06(1), (2), Stats., shall enter this judgment forthwith by affixing a file stamp that is dated.





2. Any debts incurred by each party since January 1, 1989 shall be the individual debts of such party and such responsible party shall protect and hold the other party harmless from such debt.
3. No order need be entered respecting a residential home situated in Appleton, Wisconsin, belonging to the parties in joint tenancy. The premises shall remain in joint tenancy following entry of a divorce decree.

1. I am one of the Joint Petitioners in Eau Claire County Circuit Court Case No. 95 FA 445.

2. I was married to Leo E. Wanta just over 34 years ago in Milwaukee. All of our children are adults and are living separate lives.

3. Leo and I have not lived as husband and wife or together for approximately seven (7) years or more. We each live at separate addresses and neither relies upon the other for support and neither have supported one another for at least seven years.

4. There is no possibility of reconciliation.

5. Joint Petitioner, Leo E. Wanta, is awaiting sentencing in the Circuit Court of Dane County on certain income tax charges of which he has been convicted. That hearing is scheduled for October 27, 1995. A potential period of incarceration is possible and the State of Wisconsin is seeking that.

6. Remaining married is only a legal technicality. It does, however, complicate the filing of income tax returns and places this affiant in a high tax bracket relatively speaking, and apparently does the same for Joint Petitioner, Leo E. Wanta. (This affiant knows nothing of the financial circumstances of Joint Petitioner, Leo E. Wanta.)

7. I am informed that one of the main purposes for the waiting period was to prevent "quickie divorces" without giving the parties a chance to think and to possibly reconcile. For all intents and purposes, Joint Petitioners have lived separate and apart as if they were not married for over seven years. Further delay would serve no purpose.






Dear Amb. Wanta,

This letter is to inform you that on April 22, 1999, an affirmative sentence was rendered by the appellate court, the tribunal for the diocese of Green Bay, to your petition for annulment of your marriage with Joanne E. Ramstack.

Please be aware that this decision in no way derogates from the effort and dedication that you gave the marriage. The decision was made exclusively on the basis of the dynamics of the marital relationship. This decision also has no civil affect and does not affect the status of any children born of the marriage.

In the event that you wish to remarry in the Church, this decree must be submitted to the priest or deacon conducting the pre-marital preparation.
