GREAT POWERS AT LOGGERHEADS

The struggle between and among the Great Powers over geopolitical hegemony and the energy assets of the Eurasian and Middle East regions is running at fever pitch behind the scenes. The recent announcement that the former German Chancellor, Gerhard Schroeder, has been appointed to the Chairmanship of the North European Gas Pipeline, and the news that Donald Evans, the former US Secretary of Commerce and a close personal friend of George Bush Jr., has been offered the position of head of the Board of Directors of Rosneft, the leading Russian state oil corporation, brought Soviet strategy to trap the United States and dominate Europe finally into three-dimensional focus. In the simplest of terms, US and British intelligence helped the long-range Soviet strategists dismantle overt Communism, en route to the establishment of a fake 'free enterprise' environment modelled along Leninist 'state controlled capitalism' lines. This was a necessary prerequisite for the revitalisation of the Soviet oil sector which is now being decisively leveraged in pursuit of Gorbachev's stated 'Europe from the Atlantic to Vladivostok' objective. German 'Black' intelligence is meanwhile engaged in realising the potential of its Iranian assets on behalf of the opposing German/French alliance.

WHAT STAGE HAS THE REVOLUTION REACHED?

At this time of year, it is appropriate to take stock of global revolutionary strategy. **What stage has the World Revolution reached, and how far are the Illuminati from the achievement of their ruthless Luciferian objective of global control and World Government?** The good news is that their timetable is always slipping, since although they purport to believe that they can control the evolution of events, they are singularly inept at the matter of timing.

The reason for this is inherent in their crazy methodology. This is founded upon the Rosicrucian (Sufi) Black mythology that we live in a 'mechanistic' world, which the 'chosen ones' – meaning the 'Brotherhood of Man', i.e. the self-selected Luciferian 'Illuminated' Ones themselves – are somehow entitled and are called upon to manipulate. The power that entitles and compels them to do this is called 'the seething energies of Lucifer' by the most notorious of all their adepts after the High Priest of Lucifer, Alfred Pike – namely, Manly P. Hall, the late author of innumerable esoteric, mad occultic works taken deadly seriously by global Freemasonry and the Illuminati and liberally drawing upon the Forces of Darkness, which he helped to release into the confused 20th century, and the evil consequences of whose Works we are now experiencing to our shame as never before in the West.

According to this mad methodology, there are two 'phanes', or Forces, which the sect of the Illuminati – and it is a massive sect, with more than a million brainwashed and trapped members in the United States alone, many occupying high, including the highest, positions in the structures of this Rosicrucian Republic – considers its élite are entitled and compelled to manipulate. They refer to these 'phanes' Good and Evil, although

in reality, because the world is 'mechanistic', they only profess to 'believe' in Good and Evil: in practice, because they are double-minded (the chief characteristic of the Illuminati), they both reject the concept of Good and Evil, and simultaneously call Evil Good, and Good Evil, in precise contravention of the Old Testament Prophet's injunction against such confusion:

'Woe unto them that call evil good and good evil; that put darkness for light, and light for darkness; that put bitter for sweet, and sweet for bitter. Woe unto them that are wise in their own eyes, and prudent in their own sight'¹.

WISE IN THEIR OWN EYES

These people are indeed 'wise in their own eyes, and prudent in their own sight': for they have an answer to everything. They purport to know precisely how the world should be reorganised in conformity with their Luciferian blueprint – and yet all they are ever capable of achieving, ultimately, is chaos and confusion. When such dangerous and serially deluded people achieve power in Western countries, such as the United States and

FRANCE AND GERMANY VS BRITAIN/U.S.

The structures of international relations that are routinely reported on in the 'mainstream' media appear increasingly as empty shells, within which the main Great Powers are engaged in an evidently bitter, and violent, struggle for hegemony. The intelligence war that rages behind the scenes is now constantly spilling over into the public domain, as the Franco-German secret axis struggles with Britain and the United States to grab and control energy assets worldwide. This is a game that the covert continuing Soviets relish, and that they have been exploiting to the full – enlisting the United States to implement their hegemony strategy, while German 'Black' Nazi intelligence, in an ominous move has taken over control of the Iranian régime.■

CONFIRMING
LEO EMIL WANTA

Britain, which pride themselves on 'knowing' how the rest of the world should be organised, the world finds itself in an even more precarious condition than is normal. These superpowers (and the United Kingdom is a secret financial superpower) are today controlled by Illuminated Ones who are 'wise in their own eyes, and prudent in their own sight' indeed.

THE 'TWO KARLS' DIALECTIC

The concept of the two 'phanes' or Forces is the Sufist origin of the dialectic (Thesis, Antithesis) – the two contrasting Forces which, 'released' to oppose each other, in due course yield (so the mad prescription maintains) the Synthesis. This is the essence not only of the Marxist-Leninist Hegelian dialectical methodology but, much more to the point, of the methodology of the Illuminati.

Faced with the perceived 'need' for two opposing mechanistic forces, which could be exploited politically, the Illuminati now set about inventing them. This is most easily illustrated by reference to the **'Two Karls'** – Karl Marx, the German Jew contracted by the Rothschilds to develop theoretical Communism, and Professor Karl Ritter, a German Jew based at Frankfurt University, into whose hands was placed the remit of developing the concept which became, via Neitsche, known as 'Fascism', the model embraced by the Nazis.

On page 4, we replicate the illustration of an early Nazi Labour Day Emblem which displayed both a swastika and the face of Karl Marx and a hammer and sickle – with the swastika contained within a globe surmounted by a winged beast derived directly from Egypt (The Old Testament metaphor for the Darkness, given that the culture was focused upon death).

ALBERT PIKE'S THREE CATASTROPHES

Working in the 13-room mansion that he built in Little Rock, Arkansas, the 19th century's High Priest of Lucifer, Albert Pike, the 'father' of modern American Freemasonry who engaged enthusiastically in depraved occultism and magick and the summoning-up of evil spirits, and whose writings are considered by some experts to have been demonically inspired (a view supported by your correspondent), developed the parallel framework within which the two opposing forces of 'Communism' and 'Fascism' were to be exploited.

Specifically, he sketched out a long-range plan under which the entire world system was to be remodelled as a consequence of three global catastrophes (world wars) – two of which took place in the first half of the 20th century, and the third **which is being prepared now**. It is a fact that Albert Pike envisaged the third global catastro-

phe as a devastating conflict between Islam and the Jews. Those equipped with this knowledge of what Albert Pike envisaged, are enabled, therefore, to identify what is happening today as the run-up to the third, and (Pike assumed) decisive conflict which was to leave the field clear for the absolute hegemony of the Illuminati.

In a separate study (included in his forthcoming two-volume work entitled *The New Underworld Order*), the Editor shows that the Protocols of the Learned Elders of Zion, which the Jewish lobby so vehemently condemns as a forgery, was indeed a strategic deception device – not of World Jewry, but of the Illuminati, skewed so that the Jews would receive the blame for whatever atrocities and abominations needed to be blamed upon others, so that the chief *agentur* of the Illuminati themselves would escape the consequences.

This is exactly what occurred under Hitler – with, it needs to be re-emphasised, the constructive assistance of Sephardic Jews, who collaborated with the Nazi authorities to exterminate the Ashkenazim (the category then applicable to most German Jews). Among the most prominent of these Jewish Nazis were **Adolf Eichmann**, who industrialised the mass murder machine, and **SS-Brigadeführer Dr Otto Gustav Wächter**, Nazi Governor-General of Galicia, Poland, one of the brains behind the 'Shoah'.

ENSURING THAT THE JEWS CAN ALWAYS BE BLAMED

The Illuminati's evil strategy of ensuring that the Jews can always be blamed, is illustrated in the contemporary context surrounding the fate of the Soviet Jewish intelligence and ex-Komsomol 'oligarchs', into whose hands the assets of the Party-State were 'privatised' for international public consumption – but on a strictly 'leasehold' basis. In brief, the Soviet strategists under Mikhail Gorbachëv (of Jewish extraction: his real name is Orbach, or Korbach) sought a means of leveraging and 'surfacing' the colossal Soviet criminalised KGB-*mafiya* underground economy so that it would appear to 'merge' with the 'visible' economy and could be presented to the international community as consistent with the 'free enterprise' model, whereas in reality it was to conform precisely with the Leninist concept of 'state controlled capitalism'. As a Jew himself, Gorbachëv knew perfectly well that the Jews running the *mafiya* societies, and all the Jews selected from among the Komsomol cadres and the intelligence community, would 'get greedy' and would steal assets on an open-ended basis. There accordingly appeared in Kiev in 1986 a modest book entitled *'The Party's Gold'*, in which the precedent for the Party-State 'recapturing' its stolen assets was

described. Specifically, **Stalin** (real Jewish name Iosiph David Vissarionovich Djugashvili-Kochba, a.k.a. Joseph Vissarionoch Stalin) commanded his Interior Ministry chief, **Gengrich Yagoda** (also a Jew) to provide him with a list of all the secret Swiss bank account numbers of his colleagues and other revolutionary leaders. Yagoda duly complied, but omitted to provide Stalin with his own Swiss bank account details.

However Stalin, of course, had his own super-secret investigative cadre, which had provided him with a parallel list; and that list contained the full details of Yagoda's own secret Swiss bank accounts. Like all the others (except Lenin's Jewish wife Nadezhda Krupp, a.k.a. Krupskaya),

Yagoda was accordingly despatched to Hades with a bullet through the temples. Do not be surprised that Jews murdered other Jews: in this underworld, many Jews hate each other. Indeed, the Editor was once told, while briefly employed as a humble banker with S. Japhet and Co, in St Swithin's Lane in the City of London, that **'a Jew's greatest enemy is another Jew'**.

This insight was divulged after your youthful correspondent enquired naïvely how it was that Eichmann, of Jewish extraction, had presided over the atrocities of the Holocaust.

'THE PARTY'S GOLD' DECAPITATION CAMPAIGN

GRU-President Vladimir Putin has been busily engaged for several years in implementing the Leninist 'Party's Gold' policy against the Jewish 'oligarchs' into whose hands the key assets of the Party-State had been temporarily 'privatised', for international public consumption in the context of 'collapsible Communism'. The way this sub-strategy connects with the broader strategic picture will now be explained. In order to do so, it must first be emphasised that the Illuminati Bolsheviks NEVER pursue any policy or strategy that is not political in nature. Everything that is devised in the Kremlin and its structures has a political objective. In the present context, 'political' should be amended to read 'geopolitical'.

For our immediate purposes, we will cease here to refer to the Illuminati (the three-dimensional analysis), and will revert to the two-dimensional perspective, coming back to the 3-D picture later. It should also be borne in mind that Gorbachëv remains covertly in overall control of all Soviet intelligence services (information confirmed by three separate Western intelligence sources) and is believed by the Editor of this service to remain covertly the President of the Soviet Union itself; from which it follows that Putin reports to Gorbachëv. Along with Gorbachëv, Putin received an initial down payment of \$1.0 billion from US

'Black Operations' funds for his cooperation in assisting the process of 'dismantling Communism' (even though this was always the long-range Illuminati intention, as clearly predicted and revealed by Anatoliy Golitsyn, the Soviet defector who lives under cover in the United States).

'EUROPE FROM THE ATLANTIC TO VLADIVOSTOK'

In two-dimensional terms, what is the Kremlin's geopolitical objective with regard to Europe? It fell on complacent and deaf Western ears, but was promulgated *ad nauseam* by President Mikhail Gorbachëv, and was echoed by several of his minions, notably by Andrei Kozyrev, the brilliant Leninist Foreign Minister under Yeltsin (son of one of the 100+ KGB spies expelled from London by the British Government in 1970), and by Boris Yeltsin, the so-called 'former' Secretary of the Moscow Communist Party, himself – namely: **'Europe from the Atlantic to Vladivostok'**.

Speaking in his New Year's Day 1992 broadcast on BBC Radio 4, **John Major**, the former British so-called 'Conservative' Prime Minister, stated: **'I look forward to the day when Russia is a fully-fledged Member of the European Community'**. He was, of course, simply anticipating what his top Illuminati colleague, Mikhail Gorbachëv (Orbach or Korbach) was to proclaim in the course of his Nobel 'Peace' Prize Lecture, given in Oslo in June 1992:

'Our vision of the European space from the Atlantic to the Urals is not that of a closed system. Since it includes the Soviet Union [sic: Observe that Gorbachëv said this six months after the USSR had 'ceased to exist', for public consumption purposes], which reaches to the shores of the Pacific, it goes beyond nominal [sic] geographical boundaries' – which, in accordance with the Illuminati and Freemasonic-Leninist 'line', are by definition transitory and scheduled to be abolished.

According to the controlled covert Soviet 'news' agency RIA Novosti, the Italian Prime Minister **Silvio Berlusconi**, has **'thrown his weight behind' Russia's entry into the European Union Collective**. Speaking in Turkey at the official opening of the Blue Stream natural gas pipeline recently, Sig. Berlusconi affirmed that **Russia would become 'the most important energy supplier to the European countries', and that its admission into the European Union is 'a dream destined to come true'** – i.e., a preplanned strategic objective. The Blue Stream pipeline system, a joint venture between Gazprom and Eni of Italy, was constructed on the floor of the Black Sea to enable Russian natural gas to be exported to and via Turkey.

CLEVER SOVIET APPOINTMENTS OF WESTERNERS

In rapid succession, two further developments have revealed to those with eyes to see, the flowering of the overall strategy. Specifically:

● On 9th December 2005, it was revealed that the former German Chancellor, the four-times married Gerhard Schroeder had accepted a post as head of the shareholders' committee of a Russian-led consortium, the **North European Gas Pipeline**, controlled by Gazprom, that is engaged in the construction of a gas pipeline under the Baltic Sea to supply Russian gas directly to Germany, bypassing Poland, Ukraine and the Baltic countries. At a groundbreaking ceremony some 250 miles north of Moscow, the Chief Executive of Gazprom, **Alexei Miller**, the Putin intelligence appointee and former official in the St Petersburg Mayor's Office, said that the board of the pipeline consortium headed by Schroeder would be involved in 'reaching all strategic decisions on all areas of the company's activity'. In September 2005, Schroeder and Putin had signed an agreement on behalf of Germany and Russia to construct the pipeline at an estimated cost of \$4.7 billion. Significantly, Gazprom's Chairman these days is Putin's former Chief of Staff, the Russian Deputy Prime Minister, **Mr Dmitri Medvedev** – indicating the central importance of the covert

Soviet 'gas-politik' in covert Soviet Eurasian hegemony strategy. Alexei Miller has specifically stated 'the European market' is Gazprom's *main priority*, to be followed by its expansion into the Asia-Pacific region. Schroeder's Berlin office confirmed the announcement and said that the former Chancellor was 'very pleased' to have been able to accept the appointment. The Chief Executive of the new pipeline consortium is **Matthias Warnig**, a German operative who is currently in charge of Dresdner Bank in Russia, and who is a close associate of Vladimir Putin [see page 7].

On 10th December, *The Washington Post* credited *The Wall Street Journal* as the open domain source for the revelation that Warnig 'was an officer in the STASI, the East German secret police, and met Putin during the late 1980s when the Russian President was based in East Germany as a Soviet KGB officer' (in fact, Putin has always been a GRU, i.e. Soviet Military Intelligence) officer. We have more to say about the significance of this and other STASI connections later in this analysis [see page 7].

● On 13th December 2005, it was revealed by the controlled Russian business daily *Kommersant* that **Donald Evans**, the former US Secretary of Commerce and a close personal friend of George Bush Jr., had been offered the position of head of the Board of Directors of Rosneft, the leading Russian state oil corporation². Mr Evans had met President Putin and the head of Rosneft, **Sergei Bogdanchikov**, during a visit to Moscow during the preceding week. Earlier in the present decade, **Semen (Simon) Kukes**, a former Soviet Academy of Sciences intelligence operative specialising in the energy sector, who had left the USSR suddenly during the period of the 'changes' (1989-92) and had surfaced with an American wife and as an executive with Philips-Conoco, gaining US citizenship, replaced the intelligence 'oligarch' and former Gorbachëv Minister Mikhail Khordovoksy as head of YUKOS.

A few hours after *Kommersant's* report, the Jewish Russian Deputy Minister for Economic Development, **Andrei Sharonov**, answered a press question about Mr Evans' alleged post with the typically Leninist comment that the appointment of well-known foreign specialists to senior positions in Russian corporations was 'a positive fact that kills several birds with one stone'.

What are the dickie birds in question? One of them relates to Gorbachëv's reiterated confirmation that the objective of Soviet strategy for the 'upper tier' of the Eurasian landmass is 'Europe from the Atlantic to Vladivostok'. How can this be achieved? The prerequisite for fulfilment of this strategy has all along been the

establishment of the 'former' Soviet Union as a reliable supplier of unlimited sources of oil and gas. **It would, in other words, have made no sense for the fully paid-up Illuminist Silvio Berlusconi to 'call for' Russia to join the European Union Collective until this essential precondition had been achieved.**

Until Russia could be perceived by the whole of Europe to be a 'desirable partner', and no longer (by definition) a threatening one, it would have been a waste of time for any collaborating foreign intelligence asset to 'call for' Russia to become integrated into the European Union.

Clearly, the wily John Major, one of the most devious of all British Prime Ministers, knew all about this long-range strategy back in 1992.

'STATE CONTROLLED CAPITALISM' RUSE

How was it achieved? First, a false 'free enterprise' system was established – by leveraging the full potential of the KGB-*mafia* criminalised underworld economy, very extensively controlled already by Jewish gangsters with close intelligence community links, to provide the basis for a system of 'free enterprise emerging out of the inevitable chaos consequent upon the collapse of Communism'. This process was constructively assisted by US intelligence – led by a number of US Treasury operatives, notably Leo Wanta, and by Marc Rich [see below], the fugitive from US justice indicted by Rudolph Giuliani. Marc Rich fled the United States to establish his scamming empire first in Zug, and subsequently at Meggen, Switzerland [see pages 11-12].

Rich [Reich] specialised in scamming, beyond the direct control of US intelligence, the 'collapsing' Soviet system, while Leo Wanta devised the US Treasury's Financial Warfare attack on the rouble and on Gosbank's gold reserves. These and parallel intensified Financial Warfare operations, which almost all observers have interpreted as 'take-down' offensives conducted *against* the 'disintegrating' USSR, were in fact carried out in close collaboration with Soviet intelligence, headed for the KGB by Mikhail Gorbachëv, and for Soviet military Intelligence by the secret GRU strategic coordinator, Vladimir Putin – both of whom, as indicated, received initial down payments of 'Black Ops' funds from US intelligence worth \$1.0 billion. Indeed, Leo Wanta, who knew Putin well, used to go drinking with him and other Soviet intelligence officers in Leningrad.

The 'Yeltsin years', during which a controlled 'free-for-all' environment was permitted, followed – while the criminalised underground economy, and the 'new economy' financed by the leveraging of the proceeds of innumerable scams, the col-

lapse of the rouble engineered by Leo Wanta and others, and the recycling of the Soviets' segment of the Illuminati's global drug-trafficking 'take', merged into the overt, 'visible' economy, driven inside Russia by the 'thuggist' logic of the underworld. The liquidation rate in Leningrad (as the GRU continues, to this very day, to refer to St Petersburg) soared, as the covert Bolsheviks perpetrated a selective purge or bloodbath under cover of gangland criminal warfare.

COORDINATED GEOSTRATEGY IMPLEMENTATION

And then, late in 1999, all of a sudden, the GRU operative Vladimir Putin is surfaced as Yeltsin's Prime Minister, who, with the 'sudden' termination of Yeltsin's reign amid orchestrated moves to ensure his immunity from criminal prosecution, emerges in place of Yeltsin as President of Russia (still secretly reporting to Gorbachëv). ***Putin's remit was to rationalise the environment to provide a stable basis for the emergence of Russia as a reliable supplier of energy to the whole of Europe, in pursuit and fulfilment of the 'Europe from the Atlantic to Vladivostok' strategy, reporting to Gorbachëv.*** He set about at once to implement the 'new form' of 'the Party's Gold' strategy, so as to claw back assets of the Party-State that had been raped by the leaseholder 'oligarchs' and to facilitate the 'restoration' of the stabilised fake 'non'-Communist state as owner and absolute controller of the Party-State's most important assets in the energy sector.

THE 'TAKEDOWN' OF LEO WANTA

In 1993, while on a mission ordered by William Sessions, head of the FBI, to Switzerland, the legendary US Treasury Secret Services/CIA/FBI operative Leo Wanta – known to have been President Reagan's favourite intelligence operative (or 'junkyard dog') – was arrested and flung into a stinking Swiss dungeon, where he was illegally held *incognito* for 132 days. His instructions from Sessions had included the arrest of Marc Rich. He is believed to have been accompanied by Delmart Vreeland, a US Office of Naval Intelligence operative who may have been instructed to shoot Marc Rich during a boat trip on Lake Geneva, but who allegedly failed to fulfil this mission when Wanta's head got in the way, and his handler allegedly told him not to shoot.

William Sessions was summarily dismissed by President Clinton with no warning, and Vincent Foster, an operative who was charged *inter alia* with financial transactions involving the innocent sounding CIA front called the Children's Defense Fund, was found murdered in Fort Macy Park, Virginia. Following an intervention by the Israeli

Prime Minister, Leo Wanta was released by the Swiss authorities, bundled onto a plane for New York, marched in shackles through the airport, and arraigned in a New York US courthouse on trumped-up tax evasion charges concerning an ancient tax amount allegedly arising from Leo Wanta's intelligence operations many years previously in connection with a vending machine company that had been established by US law enforcement to trace drug-trafficking perpetrators who had been distributing drugs through vending machines. The trumped-up allegations were orchestrated on behalf of President Clinton by his close associate Tommy Thompson, then US Attorney in Wisconsin, who became that State's Governor, and later surfaced in the Bush Jr. Cabinet. Wanta was sentenced to 22 years in jail, later commuted to house arrest.

COMPARTMENTALISATION OBSCURED FULL PICTURE

The significance of these complex circumstances surrounding Leo Wanta (condensed in the foregoing summary) is that, due to compartmentalisation, Wanta and Sessions had been unaware that Marc Rich was *assisting* the United States, *in collaboration with* Soviet intelligence, to bring about the transformation of the USSR and its economy that has been described. In other words, the US Presidency necessarily had a more complete, or broader, overview of strategy than Sessions and Wanta *et al.* Confirmation of this fact has been provided directly to your correspondent by Mr Wanta himself who, when informed by the Editor that he had been working not so much for the United States but actually for the Illuminati, responded (in May 2005): **'Yes, but we didn't understand that at the time'**. The Editor commends Leo Wanta for this very honest admission, because it provides a vital clue and confirms the basic integrity of the present analysis.

Removal of Marc Rich and his vast scamming network from the scene would have *slowed down* the process described, and would have *impeded* the implementation of the joint US-Soviet strategy to convert the 'former' USSR into a viable long-term supplier of oil and gas products to the West. Let us now tease out the game of double-bluff that was going on, which masked the Soviet strategic deception dimension to all this.

As has been seen, 'Europe from the Atlantic to Vladivostok' was never a starter until the 'transformation' (and dollarisation) of the Soviet economy had taken place. The 'Yeltsin period', during which the underground economy and the hegemony of intelligence scamming operations were to be leveraged in order to release the full potential of the KGB-*mafia* and the 'scamocracy' in a

Leninist manner, was a prerequisite for the rapid-fire imposition of the 'state controlled capitalism' model that the strategists needed to surface in the interests of fulfilling the 'Europe from the Atlantic to Vladivostok' strategy. Assets of the Party-State would indeed, the strategists foresaw, be stolen: but they would be recovered, with compound interest, by implementing a 'new form' of the 'Party's Gold' strategy: and this is what has happened.

We are still, you will recall, in two-dimensional mode here: that is to say, for purposes of minimising obfuscation, we are excluding the Illuminati dimension (to which we shall revert). Bearing in mind the rigorous implementation of usually counterproductive compartmentalisation within the colossal US intelligence community, only the leading strategists in Moscow and Washington were ostensibly in possession of 'a copy of' the blueprint. From the United States' perspective at sub-Presidential level, it was 'all systems go' to convert the USSR from an enemy into the United States' close energy collaborator, and a source of oil shipments to the United States and elsewhere (mainly Europe) – thereby freeing up resources for exploitation by the US energy corporations both in the 'former' USSR and in other parts of the world. The Central Intelligence Agency, which is the clandestine foreign policy arm of the US Presidency, serves the interests of the oil companies.

ESSENCE OF THE SOVIET DOUBLE-CROSS

Therefore, in the minds of compartmentalised US intelligence operatives, including the most brilliant Financial Warfare experts among them such as Leo Wanta, this was always all about opening up Soviet energy resources to the West in general, and to the United States in particular. The Soviet Leninist deceivers made sure that this was indeed the objective, and collaborated with their US intelligence counterparts – accepting their 'Black operations' funding 'in exchange for' close collaboration with US and British intelligence as though they had been corrupted and were betraying Lenin himself – whereas *in reality*, from *their* viewpoint, this was all a game, in which the stupid Westerners thought they had corrupted their Soviet counterparts. The truth was that they were helping the Soviets to implement the fulfilment of their long-range 'collapsible Communism' strategy, as exposed by the genuine Soviet defector Anatoliy Golitsyn [see: *'The Perestroika Deception'*, by Golitsyn, available via www.edwardharle.com].

In short, the Soviets played a devious game of double bluff – exploiting the greed of the vast US intelligence community, which serves the inter-

ests of the oil corporations, for energy resources, in order to procure a 'great leap forward' towards the realisation of the strategic objective of locking the whole of Europe into absolute dependence upon Russian energy structures, so that all opposition to the final implementation of the 'Atlantic to Vladivostok' strategy would be eliminated.

THE VEHICLE IS THE EUROPEAN UNION COLLECTIVE

The vehicle for the formalisation of this strategy has long since been established, in the shape of the European Union Collective – which represents a 'new form' of Communism, as will be evident, for instance, to anyone with a modicum of understanding who visits the European Parliament. Its massive plenary hall is modelled along Soviet lines, so that all that is necessary is the replacement of the esoteric EU '12 stars' flag with a bust of Lenin and a hammer and sickle, for the transformation to be complete.

The fake European rubber-stamp 'democratism' 'Parliament', in which speeches may last for no more than one minute and in which the Chair cuts off the microphone if it dislikes what is being said, replicates Soviet procedures almost precisely. All that is now necessary for the fulfilment of the Leninist strategy, assisted by the United States and Britain, is for Berlusconi's 'call for' Russia to join the EU, to be realised. Leo Wanta had to be 'put out of the way' because he might have impeded realisation of this process.

THE STASI-DVD CONNECTION

Before reviewing the underlying global Illuminati dimension, which brings Iran into the picture, we need to revert to the STASI connection. Your correspondent was very disturbed to discover, in the course of research in recent years, that a number of known STASI operatives have been working with US intelligence. This became apparent from the discovery that a certain **Eva Taleki**, purporting to be of Hungarian extraction, whose real name is Stengl, and who has been closely associated with US intelligence operatives, is a STASI agent. This woman, who apparently fled the United States for London, controls more than \$60 billion of secret funds belonging to the US Government, which were transferred into her safekeeping legally but on high-level US Government instructions (according to evidence in the Editor's possession).

Since it became known in certain British intelligence circles that the atrocities committed in London on 7th July 2005 (and the attempted but failed atrocities attempted two weeks later) were allegedly supervised and ordered by French and German 'Black' intelligence upon the reportedly

direct alleged instructions of President Jacques Chirac (who once belonged to the same Grand Orient masonic lodge in Paris as that attended by Saddam Hussein), it occurred to your correspondent that Stengl – resident as noted, in London – may have been involved in coordinating or perhaps financing these operations.

The reason for this deduction is that it seemed to the Editor to be likely that the secret 'Black' intelligence organisation of the Nazi continuum, **Deutsche Verteidigungs Dienst** (DVD), which is appropriately based at Dachau near Munich, may hide behind the STASI organisation. It has since transpired indeed that the STASI chief **Marcus Wolf**, who presided over the establishment and control of East Germany's massive Jesuitical internal spying network (under which a third of the East German population spied on itself and the other two-thirds) has all along been a DVD operative – whose cover was and remains his STASI background. Herr Wolf is now under contract to the US Department of Homeland Security, ostensibly for debriefing but in reality so that he can convey to this US Ministry of the Interior his expertise on replicating his East German universal spying environment in America.

The Editor's conclusion has acquired further traction recently from a Soviet Military Intelligence (GRU) source. It follows, accordingly, that **Matthias Warnig**, the head of Dresdner Bank in Moscow and Chief Executive of the North European Gas Pipeline, to which ex-Chancellor Gerhard Schroeder has been appointed as Chairman, may likewise be a DVD operative.

And the further significance of this is that the German Chancellor is routinely informed about, and must approve, all strategic operations of the Dachau-based German secret 'Black' Nazi continuum intelligence organisation, DVD – which is not financed by the taxpayer but has its own secret sources of 'Black Ops' funds, believed to include the slush fund in Switzerland from which 'facilitation payments' worth a total of \$5.0 billion were allocated in tranches of \$200 million to the 'facilitators' in each of the 25 EU Member States for the aborted European Constitution Treaty.

It is believed that the Soviets may only recently have become aware that the DVD has always hidden behind *inter alia* the cover of the STASI, although the Editor is as yet unable to confirm this. Even assuming that Soviet Military Intelligence has always been aware of this fact, it would have calculated that it controls all the necessary levers, given the prospect of total German dependence upon Soviet sources of energy; and on this reading, the DVD would be 'hedging its bets' through its penetration of the Soviet structures,

of which the now strategically-placed Matthias Warnig would be a conspicuous contemporary example of this secret intelligence continuity.

GERMAN DVD-NAZINESS OF NEW IRANIAN LEADER

Another DVD-sponsored operative may be the Iranian President **Mahmoud Ahmadinejad** who is described as 'viscerally anti-Jew, anti-West... [and possesses a] fascination for **Hasan al Bana**, Gamal Abdul Nasser and third worldism [respectively] the founder of the **Muslim Brotherhood**, the late Egyptian leader, and the movement that once was the flag ship of developing nations... and above all [displays a] total and fanatical belief in Shi'a doctrine', according an Iranian journalist who knew Ahmadinejad from the time when he was Mayor of Tehran.

After declaring on 26th October 2005 that 'the Zionist Entity' – the jargon that Iranian officials use to name Israel – must be 'wiped off the map of earth', Mr. Ahmadinejad subsequently questioned the Holocaust, the killing of more than 6 million Jews and the gas chambers. Specifically, he dismissed the 'Shoah' as a myth concocted to justify Israel's existence. In other words, in case you hadn't noticed, the new Iranian President spouts the Nazi 'line' against the Jews. But there is also another clue to his German orientation: his reverence for **Hasan al Bana**, the founder of the **Muslim Brotherhood**. The Muslim Brotherhood was established by German intelligence (the *Abwehr*) in the 1920s, as a vehicle for the destabilisation of British influence in the Middle East.

From this information it can now definitively be stated that President Mahmoud Ahmadinejad reports to and is in all probability secretly controlled by the German (Nazi) 'Black' intelligence organisation, Deutsche Verteidigungs Dienst.

By extension, we can surmise that the operation against US hegemony in Iran under the Shah was not merely a Soviet operation, but was conducted in conjunction with German 'Black' intelligence. Depending on the extent to which the Soviet intelligence *apparat* remained conscious of its penetration by *Abwehr* operatives following the exposure or discovery of Lavrentii Beria, Stalin's murderous secret police chief, as a long-term German Nazi deep penetration agent, the Soviets carried out this carefully prepared takeover with or without being aware of German 'Black' intelligence assistance.

And that assistance was provided, *inter alia*, by none other than the man who is now President Mahmoud Ahmadinejad of Iran.

The US officials taken hostage in Iran in 1979 were held for 444 days, until following George Bush Sr.'s 'October Surprise' operation, they were

released immediately after President Reagan's first Inauguration – the hostage-takers having been bribed by Bush Sr. and his operative colleagues during a secret meeting in Paris in October 1980, after the US intelligence conspirators had themselves stolen some of the 'Black Operations' funds allocated for the purpose of inducing the Iranians to hold the hostages right through the Presidential Election period.

This ensured that President Carter's inability to procure their release would cause his electoral defeat – a calculation that proved to be well-founded. A retired US Navy Captain (and Office of Naval Intelligence operative), Donald Sharer, who was among the US hostages, remembers Mahmoud Ahmadinejad as 'a cruel individual'.

Separately, Austrian authorities were reported in December 2005 to be investigating claims that Ahmadinejad participated in assassinations against political opponents in Vienna in 1989, notably the exiled Kurdish leader, Abdul Rahman Ghassemou and two of his associates³.

TEHRAN GOVERNMENT PACKED WITH OPERATIVES

Taking his cue from the established precedents set by Moscow, Washington and even London, Mahmoud Ahmadinejad has packed his Government with 'former' security and intelligence officials who have been responsible for serious human rights abuses, including the liquidation of thousands of dissidents in Iran, according to several sources, including the New York-based organisation Human Rights Watch. This entity has pinpointed the newly installed Iranian Interior Minister, **Mustafa Pour-Mohammadi**, as being of particular concern. Specifically, this individual is a notorious former Deputy Intelligence Minister – holding that position between 1987 and 1999, when his operatives were 'systematically engaged in extrajudicial killings of opposition figures, political activists and intellectuals'.

In a report entitled *Ministers of Murder: Iran's New Security Cabinet*, the human rights organisation linked him to the murder of thousands of political prisoners inside the notorious Evin jail in Tehran and numerous other prisons in 1988, asserting that 'the deliberate and systematic manner in which these extrajudicial executions took place may constitute a crime against humanity under international law. In certain of these cases, the hand of the Iranian Government has been well established, while in others there are credible allegations of Government involvement. Pour-Mohammadi is at the centre of strong allegations of direct involvement in orchestrating these assassinations'.

Another operative identified as especially dan-

gerous by Human Rights Watch is **Gholamhussein Mohseni Ezhei**, the newly appointed Iranian Minister of Intelligence (or of 'information'), who was previously in charge of prosecutions of prominent 'reformist' clerics – code for dissidents within the Islamic revolutionary apparatus⁴.

Ahmadinejad's closest entourage also includes intelligence strategists who focus exclusively on a plan to unpick the 'painful' progress made by the previous régime-Government in re-establishing relations with the outside world, so as to trigger a 'pariah nation' response from the international community – which would enable Iran to disregard the Nuclear non-Proliferation Treaty so as to continue production of nuclear weapons without outside interference. This assessment presupposes that the Iranians have calculated that neither the United States nor Israel⁵ relishes an attack on Iran, especially as, according to certain intelligence sources, the Iranians already possess at least three nuclear bombs – a claim that we have been unable to verify and which it has been forcefully put to us may represent disinformation calculated to provoke Britain, against the almost unanimous wish of its population, to join the United States and Israel in an attack on Iran. That would be a venture of an altogether different order of magnitude from the amoral invasion and bombardment of Iraq.

The most influential high-level Iranian strategists so far identified include **Ali Larijani**, the new Secretary of the régime's Leninist **Supreme Council on National Security**, also a 'former' Revolutionary Guard operative; his elder brother, **Ardeshtir**, a close adviser to Ahmadinejad on international issues; and **Hashemi Samare'i**, considered to be a Presidential 'mentor' – all of whom are brainwashed with Nazi-style hatred of Israel and the Jews.

OIL EXPORTS AND THE EURO

Under Ahmadinejad, an internal Iranian proposal to trade energy contracts denominated in Euros, has surfaced, in lieu of the more radical plan, considered some years ago and dropped, to denominate Iranian oil exports in Euros. When Saddam Hussein's régime embarked upon such a course, it was promptly decapitated – as the United States regards the denomination of oil payments in currencies other than the US dollar as a *casus belli* – a point obliquely made to your correspondent by a sinister US Pentagon-linked intelligence official, who affirmed without elaboration in March 2005 that **'we didn't want to invade Iraq, but we had no choice'**.

In this connection, the French have continued to enjoy the privilege of buying oil from Iran at

the special fixed price of \$12.0 per barrel agreed under a very long-term arrangement negotiated under the Shah. Since France and Germany are bound by their 1963 Treaty of the Elysée to coordinate their international (and therefore intelligence) relations, always attending international meetings for instance with a pre-arranged 'common position', it can now be seen that the new Iranian Government led by the brutalised intelligence officer Mahmoud Ahmadinejad conspicuously serves the German-French interest.

INTENSIFIED GREAT POWER RIVALRY

By extension, the looming confrontation over Iran represents a central component of the prevailing clash between the Great Powers in the Middle East and Eurasia generally. Given recent developments, specially 7/7 and its aftermath, the clash is between Britain and the United States (representative of Scottish Rite Freemasonry) on the one hand, and France and Germany (representative of Grand Orient freemasonry) on the other – with the covert Soviets double-crossing both the Americans and the British (under their noses) and the German 'Black' Nazis playing both sides of the game, but probably continuing also to double-cross the Soviets.

The rôle of the French is central to this crisis. On 12th December, the new Iranian Government announced provocatively that construction of a 'second' nuclear power plant in the oil-rich Iranian Province of Khouzestan, was now to be undertaken. Prior to the 1979 Iranian Revolution, the French had started construction work on two separate nuclear plants there.

Under cover, therefore, of global tensions surrounding such issues as the pretext of President Bush's 'War on Terror', classical Great Power rivalry in the region has probably never been more pronounced than is the case today.

THE THREE-DIMENSIONAL PERSPECTIVE

If we now factor back in the Illuminati perspective, to obtain a three-dimensional picture, it will be recalled that the American High Priest of Lucifer, Albert Pike, planned three catastrophes or world wars as mechanisms for the dislocation of the *status quo* in order to create the dialectical conditions that the self-appointed (demonic) Illuminati controllers could manipulate to procure the intended 'Synthesis' of global control which is their objective.

Before he was executed on Stalin's instructions by the NKVD in 1938, the Jewish Soviet revolutionary operative 'Christian' Rakovsky, born as **Chaim Rakover**, told his interrogators that the World Revolution's main enemy was True Chris-

tianity, and that a 'permanent revolution' had in fact been in progress ever since the birth of Jesus Christ. This is the most profound and accurate statement ever to fall from the lips of a Soviet Leninist revolutionary. Rakover was executed in cold blood shortly afterwards, but a copy of his testimony survived and was published in 1983 under the title *'The Red Symphony'*.

The 'permanent revolution' entails, ironically, a clash of opposites – True Christian forgiveness and submission to the Lord, as preached by Jesus Christ, *versus* Tamudic-Judaic acquisitiveness and lack of belief in divine retribution after death. The two are incompatible.

LEVERAGING ISLAM VERSUS THE JEWS

The third of Pike's catastrophes was to be procured by setting Islam against the Jews – a typical double-cross of Satan, given the common origins of Talmudic Judaism and Islam. Thus, in parallel with the orchestrated and false 'dismantling' of Soviet Communism, the furniture was thrown all round the global room in preparation for this 'final' preplanned bust-up, which is supposed to be 'decisive' from the perspective of the Illuminati. Since, as graphically demonstrated in the preceding issue of this service, Communism and Nazism are fabricated dialectical 'opposite' sides of the same coin, it is no surprise that this dialectic is paralleled by the dialectical 'divisions' between various components of Illuminised intelligence communities – with the secret German 'Black' intelligence organisation, paralleled by its French (and Italian) counterparts, manipulating and leveraging the 'phanes' that they think they control, while the equally Illuminised (and evil) British and American 'Black' forces operate the opposing dialectic.

Of course, the guiding hand in all this has to be spiritual (Luciferian) – not least because intelligence planners and operatives believe they can control events, whereas events almost always wind up controlling them. US intelligence spends at least 50% of its time and of certain resources in the covering up of its previous deceptions and botched operations. And the intelligence services are all compromised and interpenetrated as never before, so that, to compound the chaos and incomprehension so often arising from compartmentalisation, the national services and their innumerable subdivisions and their 'Black' intelligence cadres, may have no idea what other components of their intelligence communities are up to at any given time.

In this respect, the Iranians, Soviets, Germans and French are currently 'easier to read' than their devious, bloody-minded and probably con-

fused British and American counterparts. And what can certainly be seen with much greater clarity now is that the continuing covert Soviets have the upper hand in their operations against the British and Americans – having induced both to believe the reverse; while the German-French alliance is waging a relentless intelligence war against London and Washington, with the European Union being used as crude leverage against the United Kingdom and its compromised leader.

INTENSIFIED CONTEMPORARY INTELLIGENCE WAR

So brutal is the intelligence war that we believe that US and British intelligence may have been behind the sudden conflagrations which erupted in France in October, and which were extinguished equally abruptly in November – an operation that was 'turned on and off', like an electric light switch. Since it is known that DVD and French 'Black' intelligence planned and executed the so-called '*Al-Qaeda*' attacks in London, as a means of exerting extreme pressure on the compromised British Prime Minister, and '*Al-Qaeda*', at the two-dimensional level, is an operation of French and German intelligence, the conflagrations appear to have represented what is known in the trade as 'blowback'.

Meanwhile, just as the United States, Israel, and perhaps Britain, continue to contemplate the decapitation of the Iranian nuclear programme, which would disrupt France's discounted oil supplies, they are also considering an alternative – involving the Euro, which was frankly established against the Bundesbank's wishes and under pressure from France, as a means to mask the fundamental weakness of the French franc.

As indicated, the Iranians have been considering the imminent introduction of certain oil trading arrangements denominated in Euros – no doubt calculating that decapitation of their Government and system along Iraqi lines will be considered too risky for their enemies to undertake. For the United States, the denomination of oil invoices in any currency other than the US dollar is a *casus belli*, since without this artificial prop, the US standard of living would collapse and the country would be thrust into an era of unprecedented instability – a contingency for which concentration camp facilities have been established throughout the United States, accompanied by the means to incarcerate the 15 million or so Americans who, it is calculated, would resist the imposition of a *de facto* dictatorship.

Although the country has been divided into ten regions for certain long-range purposes, the Illuminati have their own US subdivision arrangements, with the country actually divided into

seven components, of which the New Orleans area and adjacent states is Region Number 7.

When Vice President Cheney returned from a trip to New Orleans after the disaster (brought about by the dynamiting of certain *levées*, not by Hurricane Katrina itself, he remarked, in a Freudian slip of the tongue: 'We are on top of *this exercise*'. In other words, the 2005 New Orleans catastrophe (like the Asian tsunami, which was induced by satellite-mounted scalar laser technology), was *contrived and artificial*.

Its immediate purpose was to test the militarisation of one of the *Illuminati* regions, and to secure an inhabited district of the city believed to be located above a rich oilfield.

ALTERNATIVE TO DECAPITATING IRAN

So what would alternative course of action could be procured that would remove the 'necessity' for Iran to be 'decapitated' once certain Iranian oil transactions are denominated in Euros? Bearing in mind that, as an element of his psychological warfare against the United States, President Putin has referred on several occasions since he came to power, of the possibility of the Euro being used in lieu of the US dollar for oil payments purposes. While he and his strategists know perfectly well that any such development would be counterproductive and would trigger grave consequences, the judicious use of this threat has been applied as a means of encouraging the Americans into the Soviet energy sector. To signal to the US oil and intelligence communities that they must defer to him alone, Mr Putin has deftly appointed the former German Chancellor to a key Russian energy industry post – thereby indeed 'killing several birds with one stone'.

One of the birds that may have been killed as a consequence would be an orchestrated US-British Financial Warfare wrecking operation against the Euro, resulting in its collapse and replacement by national currencies – as is most likely to occur in Italy, but is also presaged, unbelievably, in Germany and The Netherlands.

Anecdotal evidence from all three countries indicates that coupons have been circulating (in certain parts of southern Italy, eastern Holland, and eastern Germany). Various indications of Financial Warfare ops against the Euro have surfaced in recent weeks, raising the possibility that the rug could one day be pulled from beneath the Iranians by the destruction of the Euro.

As an insurance policy against any such development, **Gerhard Schroeder** now occupies an apex position inside the (covert Soviet) Russian energy sector – where he is in a position to prevail upon the German authorities to do what

GRU-President Putin and his strategists wish.

Certainly, the double game being played by the Soviets is today as transparent as the Nazi card being leveraged against the Jews by Iran's DVD-directed intelligence Government.

We can disregard published assertions of the new Iranian leadership's anti-Westernism, which is part of his cover. His brand of National Socialism is as 'genuine' as Hitler's was. What none of the parties, including the Israelis and World Jewry, can anticipate with any degree of accuracy is how the *Illuminati* will seek to manipulate these parallel dialectics in pursuit of their vile Luciferian objectives. However we *can* anticipate one obvious outcome: **chaos**. The Devil, after all, is the author of confusion; and all the parties involved in this end-game are in his hands. ■

According to a Reuters report dated 16th December 2005, most Israelis oppose a military strike against Iran's nuclear programme for now – despite the fears in the Jewish state that Iran is getting closer to building an atom bomb, according to a poll taken that week. A *Yedioth Ahronoth* newspaper survey stated that 58% of the 510 Israelis polled said that the global dispute over Iran's atomic programme should be handled diplomatically, while 36% said its reactor should be destroyed in a military strike. Israeli intelligence is saying that by March 2006, Iran will possess the know-how to make a nuclear bomb and may be able to manufacture one within three years. The Prime Minister, Ariel Sharon, has said global pressure to halt Iran's nuclear programme should continue. Israel denied a report in *The Sunday Times*, London, published a week earlier, that it was planning a strike against Iran's nuclear reactor in March, saying it preferred to let foreign diplomatic pressure on Tehran run its course. However a senior Israeli official said future military action against Iran's nuclear programme was not being ruled out. Israel bombed a nuclear reactor in Iraq in 1981. Iran has vowed to respond to any attack by Israel – which is where the suggestion that Iran already holds three nuclear weapons imported from the 'former' Soviet Union, becomes relevant. It could originate in Iranian intelligence disinformation.

MARC RICH [REICH]

In 1983, Marc Rich fled the United States to avoid prosecution under an indictment brought by the US Attorney, fellow Jew and future Mayor of New York City, Rudolph Giuliani, against him and his fellow Jews Pincus Green, and Clyde Meltzer and against Marc Rich & Co., A.G., and Marc Rich & Co. International Ltd, subsequently known as Clarendon Limited. The extensive indictment included the following language: That the defendants and unknown co-schemers 'wilfully and knowingly would and did devise and intend to devise a scheme and artifice to defraud the United States and an agency thereof, to wit, the Department of Energy, in its lawful governmental function of administering and overseeing the laws and regulations which provided for price controls and markup requirements for the sale of crude oil produced in or imported into the United States, and to obtain money and property by false and fraudulent pretenses, representations and promises.... Massive profits... were derived by the defendants through a deliberate attempt to violate and to circumvent the price control and permissible average markup' and to defraud the Internal

Revenue Service and regulations of the DOE. [Indictment S 83 Cr. 579 (SWK), United States Southern District Court of New York, microfilm copy of 5th March 1984]. Marc Rich's name crops up in innumerable investigations into the corrupt operations of the covert Soviet KGB-GRU 'oligarchs', in connection with alleged commodity and money-laundering scams too numerous to elaborate upon here. Having fled to Switzerland with Pincus Green, to avoid Giuliani's charges of trading with Iran and tax evasion, both men remained on the FBI's Most Wanted list for many years.

On 20th January 2001, only hours before leaving office, President Clinton, having received representations from Marc Rich's attorney, Jack Quinn, and from Marc Rich's former wife, Denise Rich, granted Rich the most controversial Presidential pardon in history. Since Mrs Denise Rich, mother of Rich's three children, had made sizeable donations to the Democratic Party during Mr Clinton's time in office, it was widely alleged that Rich's pardon had been bought; but Bill Clinton subsequently explained his decision by noting that similar situations had been settled in civil, not criminal courts (a curious irrelevance here) and cited clemency pleas from Israeli Government officials, including then-Prime Minister Ehud Barak.

STARTED WITH EXPLOITATION OF U.S GRAIN BAN

After fleeing the United States, Rich took advantage of the grain embargo imposed on the USSR following the Soviet invasion of Afghanistan, ignoring it and importing grain into the USSR, and winning valuable contacts inside the Soviet *nomenklatura* which he proceeded to exploit extensively. According to NewsMax.com's intelligence sources, from then on Rich was guided in his business dealings 'by the Communist Party and senior KGB figures. Everybody in that carousel... got personal benefits... commissions in Western bank accounts'. Rich was drawn into the inner recesses of the corrupt Soviet hierarchy; and according to Dr Joseph D. Douglass [author of *Red Cocaine: The Drugging of America and the West*: see www.edwardharle.com], Rich played an important part in the strategic deception that enabled the old Communist *apparat* to maintain its grip on Russia and the rest of the Soviet Union following the orchestrated collapse of the USSR and the so-called 'collapse' of Soviet rule, which proceeded in precise accordance with the predictions and analyses of Anatoliy Golitsyn. Dr Douglass told the *New American* magazine that 'no revolution took place in Russia or the other Soviet Republics that would account for the sudden dismantling of the Soviet state. Nothing forced the Communist Party of the Soviet Union (CPUSA) to relinquish its monopoly on power. In reality, what the CPSU did was to diversify its holdings, rather than to dispense with its monopoly' – another way of describing the implementation of a more sophisticated version of Lenin's 'state capitalism', namely 'state controlled capitalism'.

Douglas reiterated and elaborated the analysis published in our *Soviet Analyst*, to the effect that the Communist Party bosses surreptitiously 'either created new parties ['democratism' – Ed.] or took over the leadership of existing ones'. Well before the orchestrated 'collapse', the CPSU-KGB 'set up all of the structures of what they called the 'invisible Party economy'. This was already going on in the early 1980s, even before Mr Gorbachev arrived with his 'reforms'. Because of the hidden superstructure that Marc Rich and his KGB colleagues created, Members of the Communist

nomenklatura had placed themselves in a position to become the masters of the new 'privatised economy'.

Your correspondent takes an almost identically robust view – namely, that *there was never any intention of establishing anything other than an 'invisible Party economy' using the Leninist model elaborated as 'state controlled capitalism'*. Although widely reported to reside in Zug, Rich has in fact moved his domicile to Meggen in the Swiss Canton of Lucerne. He lives in La Villa Rose, on the shores of the Vierwaldstättersee, also known as Lake Lucerne.

The Chicago-based veteran analyst Mr Sherman Skolnik [23rd June 2002] characterised Rich as 'the American CIA's laundryman' whom Rudolph Giuliani found out too late 'was immune'. When the top US Secret Service/US Treasury and CIA/FBI operative Leo Wanta arrived in 1993 to arrest Marc Rich, to meet Vincent W. Foster Jr. and to monitor or otherwise interact in a law enforcement capacity with a money-laundering operation involving the CIA's innocent-sounding front called the Children's Defense Fund – headed prior to Bill Clinton's election by the CIA operative Hillary Clinton – he was seized by the Swiss authorities and clapped into a stinking Swiss dungeon for 132 days, while Vince Foster was murdered by a hired 'hit' team and his body dumped in Fort Marcy Park, VA.

Wanta was indicted, jailed and later held under house arrest on trumped-up charges orchestrated by George Bush Sr.'s associate Tommy Thompson – then US Attorney in Wisconsin, later Governor, and subsequently a Bush Jr. Cabinet official – of not having paid ancient Wisconsin taxes. Among reasons for the neutralising and silencing of Leo Wanta, President Reagan's favourite operative, was that he is one of the world's very few real experts on the Russian/Soviet *mafia*. Another factor was his identification of the alleged fact that George Bush Sr. received massive corrupt payments contrary to US law applicable to holders of official office. In later years, Marc Rich grew wealthier than ever, undertaking lucrative ventures in the 'former' USSR, Iraq, Nigeria, South Africa and elsewhere.

His company Marc Rich Real Estate GmbH is involved in large real estate development projects, especially in Prague, Czech Republic. He renounced his US citizenship, and now holds Swiss, Spanish and Israeli citizenship. He is reported to have unspecified relations with the Israeli intelligence agency, Mossad. The recently indicted Jewish US Vice Presidential Chief of Staff, Lewis 'Scooter' Libby, served as Rich's lawyer as far back as 1985, and has been reported to have charged him \$2.0 million for legal fees.

Rich's birth date, 18th December 1934, is extremely close to that of a Nazi agent who immigrated to Canada from Korbach, Germany on 23rd May 1954 aboard MS 'Seven Seas' from Bremerhaven to Quebec under the codename Hans Brand, whose physique Marc Rich resembles, and whose birth date was 4th June 1934. If the two men are one and the same, Rich's 'legend' to the effect that he was born in Antwerp, Belgium, of a Jewish family the members of which emigrated (extremely late) to the United States in 1942 to escape the Nazis, is false, and the Editor would classify him as a long-term agent of the Dachau-based 'Black' Nazi intelligence continuum agency, DVD (Deutsche Verteidigungs Dienst), which supervises long-range Nazi strategy.

It should be understood that it would be nothing unusual for a person of Jewish extraction to be a Nazi continuum operative: see *Soviet Analyst* Volume 29, 8-10 for details. ■
