

Subject: EU Debate on Court of Auditors report for 2004

Message to both Christophers!

I got a one minute slot on the floor of the House yesterday, Monday, and used it to say:

"I should inform the House and the Commission that the new ambassador to the EU from the United States of America, Mr Boyden Gray, is a lawyer with a special interest in public finances.

He has been fully briefed on the level of fraud and corruption here, and is now acquainted with much of the detail published last month in International Currency Review.

At a time when public accountability is a big issue on both sides of the Atlantic - and not only on financial management - his arrival here shortly is to be welcomed.

My I also inform the House that not a single word on EU corruption published last month in International Currency Review has been challenged or refuted."



Later, in a special meeting of the Budget Control Committee called to hear in advance of the debate in the House today (Tuesday) the 2004 Annual Accounts Discharge Report from the president of the Court of Auditors, I ad libbed as follows:

"There is not one company, nor a single firm of auditors, anywhere in the European Union who would accept your report. Not one. You have admitted that the Commission's records of sundry debtors, and assets and liabilities, are incomplete. You have admitted that the opening balances under the new system of accrual accounting cannot be reconciled with closing balances under the old system of cash accounting, and you have admitted that the Commission retrospectively changed information in previous sets of accounts - which is illegal.

You say these things "may" affect the 2005 accounts. Mr Weber they will affect every future set of accounts. These unreconciled opening balances mean that the Court of Auditors can NEVER sign off future accounts.

Every year since the Court started work, and probably every year into the future, there will be warm words of good intent, based on a breathtaking level of complacency. But nothing fundamentally changes.

There are only two ways to achieve effective change. Have the Court of Auditors answer directly to their paymasters - the member states - and stop acting as a creature of the Commission. And one member state - preferably the UK - should withhold all future payments to the EU and put the money in an escrow account until this gigantic financial scandal is finally sorted.

For it is a scandal that the EU is the one organisation in Europe that has failed to meet the International Financial Reporting Standards it has sought to impose on everyone else."

Stunned silence, and a smirk on a few faces - some who don't care and a few who agree.

Today, Tuesday, when Weber made the same statement to the whole House, my colleague, the Austrian MEP Hans-Peter Martin tried to deliver much the same as my speech from the previous night, but I fear his lack of knowledge of the German equivalent for various English accounting terms defeated him somewhat.

I have a copy of the Weber report and will fax it to you when I get back. Alternatively tell me when you are in the office and I'll try to reach you from here.



One other matter, for Christopher Story in particular:

My visit to Lithuania and Kaliningrad threw up much worse situation on immigration than I imagined. More on that later. More urgently, my guide, from Estonia, has a lawyer friend with ALL the dirt on Kallas. He is sending it. Having read it, you may want to visit Tallinn to get it first hand. Sounds horrific, and involves the theft of millions from the Estonian government via Zurich.
